# PROPOSED GRANT OF GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES; PROPOSED RE-ELECTION OF DIRECTORS; AND (3) NOTICE OF ANNUAL GENERAL MEETING

#### INTRODUCTION

At the forthcoming AGM, resolutions will be proposed to seek the Shareholders' approval for, among other things, (i) the granting of the General Mandate and the Repurchase Mandate to the Directors; and (ii) the re-election of Directors.

The purpose of this circular is to provide you with information relating to the resolutions to be proposed at the AGM for the grant of the General Mandate and the Repurchase Mandate, the proposed re-election of Directors, and the notice of the AGM.

#### GENERAL MANDATE AND REPURCHASE MANDATE

At the AGM, the Directors propose to seek the approval of the Shareholders to grant to the Directors the General Mandate and the Repurchase Mandate.

#### **General Mandate**

At the AGM, an ordinary resolution will be proposed that the Directors be given an unconditional general mandate to allot, issue and deal with unissued Shares or securities convertible into Shares, options, warrants or similar rights to subscribe for any Shares (other than by way of rights or pursuant to a share option scheme for employees of the Company or Directors and/or any of its subsidiaries or pursuant to any scrip dividend scheme or similar arrangements providing for the allotment and issue of Shares in lieu of whole or part of the dividend on Shares in accordance with the Articles of Association or upon the exercise of rights of subscription or conversion under the terms of any securities or bonds convertible into Shares) or make or grant offers, agreements, options and warrants which might require the exercise of such power, of an aggregate nominal amount of up to 20% of the aggregate nominal amount of the issued Shares as at the date of granting the general mandate.

As at the Latest Practicable Date, the Company had an aggregate of 1,149,600,000 Shares in issue. Subject to the passing of the resolution for the approval of the General Mandate and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the date of the AGM, the Company would be allowed under the General Mandate to allot, issue and deal with a maximum of 229,920,000 Shares.

#### **Repurchase Mandate**

At the AGM, an ordinary resolution will also be proposed that the Directors be given an unconditional general mandate to repurchase Shares on the Stock Exchange or any other stock exchange on which the Shares may be listed and recognised by the Securities and Futures Commission of Hong Kong and the Stock Exchange for such purpose, of an aggregate nominal amount of up to 10% of the aggregate nominal amount of the issued Shares as at the date of granting the repurchase mandate.

Subject to the passing of the resolution for the approval of the Repurchase Mandate and on the basis that no further Shares are issued or repurchased between the Latest Practicable Date and the date of the AGM, the Company would be allowed under the Repurchase Mandate to repurchase a maximum of 114,960,000 Shares.

The General Mandate and the Repurchase Mandate shall continue to be in force during the period from the date of passing of the resolutions for the approval of the General Mandate and the Repurchase Mandate up to (i) the conclusion of the next annual general meeting of the

Company; (ii) the expiration of the period within which the next annual general meeting of the Company is required by the Articles of Association, the Companies Law (Law 3 of 1961, as consolidated and revised) or any applicable laws of the Cayman Islands to be held; or (iii) the revocation or variation of the General Mandate or the Repurchase Mandate (as the case may be) by ordinary resolution of the Shareholders in general meeting, whichever occurs first.

An explanatory statement in connection with the Repurchase Mandate is set out in Appendix I to this circular. The explanatory statement contains all the requisite information required under the Listing Rules to be given to the Shareholders to enable them to make an informed decision on whether to vote for or against the resolution approving the Repurchase Mandate.

#### **RE-ELECTION OF DIRECTORS**

According to Article 87(1) and the Code on Corporate Governance Practices (the "CG Code") contained in Appendix 14 of the Listing Rules, every Director shall be subject to retirement by rotation at least once every three years. A retiring Director shall be eligible for re-election.

In accordance with Article 87(1) and the CG Code, Mr. Chow Yin Kwang, Ms. Chan Yim Fan , Mr. Zheng Jin Hong and Mr. Leung Yuen Wing shall retire from office by rotation at the AGM. Being eligible, each of Mr. Chow Yin Kwang and Ms. Chan Yim Fan will offer himself/herself for re-election as executive Director, Mr. Zheng Jin Hong will offer himself for re-election as non-executive Director and Mr. Leung Yuen Wing will offer himself for re-election as independent non-executive Director .

At the AGM, ordinary resolutions will be proposed to re-elect each of Mr. Chow Yin Kwang and Ms. Chan Yim Fan as executive Director, Mr. Zheng Jin Hong as non-executive Director and Mr. Leung Yuen Wing as independent non-executive Director.

Particulars relating to each of Mr. Chow Yin Kwang, Ms. Chan Yim Fan, Mr. Zheng Jin Hong and Mr. Leung Yuen Wing are set out in Appendix III to this circular.

#### AGM

#### **EXPLANATORY STATEMENT**

This Appendix serves as an explanatory statement, as required by the Listing Rules, to provide requisite information to you for your consideration of the Repurchase Mandate.

#### 1. Repurchase of securities from connected parties

The Listing Rules prohibit a company from knowingly purchasing securities on the Stock Exchange from a "connected person", that is, a director, chief executive or substantial shareholder of the Company or any of its subsidiaries or their respective associates (as defined in the Listing Rules) and a connected person is prohibited from knowingly selling his/her/its securities to the Company.

No connected person of the Company has notified the Company that he/she/it has a present intention to sell any Shares to the Company nor has any such connected person undertaken not to sell any of the Shares held by him/her/it to the Company in the event that the Repurchase Mandate is passed.

#### 2. Share capital

As at the Latest Practicable Date, the issued share capital of the Company comprised 1,149,600,000 fully paid Shares.

Subject to the passing of the proposed resolution for the approval of the Repurchase Mandate and on the basis that no further Shares are issued or repurchased by the Company prior to the AGM, the Company will be allowed under the Repurchase Mandate to repurchase a maximum of 114,960,000 fully paid Shares, representing 10% of the issued share capital of the Company.

#### 3. Reasons for the repurchase

The Directors believe that the Repurchase Mandate is in the best interests of the Company and its shareholders as a whole. An exercise of the Repurchase Mandate may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net assets per Share and/or earnings per Share and will only be made when the Directors believe that a repurchase will benefit the Company and its shareholders as a whole.

#### 4. Funding of repurchases

Pursuant to the Repurchase Mandate, repurchases would be funded entirely from the Company's available cash flow or working capital facilities which will be funds legally available under the Cayman Islands law and the Memorandum and Articles of Association of the Company for such purpose.

An exercise of the Repurchase Mandate in full could have a material adverse impact on the working capital and gearing position of the Company compared with that as at 31 December 2006, being the date of its latest published audited consolidated accounts. The Directors do not, however, intend to make any repurchase in circumstances that would have a material adverse impact on the working capital or gearing position of the Company.

# **EXPLANATORY STATEMENT**

The Directors are not aware of any consequences which may arise under the Takeovers Code as consequences of any purchase made under the Repurchase Mandate. However, the Company may not repurchase Shares which would result in the amount of Shares held by the public being reduced to less than 25%.

On the basis of the current shareholding of PME Investments (BVI) Co., Ltd., Mr. Cheng Kwok Woo, Mr. Cheng Kwong Cheong, Ms. Cheng Wai Ying, Ms. Tsang Sui Tuen, Ms. Wan Kam Ping and Mr. Cheng Yau Kuen, an exercise of the Repurchase Mandate in full will result in them becoming obliged to make a mandatory offer under Rule 26 of the Takeovers Code.

The Directors have no intention to exercise any of the Repurchase Mandate to such an extent that will result in a requirement of PME Investments (BVI) Co., Ltd., Mr. Cheng Kwok Woo, Mr. Cheng Kwong Cheong, Ms. Cheng Wai Ying, Ms. Tsang Sui Tuen, Ms. Wan Kam Ping and Mr. Cheng Yau Kuen to make a mandatory offer under the Takeovers Code.

# APPENDIX II PROCEDURES BY WHICH SHAREHOLDERS MAY DEMAND A POLL AT GENERAL MEETING PURSUANT TO THE ARTICLES OF ASSOCIATION

The procedures by which the Shareholders may demand a poll at the AGM are set out in this Appendix.

According to Article 66, at any general meeting a resolution put to the vote of the meeting shall be decided on a show of hands unless a poll is (before or on the declaration of the result of the show of hands or on the withdrawal of any other demand for a poll) demanded. A poll may be demanded by:

- (a) the chairman of the meeting; or
- (b) at least three Shareholders present in person (or, in the case of a Shareholder being a corporation, by its duly authorised representative) or by proxy for the time being entitled to vote at the meeting; or
- (c) any Shareholder or Shareholders present in person (or, in the case of a Shareholder being a corporation, by its duly authorised representative) or by proxy and representing not less than one-tenth of the total voting rights of all Shareholders having the right to vote at the meeting; or
- (d) any Shareholder or Shareholders present in person (or, in the case of a Shareholder being a corporation, by its duly authorised representative) or by proxy and holding shares in the Company conferring a right to vote at the meeting being shares on which an aggregate sum has been paid up equal to not less than one-tenth of the total sum paid up on all the shares conferring that right; or
- (e) if required by the Listing Rules, by any Director or Directors who, individually or collectively, hold proxies in respect of shares representing 5% or more of the total voting rights at the meeting.

The details of the Directors who will retire from office at the AGM and being eligible, will offer themselves for re-election at the AGM, are set out below:

#### (1) Mr. Chow Yin Kwang

Mr. Chow Yin Kwang, aged 68, an executive Director and joined the Group in 1995. He is responsible for the project development and quality management of the Group. He has over 10 years experience in the Group's project development, operation and quality management. Before joining the Group, Mr. Chow had more than 30 years experience in operation management. Other than acting as an executive Director of the Company, Mr. Chow did not hold any directorship in any listed companies in the past three years. Mr. Chow does not have any relationship with any other Directors, senior management of the Company, substantial Shareholders or controlling Shareholders. He has entered into a service agreement with the Company for a term of 3 years commenced from 1 October 2002 and will continue thereafter until terminated by not less than three months' notice in writing served by either party on the other. Mr. Chow is currently entitled to an annual emolument of HK\$751,660 and a management bonus to be determined by the Board at their absolute discretion. He does not have any interest in the shares of the Company within the meaning of Part XV of the SFO.

There is no information relating to Mr. Chow that is required to be disclosed pursuant to Rules 13.51(2)(h) to (v) of the Listing Rules.

Save as disclosed herein, there is no other matter that needs to be brought to the attention of the Shareholders and the Stock Exchange.

#### (2) Ms. Chan Yim Fan

Ms. Chan Yim Fan, aged 56, an executive Director and joined the Group in 1990. She is responsible for the logistics of the Group including product supply, delivery, storage, and raw materials as well as trading product procurement. She has over 20 years experience in logistics management. Other than acting as an executive Director, Ms. Chan did not hold any directorship in any listed companies in the past three years. Ms. Chan does not have any relationship with any other Directors, senior management of the Company, substantial Shareholders or controlling Shareholders. She has entered into a service agreement with the Company for a term of 3 years commenced from 1 October 2002 and will continue thereafter until terminated by not less than three months' notice in writing served by either party on the other. Ms. Chan is currently entitled to an annual emolument of HK\$370,565 and a management bonus to be determined by the Board at their absolute discretion. As at the Latest Practicable Date, Ms. Chan has personal interests of 8,205,333, representing approximately 0.71% of the entire issued share capital of the Company. Save as disclosed above, Ms. Chan does not have, and is not deemed to have, any other interests or short positions in any shares, underlying shares or debentures of the Company within the meaning of Part XV of the SFO.

There is no information relating to Ms. Chan that is required to be disclosed pursuant to Rules 13.51(2)(h) to (v) of the Listing Rules.

Save as disclosed herein, there is no other matter that needs to be brought to the attention of the Shareholders and the Stock Exchange.

#### (3) Mr. Zheng Jin Hong

Mr. Zheng Jin Hong, aged 43, a non-executive Director, joined the Group in 2002. He is a certified public accountant and certified tax accountant in the PRC. He is a director of the Dongguan Accounting Society and an executive director of the Dongguan Association of Certified Public Accountants. Other than disclosed above, Mr. Zheng did not hold any directorship in any listed companies in the past three years. Mr. Zheng does not have any relationship with any other Directors, senior management of the Company, substantial Shareholders or controlling Shareholders. He has entered into a service contract with the Company pursuant to which his term of appointment shall continue until 30 September 2007 subject to retirement by rotation and re-election in accordance with the Articles of Association. Mr. Zheng's annual directors' fee shall be determined by the Board with reference to the services and contributions to the Company annually. He does not have any interest in the shares of the Company within the meaning of Part XV of the SFO.

There is no information relating to Mr. Zheng that is required to be disclosed pursuant to Rules 13.51(2)(h) to (v) of the Listing Rules.

Save as disclosed herein, there is no other matter that needs to be brought to the attention of the Shareholders and the Stock Exchange.

#### (4) Mr. Leung Yuen Wing

Mr. Leung Yuen Wing, aged 40, was appointed as an independent non-executive director in September 2004. He had held managerial positions in various renowned accounting firms and an investment bank. He is currently the Financial Controller and Company Secretary of iMerchants Limited, and a certified public accountant of the Hong Kong Institute of Certified Public Accountants and a fellow member of the Association of Chartered Certified Accountants. Other than disclosed above, Mr. Leung did not hold any directorship in any other listed companies in the past three years. Mr. Leung does not have any relationship with any other Directors, senior management of the Company, substantial Shareholders or controlling Shareholders. He has entered into a service contract with the Company pursuant to which his term of appointment shall continue until 30 September 2007 subject to retirement by rotation and re-election in accordance with the Articles of Association. Mr. Leung is currently entitled to an annual director's fee of HK\$120,000. He does not have any interest in the shares of the Company within the meaning of Part XV of the SFO.

There is no information relating to Mr. Leung that is required to be disclosed pursuant to Rules 13.51(2)(h) to (v) of the Listing Rules.
