FURTHER POSTPONEMENT OF BOARD MEETING AND DELAY IN THE PUBLICATION OF THE RESULTS AND DISPATCH OF THE ANNUAL REPORT FOR THE FINANCIAL YEAR ENDED 31 DECEMBER 2006

The Board wishes to inform shareholders of the Company that there will be a further postponement of the board meeting that was expected to be held to consider, amongst other things, the results of the Company and its subsidiaries for the financial year ended 31 December 2006, and there will be a further delay in the publication of the results of the Company and the dispatch of the annual report for the financial year ended 31 December 2006. The Board envisages that the Company will be in a position to release its preliminary results on or before 29 June 2007 and dispatch its annual report on or before 4 July 2007.

At the request of the Company, trading in the shares of the Company was suspended from 9:30 a.m. on 30 April 2007 pending the release of the results of the Company for the financial year ended 31 December 2006.

Reference is made to the announcements of Pan Sino International Holding Limited (the “**Company**”) dated 23 April, 24 April, 17 May and 23 May 2007.

The board of directors of the Company (the “**Board**”) wishes to inform shareholders of the Company that there will be a further postponement of the meeting of the Board to consider, amongst other things, the results of the Company and its subsidiaries (the “**Group**”) for the financial year ended 31 December 2006, and there will be a further delay in the publication of the results of the Company and the dispatch of the annual report for the financial year ended 31 December 2006. The further delay was due to the fact that there was a change of the Group’s local auditors in Indonesia after the Company issued its previous announcement on 23 May 2007. It has, therefore, taken more time than expected to complete the audit process and prepare the audited results of the Group for the financial year ended 31 December 2006. The Board envisages that the Company will be in a position to release its preliminary results on or before 29 June 2007 and dispatch its annual report on or before 4 July 2007.

Pursuant to Rule 13.46(2)(b) of the Listing Rules, the Company shall make up its annual accounts to a date falling not more than 6 months before the date of its annual general meeting (“**AGM**”). Since the Company will not be able to hold an AGM on or before 30 June 2007, the Company acknowledges that the delay will constitute a breach of Rule 13.46(2)(b) of the Listing Rules.

After making due enquiries with all the directors of the Company, the Board confirmed that save as disclosed above, the Board is not aware of any price-sensitive information or fact in relation to the Company which has given rise to the further delay in the publication of the Company's results and which ought to be disclosed under the general obligation imposed by Rule 13.09 of the Listing Rules.

The Board further confirmed that as at the date of this announcement, the Company did not have any disagreement with the Company's auditors in the course of the preparation of the audited report for the financial year ended 31 December 2006.

At the request of the Company, trading in the shares of the Company was suspended from 9:30 a.m. on 30 April 2007 pending the release of the results of the Company for the financial year ended 31 December 2006.
