利民實業有限公司(「本公司」)董事會(「董 事會」) 欣然呈報本公司及其附屬公司(統 稱「本集團」)截至二零零七年六月三十日 七年六月三十日止六個月之綜合損益表及 本集團於二零零七年六月三十日之綜合資 產負債表連同選定之説明附許均為未經審 核及簡明賬目形式編製,已經本公司審核 委員會連同本公司之獨立核數師香港天華 會計師事務所有限公司審閱。

The Board of Directors (the "Board") of Raymond Industrial Limited (the "Company") is pleased to present the interim report for the six months ended 30th June 2007 of the Company and its subsidiaries (collectively the "Group"). The consolidated income statement, consolidated cash flow statement and consolidated statement of changes in equity of the Group for the six months ended 30th June 2007 and the consolidated balance sheet of the Group as at 30th June 2007, along with selected explanatory notes. are unaudited and condensed and have been reviewed by the Company's audit committee together with the Company's independent auditors, Baker Tilly Hong Kong Limited .

### 業績概要

於二零零七年上半年,我們增加產品種類 的策略,因受美國樓市放緩的影響而令家 居住宅用空氣過濾系統銷售下降並引致暫 時虧損。同時,人民幣升值和中國政府的 最低工資制度致使管理費用和勞動力成本 增加。本集團於二零零七年上半年營業額 為港幣三億八仟三百萬元,與去年同期綜 合營業額相比,集團營業額下降了百分之 十六。集團淨虧損港幣五百七十萬元,比 去年同期下降了百分之一百二十二。集團 虧損港幣五百七十萬元已包括集團的聯營 公司祥豐科技(集團)有限公司虧損港幣五 百二十萬元,及核心業務虧損港幣五十萬 元。

### **BUSINESS HIGHLIGHTS**

In the first half of 2007, our strategy to diversify our product lines took a temporary setback because of slow sales of residential air filtration systems due to the slowdown in the USA housing market. During the same period, overhead and labor costs increased significantly, mainly due to RMB currency appreciation and the new minimum wage requirement in China. The turnover of the Group was HK\$383 million in the first six months of 2007, representing a decrease of 16 % compared with turnover at the same time last year for the Group's consolidated result. The Company's net loss was HK\$5.7 million, reflecting a decrease of 122 % compared with same time last year. The net loss of HK\$5.7 million consists of loss from the Group's associate company Cheung Fung Technology (Holdings) Ltd. of HK\$5.2 million, as well as net loss of HK\$0.5 million from the core business.

雖然集團營業額有所下降,以及公司遭受了營運虧損,我們仍然樂觀地認為開發新產品和維護產品質量的態度之策略將會取得成效。許多同行業競爭者都以降低原材料品質來降低材料成本,但我們仍然在此競爭激烈的環境中與優質供應商密切合作,確保供應的所有零部件都符合國際質量標準。

### 二零零七年下半年展望

本公司於二零零七年下半年將繼續開發和 推出新的空氣過濾系列產品。同時,我們 也期望於二零零七年下半年和二零零八年 初推出一些其它品種的新產品。公司持樂 觀態度,接下來十二個月推出的新產品將 會增加公司的營業額和利潤。

我們將繼續開發新的醫療器械產品,尋求 合作機會。盡管進展比預期稍慢,但是我 們相信新產品開發工作一直在正確的方向 上發展,並且與潛在客戶已有合作意向。

為應付管理費用和勞動力成本的增加,管理層實施E100計劃以提高生產效率,實現低投入高產出,實行外包制度,保持質量水平但降低成本。我們期望該計劃於二零零七年下半年見成效。

Despite the lower turnover and the fact that the Company suffered an operating loss, we are still optimistic that our strategy to develop new products in new categories and our uncompromising attitude on maintaining good product quality will succeed. Many of our competitors lowered their material costs by substituting reliable suppliers with less reliable sources. However, our Company continues to work closely with our quality suppliers during this challenging time to ensure that all parts from our supply chain comply with international quality standard.

# PROSPECTS FOR THE SECOND HALF OF 2007

The Company continues to develop and will launch a series of new air filtration products in the second half of 2007. We expect to launch other new products during the second half of 2007 and early part of 2008. The Company is optimistic that the new products to be launched in the next 12 months will make positive contribution to the Company's turnover and profits.

We continue to explore new product development and opportunities in the medical equipment field. Despite that the progress is slower than our initial expectation, we believe we are moving in the right direction as we have obtained solid cooperation with potential customers.

To counter the increase in overhead and labor costs, our management has implemented an E100 productivity efficiency program to achieve a slimmer workforce that can generate higher production output and explore subcontracting some process that will not compromise overall quality. We expect to see positive result during the second half of 2007.

關於煙紙業務,由於高誘氣度過濾咀棒的 銷售不理想,財政狀況受到負面影響。管 理層一直在與我們的策略性合作伙伴/買 方談判,希望於接下來的六到十二個月內 退出煙紙業務,集中資源和精力發展我們 的核心業務。

Regarding the cigarette paper business. financial result was adversely impacted due to the less than satisfactory sales growth for the high porous plug wrapped paper product. Our management has been negotiating with our strategic partner/buver on possible merger/buyout opportunities. management also expects to exit the cigarette paper business within the next 6 -12 months so we can focus our resources and effort in developing our core business.

### 財政狀況

本集團的資金流動情況令人滿意。於二零 零七年六月三十日,本集團之資金流動率 為三點八。

於二零零七年六月三十日,銀行結餘及現 金總額為港幣三億零七百萬元,比去年同 期下降了港幣三仟四百萬元。主要由於現 金用於支援營運活動的和派發二零零六年 度股息。

於二零零七年六月三十日,本集團並無銀 行貸款及或然負債。

### 資產抵押

於二零零七年六月三十日,本集團概無資 產抵押。 In order to qualify for the interim dividend, all transfers accompanied by the relevant share certificates must be lodged with the Company's share registrars, Computershare Hong Kong Investor Services Limited, at 46th Floor, Hopewell Centre, 183 Queen's Road East, Wan Chai, Hong Kong by 4:00 p.m. on 28th September 2007. ### FINANCIAL POSITION

The liquidity position of the Company was very good. The current ratio was 3.8 as of 30th June 2007.

Bank balances and cash were HK\$307 million as of 30th June 2007, representing a decrease of HK\$34 million over that of the same period of the previous year. The change was mainly due to cash used in supporting operating activities and dividends paid out at fiscal year end of 2006.

There was no bank borrowing as of 30th June 2007, and the Group had no contingent liabilities as of 30th June 2007.

### **CHARGE ON ASSETS**

The Group has no charges on assets as of 30th June 2007.

### 外匯風險

### 職員

本集團現有香港職員約六十五人,並為其 提供強制性公積金計劃以及退休供款計 劃。中國生產廠現時約有三百名職員,於 期內直接或間接聘用之工人約五千至六千 五百名。

本集團之薪酬政策及購股權計劃與二零零 六年十二月三十一日止年度之年度財務報 表所披露者相同。

本人謹代表董事會對所有職員在期內對本 集團所作出之貢獻,表示謝意。

### 購買、出售或贖回股份

本公司於期內並無贖回其股份。本公司及 其任何附屬公司於期內亦無購買、出售或 贖回本公司之股份。

### FOREIGN EXCHANGE EXPOSURE

Most of the Group's transactions were conducted in US Dollars, Hong Kong Dollars and Renminbi. The Group does not foresee any substantial exposure to foreign currency fluctuations and thus use of financial instruments for exchange rate hedging purpose is not considered.

### STAFF

The Group currently employs approximately 65 Hong Kong staff members and has participated in the Mandatory Provident Fund Scheme and defined contribution pension schemes. Our factory in mainland China employs about 300 staff members. Workers employed directly or indirectly by the factory ranged from 5,000 to 6,500 persons during the period.

The Group's remuneration policies and share option scheme remained the same as revealed in the annual financial statements for the year ended 31st December 2006.

On behalf of the Board, I would like to extend the Board's appreciation to all our staff members for their hard work and dedication throughout the period.

### **PURCHASE, SALE OR REDEMPTION OF SECURITIES**

The Company has not redeemed any of its shares during the period. Neither the Company nor any of its subsidiaries has purchased, sold or redeemed any of the Company's shares during the period.

於期內,除關於獨立非執行董事之服務任 期偏離了常規守則A.4.1項條款外,本公司 一直遵守《上市規則》附錄14所載之企業管 治常規守則(「常規守則」) 之規定。

根據常規守則A.4.1項條款規定,非執行董 事(包括獨立非執行董事)應設有特定委任 年期並須輪值告休。

本公司之現任獨立非執行董事均不設特定 委任年期,此點偏離了常規守則A.4.1項條 款之規定。然而,根據本公司之公司組織 章程,獨立非執行董事均須在應屆股東调 年大會輪值告休。因此,本公司認為已採 取充份措施以確保本公司之企業管治水平 並不較常規守則之要求寬鬆。

### CORPORATE GOVERNANCE

Throughout the period, the Company was in compliance with the Code of Corporate Governance Practices (the "CG Code") as set out in Appendix 14 of The Rules Governing the Listing of Securities of The Stock Exchange of Hong Kong Limited (the "Listing Rules"), with deviations from code provision A.4.1 of the CG Code in respect of the service term of independent nonexecutive directors.

Under code provision A.4.1 of the CG Code, non-executive directors (includina independent non-executive directors) should be appointed for a specific term and subject to re-election.

None of the existing independent nonexecutive directors of the Company is appointed for a specific term. This constitutes a deviation from code provision A.4.1 of the CG Code. However, all independent nonexecutive directors are subject to retirement by rotation and re-election at the annual general meeting of the Company in accordance with the provisions of the Company's Articles of Association. As such, the Company considers that sufficient measures have been taken to ensure that the Company's corporate governance practices are no less exacting than those in the CG Code.
