Corporate Profile 集團簡介

The Perennial Group, founded in 1989, manufactures and trades quality power cord, power cord sets, cables and solid wire, wire harnesses and plastic resins. The Group's primary markets are America, Europe, Australia, Mainland China, Japan and Southeast Asia where it sells to prominent multi-national producers of electrical and electronic products.

Headquartered in Hong Kong, the Group employs approximately 1,600 staff worldwide involved in management, sales and marketing, shipping, procurement, financial and accounting, research and development, production and manufacturing. The Group considers its employees to be its most important asset while its key values are quality, prudence and integrity.

恒都集團於一九八九年成立,專門製造及營銷優質的電源線、電源線組合、導線、組合線束及塑膠皮料。集團主要的外銷市場是美洲、歐洲、澳洲、中國大陸、日本及東南亞客戶對象為著名的跨國電器及電子產品生產商。

集團總部設於香港,在全球僱用約1,600名 員工,主要負責管理、銷售及市場推廣、船 務、採購、財務及會計、研發及生產等工 作。集團視員工為最寶貴的資產,而優質、 審慎及誠信則為最重要的價值。

On behalf of the Board of Directors (the "Directors"), I am pleased to announce the audited consolidated financial results of Perennial International Limited (the "Company"), together with its subsidiaries (the "Group") for the year ended 31st December 2008.

本人謹代表恒都集團有限公司(「本公司」)董 事會,宣佈本公司及其附屬公司(「本集團」) 截至二零零八年十二月三十一日止年度的經 審核綜合財務報告。

The Group's turnover was HK\$507,628,000 (2007: HK\$470,496,000), up 8%. Profit for the year was HK\$22,294,000 compared to HK\$24,398,000 in 2007. Earnings per share were HK\$0.112 (2007: HK\$0.123).

本集團的營業額為507,628,000港元(二零零七年:470,496,000港元),增長8%。全年溢利為22,294,000港元,而二零零七年同期則為24,398,000港元。每股盈利為11.2港仙(二零零七年:12.3港仙)。

The Group is principally engaged in the manufacturing and trading of quality power cord and power cord sets, cables and wires, wire harnesses and plastic resins. 本集團之主要業務包括專門製造及營銷品質 穩定的電源線及電源線組合、導線、組合線 束及塑膠皮料。

FINAL DIVIDEND

末期股息

The Board of Directors recommend the payment of a final dividend of HK\$0.03 per share. Together with the interim dividend of HK\$0.02 per share, the Group's total dividend for the year 2008 amount to HK\$0.05 per share (2007: HK\$0.04 per share).

董事會建議派發末期股息每股3港仙,連同已派發的中期股息每股2港仙,本集團二零零八年之全年股息為每股5港仙(二零零七年:每股4港仙)。

The register of members of the Company will be closed from 27th April 2009 to 30th April 2009, both days inclusive, during which period no transfer of shares will be effected. Subject to the approval of shareholders at the Annual General Meeting to be held on 30th April 2009, the final dividend will be paid on or before 15th May 2009 to shareholders whose names are registered in the register of members of the Company at the close of business on 30th April 2009.

BUSINESS REVIEW

During the year, our sales in power cord and power cord sets, cables and wires, wire harnesses and plastic resins accounted for 58%, 12%, 29% and 1% of the Group's total turnover, respectively.

Although manufacturers in the past year have been facing severe head wind from the Global Financial Tsunami, the Group has implemented prudent strategy, set defined vision, adopted risk management, optimized cashflow management, conducted evaluation and take defensive measures on cost control. Consequently, the Financial Tsunami has not constituted significant impact on our result. The Group maintained steady growth in revenue and profit during the year under review. We, in the meantime, will continue to implement the same strategy in 2009.

Meanwhile, we focus on the development of high quality, stable returns and solid growth environmentally-proof products. This proven strategy has brought in positive contribution to our bottom line performance.

The implementation of the People's Republic of China's new labour law on 1st January 2008 has undoubtedly increased our cost. Nevertheless, the Group has continued to adhere to the regulations upon executing our employees policy. We are committed to lessening the surging pressure on costs by capitalizing on semi-automation to enhance efficiency and reduce manpower. As a result, the additional cost arising from the new labour law has not constituted substantial increase in cost.

業務回顧

年內,電源線及電源線組合、導線、組合線 束及塑膠皮料的銷售額,分別佔本集團營業 額之58%、12%、29%及1%。

雖然過去一年,席捲全球的金融海嘯對經濟造成嚴重打擊,為很多生產商帶來嚴峻考驗,但本集團憑藉審慎策略,確立清晰目標,做好風險管理,完善現金流管理,對各方面作出評估,制定防禦措施,小心控制成本,所以金融海嘯對本集團未有造成太大影響,在年內仍能保持其收益及利潤的穩健增長。同時,我們於二零零九年會繼續採取這些政策。

此外,本集團專注發展高質量、穩定回報及 增長產品,以及符合環保要求的電線業務之 策略,成效顯著,對盈利有一定貢獻。

中華人民共和國於二零零八年一月一日推出 的新勞動法無疑增加了成本負擔。恒都一直 都是依法執行人事制度,我們又致力透過加 強半自動化生產,提高效益及節省人手,減 輕成本壓力,因此新勞動合同帶來的附加成 本並未造成沉重的成本增幅。

FUTURE PROSPECTS

The Group achieved solid growth last year and is expecting a steady growth in sales volume in year 2009. There will be challenges arising from the weak global economy and the economic recession in many mature countries. However, the Group will continue to implement prudent strategy and take cautious measures to weather these challenges.

Our core strategy for 2009 is to provide customers with strong performance products at competitive price. With a progressive increase in production of high growth wire harnesses and environmentally-sound halogen-free products, we will continue to invest our resources in research and development of environmentally-friendly and green products.

On employees policy front, we will re-engineer our structure to streamline staff force and reduce expenses. In the meantime, the Group will capitalize on the Financial Tsunami opportunity to sharpen our management and operations edge by recruiting well-educated and experienced talents.

To conclude, 2009 will be a challenging year. But we believe if we remain positive, optimistic and prudent in enhancing efficiency, controlling cost and building closer partnership relationship with our customers, the Group's business will continue to grow and prosper in a progressive manner.

CORPORATE GOVERNANCE

The Group is committed to safeguarding shareholders' rights and enhancing corporate governance standard. As a result, we establish the Compliance Committee, Audit Committee, Remuneration Committee and Nomination Committee to adhere to the best practice.

SOCIAL RESPONSIBILITY

Being a responsible corporate citizen is the Group's strong belief. So we continue to participate and support community activities in both Hong Kong and the People's Republic of China.

未來展望

本集團去年業績取得穩定增長,展望二零零九年銷售數量表現將會繼續平穩。環球經濟疲弱,加上全球很多發達國家紛紛步入經濟衰退,對市道必然有所沖擊,但本集團仍以一貫審慎態度,推行穩健措施,面對挑戰。

我們於二零零九年的核心策略是為客户提供 高質量及價格具競爭力的產品,並且進一步 增加生產高增長的組合線束和符合環保要求 的無鹵電線產品。我們會繼續投放資源,研 究及開發環保產品,推廣綠色產品。

在僱傭政策方面,我們會調整架構,精簡人 手,削減開支。與此同時,本集團將利用目 前的金融海嘯機會,穩步物色和招聘具高學 歷和豐富經驗的人員,加強整體的管理及營 運實力。

總括來說,二零零九年是充滿挑戰的一年, 但我們相信只要抱著積極、樂觀和審慎的態度,提升營運效率,嚴格控制成本,加強與 客户的緊密合作夥伴關係,必定可以推動本 集團的業務增長,取得平穩成績。

本集團致力維護股東權益,提升企業管治水平。因此,我們設立監察委員會、審核委員會、薪酬委員會及提名委員會,遵守最佳守則。

Management Discussion and Analysis 管理層討論及分析

LIQUIDITY AND FINANCIAL RESOURCES

As at 31st December 2008, the consolidated indebtedness of the Group, including long-term borrowings of HK\$6,313,000, was HK\$73,410,000. The borrowings are mainly denominated in Hong Kong dollars. The cash and cash equivalents amounted to HK\$14.307.000.

As at 31st December 2008, the Group's trade receivables balance was HK\$106,576,000, representing 21.0% of the year's turnover of HK\$507,628,000. The Group adopted a stringent credit policy to minimize credit risk.

The interest cover was 6.3 times as compared to 5.2 times in 2007.

CAPITAL STRUCTURE

As at 31st December 2008, the consolidated shareholders' equity of the Group was HK\$236,411,000, an increase of 11.2% over that of the previous year. The debt to equity ratio, (calculated by dividing total liabilities to shareholders' equity), was approximately 54.0%.

CAPITAL EXPENDITURE AND MATERIAL ACQUISITIONS

During the year under review, capital expenditures were made in the construction of new facilities at Shi Yan District, Shenzhen and expansion of production capacity (approximate to HK\$17,754,000).

PLEDGE OF ASSETS

As at 31st December 2008, the Group's banking facilities amounting to approximately HK\$50,871,000 were secured by legal charges over certain leasehold land, land use rights, buildings and investment property of the Group with a total net book value of HK\$39,335,000.

SEGMENT INFORMATION

During the year under review, Hong Kong, America and the Mainland China continued to be the Group's major markets, accounting for approximately 43%, 31% and 17% of the Group's total sales respectively. The remaining 9% of sales were generated from customers located in Other Asian Countries and Europe.

流動資金及財務資源

於二零零八年十二月三十一日,本集團之借貸為73,410,000港元,其中6,313,000港元 為長期借貸。借貸主要以港元為單位。現金 及現金等價物達14,307,000港元。

於二零零八年十二月三十一日,本集團之應 收賬款結餘為106,576,000港元,佔年度營 業額507,628,000港元之21.0%。本集團採 納嚴謹之信貸政策,以盡量減低信貸風險。

盈利對利息倍數為6.3倍,二零零七年則為5.2倍。

股本結構

於二零零八年十二月三十一日,本集團之綜合股東資金為HK\$236,411,000港元,較去年上升11.2%。負債對資本比率(以負債總額除以股東資金計算)約為54.0%。

資本開支及重大收購

於回顧年度,資本開支為建造深圳石岩新廠 房及擴展生產(約17,754,000港元)

抵押資產

於二零零八年十二月三十一日,本集團約有50,871,000港元之銀行信貸乃以本集團若干租賃土地及土地使用權及樓宇及投資物業之法定抵押。該等土地及樓宇及投資物業之總賬面值淨值共39,335,000港元。

分部資料

回顧期內,香港,美國及中國大陸依舊是本 集團的主要銷售市場,分別佔本集團營業額 約43%,31%及17%。其他亞洲國家及歐 洲地區的客戶則佔本集團餘下約9%的營業 額。

EMPLOYEES' REMUNERATION POLICY

As at 31st December 2008, the Group employed approximately 1,600 full time management, administrative and production staff worldwide. The Group follows market practice on remuneration packages. Employee's remuneration is reviewed and determined by senior management annually depending on the employee's performance, experience and industry practice. The Group invests in its human capital, In addition to on-job training, the Group adopts policies of continuous professional training programs.

FOREIGN EXCHANGE EXPOSURE

All foreseeable foreign exchange risks of the Company are appropriately managed or hedged.

CONTINGENT LIABILITIES

As at 31st December 2008, the Group did not have any material contingent liabilities.

僱員薪酬政策

於二零零八年十二月三十一日,本集團在全球僱用約1,600名全職之管理、行政及生產人員。本集團之薪酬組合乃按市場常規而定。高級管理人員按僱員表現、經驗及業內常規,每年檢討及釐定僱員薪酬。本集團對人力資源作出投資,除為員工提供在職培訓外,亦制訂員工持續進修專業培訓政策。

匯率風險

本公司所有可預見外匯風險已被合適地監管 及對沖。

Perennial International Limited is firmly committed to statutory and regulatory corporate governance standards with emphasis on transparency, independence, accountability, responsibility and fairness.

恒都集團有限公司奉行法定及監管企業管治 標準,並著重其透明度、獨立、問責、負責 與公平。

THE CODE ON CORPORATE GOVERNANCE PRACTICES

With effect from 1st January 2005, the Company has applied the principles and complied with the requirements of the Code on Corporate Governance Practices (the "Code") as set out in Appendix 14 of the Rules Governing the Listing of Securities (the "Listing Rules") on The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

The Directors confirm that the Company fully complies to the Code Provisions, and adopts Recommended Best Practices as defined in Appendix 14 of the Rules Governing the Listing of Securities appropriately when possible.

THE BOARD

The Board's primary role is to protect and enhance long-term shareholder value. It sets the overall strategy for the Group and supervises executive management to whom the responsibility of managing the day-to-day operation of the Group is delegated. In the course of discharging its duties, the Board acts in integrity, due diligence and care, and in the best interests of the Company and its shareholders.

The Board oversees the Company in a responsible and effective manner. It has adopted formal terms of reference which details its functions and responsibilities. Its main responsibilities include, but not limited to, ensuring competent management, approving objectives, strategies and business plans, ensuring prudent conduct of operations within laws and approved policies, ensuring and monitoring integrity in the Company's conduct of affairs. Directors, as members of the Board, jointly share responsibility for the proper direction of the Company.

企業管治常規守則

自二零零五年一月一日起,本公司已採用並遵守香港聯合交易所有限公司(「聯交所」)證券上市規則(「上市規則」)附錄14所載之企業管治常規守則(「守則」)的要求。

董事確認本公司已全面遵守了該守則條文的 規定,及當適用時實行在證券上市規則附錄 14中定義的最佳建議常規。

董事會

董事會之主要角色乃保障及提升股東之長期 價值。董事會為本集團制定整體策略及監督 已獲授權處理本集團日常運作的行政管理 層。於執行職責期間,董事會秉承誠實、勤 勉及謹慎的態度,並以本公司及其股東的最 佳利益為依歸。

董事會以盡責的態度和有效的方式領導本公司,並已採納正式而詳列其職能及責任的職權範圍。董事會主要責任包括但不限於確保管理層有足夠能力執行管理;審批目標、策略和業務計劃;確保日常運作審慎進行及依循法律和既定政策;確保及監察本公司事務符合道德規範。所有董事會成員,對於為本公司制訂正確方針共同分擔責任。

THE BOARD (CONTINUED)

The Board currently consists of (9) members whose details are set out on pages 27 and 32. It meets quarterly and holds specific meetings as and when they are deemed necessary. The Board held four (4) meetings during the year ended 31st December 2008. A record of the Directors' attendance at Board meetings is set out on page 23 of this report.

The Group provides extensive background information about its history, mission and businesses to Directors. The Directors are also provided with the opportunity to visit the Group's operational facilities and meet with the management to gain a better understanding of its business operations.

The Board has separate and independent access to the senior management and the Company Secretary at all times. The Board also has access to independent professional advice where appropriate.

The Company has arranged for appropriate liability insurance for the Directors and the senior management of the Group for indemnifying their liabilities arising out of corporate activities. The insurance coverage is reviewed on an annual basis.

In order to reinforce the independence, accountability and area of responsibility, the role of the Chairman is separate from that of the Chief Executive Officer. Their respective responsibilities are clearly established and set out in writing. The Chairman manages the Board, while the Chief Executive Officer is responsible for implementing strategies, policies, and for conducting the Group's businesses.

Pursuant to the Bye-laws of the Company, one-third of the Directors that have served longest on the Board must retire at each annual general meeting, and may offer themselves for reelection. Each Director is subject to retirement by rotation at least once every three years. To enhance accountability, any further reappointment of an Independent Non-Executive Director, who has served the Board for more than nine years, is subject to a separate resolution as passed by the shareholders.

董事會(續)

董事會現由9名成員組成,其詳細資料載於第27及32頁。董事會每季度均舉行會議,並於需要時召開特別會議。董事會於截止二零零八年十二月三十一日之年度共舉行四次會議。董事出席董事會會議之記錄載於本報告第23頁。

本集團向董事提供關於其歷史、宗旨及業務 的廣泛資料。董事亦獲提供參觀本集團營運 設施並與管理層會面之機會,讓彼等更了解 本集團之業務運作。

董事會可於任何時間個別及獨立接觸高級管 理層及公司秘書。董事會亦可於適當時候獲 取獨立專業意見。

本公司已為本集團各董事及高級管理層安排 適當之責任保險,就公司活動導致彼等需負 之責任給予彌償。保障範圍將每年審議。

為加強各自之獨立性、責任及職責範圍,主席之角色乃獨立於行政總裁之角色,彼等各自之職責均以書面清楚界定。主席管理董事會:行政總裁則負責推行本集團之策略及政策,以及經營業務。

根據本公司之公司細則,於董事會服務年資最長的三分一之董事,必須於每次股東週年大會上按規定輪席告退,但可膺選連任。所有董事均須最少每三年輪席告退一次。為提升彼等對責任之承擔,任何已服務董事會超過九年之獨立非執行董事,於進一步連任時,必須由股東以獨立決議案批准通過。

THE BOARD (CONTINUED)

Pursuant to the requirement of the Listing Rules, the Company acknowledge receipt of a written confirmation from each of the Independent Non-Executive Directors for confirmation of their independence to the Company. The Company considers all its Independent Non-Executive Directors to be independent.

RESPONSIBILITIES OF THE DIRECTORS FOR THE FINANCIAL STATEMENTS

The Board should present a balanced, clear and comprehensible assessment of the Company's performance, position and prospects. The directors should prepare the accounts on a going concern basis, with supporting assumptions or qualifications as necessary. The board's responsibility to present a balanced, clear and understandable assessment extends to annual and interim reports, other price-sensitive announcements and other finance disclosures required under the Hong Kong Listing Rules, and reports to regulators as well as to information required to be disclosed pursuant to statutory requirements.

BOARD COMMITTEES

The Board has established four (4) committees, each of them having specific terms of reference, to consider matters relating to specialized areas and to advise the Board or, where appropriate, to decide on behalf of the Board on such matters. Details of these committees and their principal terms of reference are as follows:

董事對財務報表之責任

董事會應平衡、清晰及全面地評核公司的表現、情況及前景。董事擬備的賬目應以公司持續經營為基礎,有需要時更應輔以假設或保留意見。若董事知道有重大不明朗事件或情況可能。有關董事會應平衡、清晰及明白地評審公司表現的責任,適用於年度報告及中期報告、其他涉及股價敏感資料的通告及根據《上市規則》規定須予披露的其他財務資料,以及向監管者提交的報告書以至根據法例規定須予披露的資料。

董事委員會

- (c) System and procedures are in place to identify, measure, manage and control risks including liquidity, credit, market, business, regulatory, operational and reputational risks that may have an impact on the Group; and
- (d) Internal Audit Team performs independent reviews of the risks and key controls to provide reasonable assurance to the management and the Audit Committee that risks and controls have been adequately addressed.

External auditors shall also be invited to attend the Company's annual general meetings and are available to assist the Directors in addressing queries from shareholders relating to the conduct of the audit and the preparation and content of their auditor report.

PIEL is wholly-owned by Mr. Zhou Jing Zhuan, a director of Perernnial Cable (Shenzhen) Co. Ltd. ("PCS"). PIEL is thus a connected person of the Company and the transactions between PIEL and the Group constitute continuing connected transactions for the Company under the Listing Rules.

The Group has been supplying the Goods to PIEL since April 2006 on terms no less favourable to the Group than those offered to independent third parties. However, no master agreement was ever entered into by the Group with PIEL. Their past transactions were constituted by individual written purchase orders. The Master Agreement serves to provide a framework for the supply of Goods to PIEL on a long-term basis.

The revenue arising from the supply of goods to PIEL for the year ended 31st December 2008 was RMB75,000 (about HK\$ 79,000).

1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies adopted in the preparation of these consolidated accounts are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

These consolidated accounts are presented in thousands of Hong Kong dollars ("HK\$'000") unless otherwise stated.

1.1 Basis of preparation

The consolidated accounts have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs"). They have been prepared under the historical cost convention, as modified by the revaluation of buildings, investment property and derivative financial instruments which are carried at fair value.

The preparation of the accounts in conformity with HKFRS requires the use of certain critical accounting estimates. It also requires management to exercise its judgement in the process of applying the Group's accounting policies. The areas involving a higher degree of judgement or complexity, or areas where assumptions and estimates are significant to the consolidated accounts are disclosed in note 3.

1.2 Consolidation

The consolidated accounts include the accounts of the Company and its subsidiaries made up to 31st December.

Subsidiaries are all entities over which the Group has the power to govern the financial and operating policies generally accompanying a shareholding of more than one half of the voting rights. The existence and effect of potential voting rights that are currently exercisable or convertible are considered when assessing whether the Group controls another entity.

Subsidiaries are fully consolidated from the date on which control is transferred to the Group. They are deconsolidated from the date that control ceases.

Inter-company transactions, balances and unrealised gains on transactions between group companies are eliminated.

The consolidated accounts are presented in Hong Kong dollars, which is the Company's functional and presentation currency.

(ii) Transactions and balances

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in the profit and loss account.

Property that is held for long-term rental yields or for capital appreciation or both, and that is not occupied by the Group's companies, is classified as investment property. Investment property comprises land held under operating leases. Land held under operating leases are classified and accounted for as investment property when the rest of the definition of investment property is met.

Investment property is measured initially at its cost, including related transaction costs.

After initial recognition, investment property is carried at fair value. The valuation is reviewed annually by an external independent valuer on an open market basis. Separate value is not attributed to land and buildings. The valuation is incorporated in the accounts. Changes in fair values are recognised in the profit and loss account.

Subsequent expenditure is charged to the asset's carrying amount only when it is probable that future economic benefits associated with the item will flow to the Group and the cost of the item can be measured reliably. All other repairs and maintenance costs are expensed in the profit and loss account during the financial period in which they are incurred.

Buildings comprise factories and offices. Buildings are shown at fair value, based on regular valuations by an external independent valuer, less subsequent depreciation and impairment. Any accumulated depreciation and impairment at the date of revaluation is eliminated against the gross carrying amount of the asset and the net amount is restated to the revalued amount of the asset.

Increases in the carrying amount arising on revaluation of buildings are credited to building revaluation reserve in equity, except to the extent that it reverses a revaluation decrease for the same asset previously recognised in the profit and loss account, in which case the increase is credited to the profit and loss account to the extent of the decrease previously charged. Decreases that offset previous increases of the same asset are charged against building revaluation reserve directly in equity; all other decreases are expensed in the profit and loss account.

(ii) Other property, plant and equipment

Other property, plant and equipment, comprising leasehold improvements, plant and machinery, furniture and fixtures, office equipment, motor vehicles and pleasure boat are stated at cost less accumulated depreciation and accumulated impairment losses.

Construction in progress is stated at cost which comprises construction costs, purchase costs and other related expenses incurred in connection with the construction of buildings, plant and machinery for own use, less provision for impairment losses, if any.

(v) Gains or losses on disposals

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in the profit and loss account. Where revalued assets are sold, the amounts included in buildings revaluation reserve are transferred to retained earnings.

(i) Operating lease

Leases in which a significant portion of the risks and rewards of ownership are retained by the lessor are classified as operating lease. Payments made under operating lease (net of any incentives received from the lessor) are charged in the profit and loss account on a straight-line basis over the period of the leases.

(ii) Finance lease

Leases of assets where the Group has substantially all the risks and rewards of ownership are classified as finance lease assets. Finance lease assets are capitalised at the commencement of the lease and at the lower of the fair value of the assets and the present value of the minimum lease payments. Each lease payment is allocated between the liability and finance charges so as to achieve a constant rate on the outstanding finance balance. The corresponding rental obligations, net of finance charges, are included in current and non-current borrowings. The interest element of the finance cost is recognised in the profit and loss account over the lease period so as to produce a constant periodic rate of interest on the remaining balance of the liability for each period.

1.7 Leasehold land and land use rights

Leasehold land and land use rights are stated at cost less accumulated amortisation and accumulated impairment losses (if any). Cost mainly represents consideration paid for the rights to use the land on which various plants and buildings are situated for a period of 46 to 50 years from the date the respective right was granted. Amortisation of leasehold land and land use rights is calculated on a straight-line basis over the period of the leasehold land and land use rights.

1.8 Impairment of investments in subsidiaries and non-financial assets

Assets that have an indefinite useful life are tested for impairment annually. Assets are reviewed for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognised for the amount by which the asset's carrying amount exceeds it recoverable amount. The recoverable amount is the higher of an asset's fair value less costs to sell and value in use. Such impairment loss is recognised in the profit and loss account.

1.9 Inventories

Inventories are stated at the lower of cost and net realisable value. Costs are assigned to individual items on the first-in, first-out basis and are arrived at as follows:

- Raw materials purchased for use in the manufacturing process – invoiced price and shipping cost.
- (ii) Work in progress and finished manufactured goods – costs of direct materials, direct labour and an appropriate proportion of production overheads.

Trade and other receivables are recognised initially at fair value and subsequently measured at amortised cost using the effective interest method, less provision for impairment. A provision for impairment of receivables is established when there is objective evidence that the Group will not be able to collect all amounts due according to the original terms of receivable. The amount of the provision is the difference between the asset's carrying amount and the present value of estimated future cash flows, discounted at the effective interest rate. The amount of the provision is recognised in the profit and loss account. Subsequent recoveries of amounts previously written off are credited in the profit and loss account.

1.11 Cash and cash equivalents

The Group's cash and cash equivalents are categorised as loan and receivable financial assets.

Cash and cash equivalents comprise cash on hand and deposits held at call with banks with original maturities of three months or less

Borrowings are recognised initially at fair value, net of transaction costs incurred. Borrowings are subsequently stated at amortised cost; any difference between the proceeds (net of transaction costs) and the redemption value is recognised in the profit and loss account over the period of the borrowings using the effective interest method.

All borrowing costs are charged to the profit and loss account in the financial period in which they are incurred.

1.14 Employee benefits

(i) Employee leave entitlements

Employee entitlements to annual leave and long service leave are recognised when they accrue to employees. A provision is made for the estimated liability for long service leave as a result of services rendered by employees up to the balance sheet date.

Employee entitlements to sick leave and maternity leave are not recognised until the time of leave.

(iii) Retirement benefit costs

For Hong Kong employees, the Group contributes to Mandatory Provident Fund ("MPF") scheme in accordance with Hong Kong Mandatory Provident Fund Schemes Ordinance. Contributions to the MPF scheme by the Group and employees are calculated as a percentage of employees' remuneration received. The Group's contributions to MPF scheme are expensed as incurred. The assets of the MPF scheme are held separately from those of the Group in an independently administered fund.

For employees in the Mainland China, the Group contributes to a defined contribution retirement scheme managed by the local municipal government in the Mainland China. The Group's contributions to the retirement scheme are expensed as incurred while the local municipal government in the Mainland China undertakes to assume that the retirement benefit obligations of the qualified employees in the Mainland China.

The current income tax charge is calculated on the basis of the tax laws enacted or substantively enacted at the balance sheet date in the countries where the Company and its subsidiaries operate and generate taxable income. Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretation and establishes provisions where appropriate on the basis of amounts expected to be paid to the tax authorities.

Deferred income tax is provided in full, using the liability method, on temporary differences arising between the tax bases of assets and liabilities and their carrying amounts in the accounts. However, deferred income tax is not accounted for if it arises from initial recognition of an asset or liability in a transaction other than a business combination that at the time of the transaction affects neither accounting nor taxable profit or loss. Deferred income tax is determined using tax rates (and laws) that have been enacted or substantively enacted by the balance sheet date and are expected to apply when the related deferred income tax asset is realised or the deferred income tax liability is settled.

Deferred income tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the temporary differences can be utilised.

Deferred income tax is provided on temporary differences arising on investments in subsidiaries, except where the timing of the reversal of the temporary difference is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

Revenue comprises the fair value of the consideration received or receivable for the sale of goods, interest income and operating lease rental income in the ordinary course of the Group's activities. Revenue is shown net of value-added tax, returns, rebates and discount, and after eliminating sales within the Group.

The Group recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefits will flow to the entity and specific criteria have been met for each of the Group's activities as described below. The Group bases its estimates on historical results, taking into consideration of the type of customer, the type of transaction and the specifics of each arrangement. Revenue is recognised as follows:

- (i) Revenue from the sale of goods is recognised on the transfer of risks and rewards of ownership, which generally coincides with the time when the goods are delivered to customers and title has passed.
- (ii) Interest income is recognised on a timeproportion basis using the effective interest method.
- (iii) Operating lease rental income is recognised on a straight-line basis over the period of the lease.

Provisions are recognised when the Group has a present legal or constructive obligation as a result of past events, it is probable that an outflow of resources will be required to settle the obligation, and a reliable estimate of the amount can be made.

Provisions are measured at the present value of the expenditures expected to be required to settle the obligation using a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the obligation. The increase in the provision due to passage of time is recognised as interest expense.

1.18 Dividend distribution

Final dividend proposed to the Company's shareholders is recognised as a liability in the accounts in the period in which the dividend is approved by the Company's shareholders.

1.19 Segment reporting

In accordance with the Group's internal financial reporting, the Group has determined that business segments be presented as the primary reporting format and geographical segments as the secondary reporting format.

Unallocated costs and income represent mainly corporate expenses and income from investment property. Segment assets consist primarily of leasehold land and land use rights, property, plant and equipment, inventories, receivables and operating cash. Segment liabilities comprise operating liabilities. Unallocated assets represent deferred tax assets and investment property. Unallocated liabilities mainly comprises deferred tax liabilities, taxation payable, obligation under finance lease contracts, accruals for corporate expenses and short-term bank loans. Capital expenditure mainly comprises additions to property, plant and equipment and leasehold land and land use rights.

The Group's derivative financial instruments are caterorised as financial assets/liabilities at fair value through profit or loss.

Derivatives are initially recognised at fair value on the date a derivative contract is entered into and are subsequently remeasured at its fair value. Changes in the fair value of these derivative instruments that do not qualify for hedge accounting are recognised immediately in the profit and loss account.

1.21 Financial guarantee contract

A financial guarantee contract is a contract that requires the Company to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the original or modified terms of a debt instrument. A financial guarantee contract issued by the Company and not designed as at fair value through profit or loss is recognised initially at its fair value less transaction costs that are directly attributable to the issue of the financial guarantee contract. Subsequent to initial recognition, the Company measures the financial guarantee contract at the higher of: (i) the amount determined in accordance with HKAS 37 "Provisions, Contingent Liabilities and Contingent Assets"; and (ii) the amount initially recognised less, when appropriate, cumulative amortisation recognised in accordance with HKAS 18 "Revenue".

(a) Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk, price risk and interest rate risk), credit risk and liquidity risk. The Group's overall risk management programme focuses on the unpredictability of financial markets and seeks to minimise potential adverse effects on the Group's financial performance.

Management regularly manages the financial risks of the Group.

(i) Foreign exchange risk

The Group is exposed to foreign currency risk arising from various currency exposures, primarily with respect to Renminbi ("RMB"). Foreign exchange risk arises from future commercial transactions, recognised assets and liabilities and net investments in foreign operations. In addition, the conversion of RMB is subject to the rules and regulations of foreign exchange control promulgated by the Mainland China monetary authority.

The Group uses forward contracts to manage exposures arising from the fluctuation of RMB. Details are disclosed in note 25 to the consolidated accounts.

Should HK\$ strengthened/weakened by 6% at 31st December 2007 and 2008 against the RMB, with all other variables held constant, the impact of the profit after taxation and the equity for the year would have been approximately HK\$1,058,000 and HK\$263,000, respectively, higher or lower.

Certain of the assets of the Group are denominated in United States Dollar ("USD") but the foreign exchange risk is insignificant as USD to HK\$ exchange rate is pegged.

The Group exposes to fluctuations in the market price of major raw materials; copper rods and chemicals to make plastic resins.

The Group is able to pass certain realised price gains and losses on raw materials to certain customers through price adjustments, which can mitigate the price risk. The Group has not used any derivative instruments to hedge such economic exposures.

(iii) Interest rate risk

The Group's interest rate risk arises from bank borrowings. Borrowings at variable rates expose the Group to cash flow interest rate risk. Borrowings at fixed rates expose the Group to fair value interest rate risk. Details of the Group's borrowings have been disclosed in Note 23 to the consolidated accounts.

The Group has not used any hedging arrangement to hedge its exposure to interest rate risk.

The sensitivity analysis presents the effects on the Group's profit after taxation for the year as a result of changes in interest expense on floating rate borrowings. The sensitivity to interest rate used is based on market forecasts available at the balance sheet date and under the economic environments in which the Group operates, with other variables held constant.

The Group's bank balances and cash are deposited with financial institutions with reliable and acceptable rating quality. Management regularly assesses the credit risk of these financial institutions by reviewing their published financial information and credit rating.

The Group's exposure to credit risk arises from default of the counterparty, with a maximum exposure equal to the carrying amount of each financial asset, including cash and cash equivalents, trade and other receivables, and derivative financial instruments, as disclosed on the consolidated balance sheet.

The Group has concentration of credit risk. Certain level of sales made to the top 5 customers amounted to approximately HK\$137,000,000 (2007: HK\$136,000,000), representing 27% (2007: 29%) of total revenue for the year. The total accounts receivable balance of these top 5 customers as at 31st December 2008 was HK\$32,680,000 (2007: HK\$39,673,000).

The Group has policies in place to ensure sales are made to customers with an appropriate credit terms and the Group performs periodic credit check with reference to credit rating performed by external credit agents, and makes periodic assessment of the customers' payment history to assess the recoverability of trade receivables of its customers.

(v) Liquidity risk

Prudent liquidity risk management implies maintaining sufficient cash and making available an adequate amount of committed credit facilities with staggered maturities to reduce refinancing risk in any year and to fund working capital, debt servicing, dividend payments, new investments and close out market positions if required. The Group maintains significant flexibility to respond to opportunities and events by ensuring that committed credit lines available. As at 31st December 2008, the Group had available banking facilities of HK\$230,764,000 of which HK\$73,410,000 were utilised. In March 2009, the Group has obtained SME loans amounting to HK\$16 million for a period of 3 years. These SME loans are repayable on a monthly instalment basis.

The table below analyses the Group's financial liabilities and net-settled derivative financial liabilities into relevant maturity groupings based on the remaining period at the balance sheet date to the contractual maturity date. The amounts disclosed in the table are the contractual undiscounted cash flows. Balances due within 12 months equal their carrying balances as the impact of discounting is not significant.

The carrying amounts of the Group's financial assets and liabilities including cash and cash equivalents, trade and other receivables, trade and other payables, and short-term borrowings approximate to their fair values due to their short-term maturities. The fair value of financial liabilities for disclosure purposes is estimated by discounting the future contractual cash flows at the current market interest rate that is available to the Group for similar financial instruments.

The fair value of financial instruments traded in active markets is based on quoted market prices at the balance sheet date. The quoted market price used for financial assets and liabilities held by the Group is the current bid price.

The fair value of financial instruments that are not traded in an active market is determined by using valuation techniques. The Group uses a variety of methods and makes assumptions that are based on market conditions existing at each balance sheet date. Quoted market prices or dealer quotes for similar instruments are used for long-term debt. Other techniques, such as estimated discounted cash flows, are used to determine fair value for the remaining financial instruments.

Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

The Group makes estimates and assumptions concerning the future. The resulting accounting estimates will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

(a) Taxation

The Group is subject to taxation in several jurisdictions. Significant judgement is required in determining the provision for taxation. Sufficient provisions are set aside to meet all tax liabilities. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made.
