PROPOSAL FOR RE-ELECTION OF DIRECTORS PROPOSED GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

AND

NOTICE OF ANNUAL GENERAL MEETING

1. INTRODUCTION

The purpose of this circular is to provide you with the AGM Notice and the information regarding the Ordinary Resolutions that will be proposed at the AGM for the Shareholders to consider and, if thought fit, to re-elect the retiring Directors and to approve the granting of the General Mandates to the Directors.

2. RE-ELECTION OF DIRECTORS

The Board currently consists of three executive Directors, namely, Mr. Song Jiacheng, Mr. Cao Yu and Mr. Peng Kaichen, two non-executive Directors, namely, Mr. Zeng Jun and Mr. Lee Kwan Hung, Eddie and three independent non-executive Directors, namely, Mr. Chang Tso Tung, Stephen, Mr. Chan Chi On, Derek and Mr. Sun Lun.

Pursuant to Article 87 of the Articles of Association, at each annual general meeting one-third of the Directors for the time being (or, if their number is not a multiple of three, the whole number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at least once every three years. The Directors to retire in every year shall be those who have been longest in office since their last re-election or appointment but as between persons who became or were last re-elected as Directors on the same day those to retire shall (unless they otherwise agree among themselves) be determined by lot. As Mr. Cao Yu, Mr. Peng Kaichen and Mr. Zeng Jun have been longest in office, they shall retire as Directors at the AGM. Mr. Cao Yu, Mr. Peng Kaichen and Mr. Zeng Jun, being eligible, will offer themselves for re-election as Directors at the AGM.

Pursuant to Rule 13.74 of the Listing Rules, the biographical details of Mr. Cao Yu, Mr. Peng Kaichen and Mr. Zeng Jun are set out in Appendix I to this circular.

3. PROPOSED GENERAL MANDATES TO ISSUE SHARES

At the annual general meeting of the Company held on 21 May 2008, an ordinary resolution was passed to grant a general and unconditional mandate to the Directors to allot, issue and deal with new Shares up to a limit of 20% of the aggregate nominal amount of the issued share capital of the Company as at 21 May 2008. A further general mandate was also given to the Directors to allot and issue additional Shares by the number of Shares repurchased by the Company pursuant to the Repurchase Mandate passed on 21 May 2008. No Share was issued pursuant to these mandates.

The Directors believe that the renewal of the Issue Mandate is in the best interests of the Company and the Shareholders as a whole as this mandate will expire at the conclusion of the AGM. Accordingly, a renewal of the Issue Mandate will be sought from the Shareholders at the AGM to authorise the Directors to allot, issue and deal with additional Shares up to 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of the passing of the relevant resolution, which (on the basis of the issued capital of the Company as at the Latest Practicable Date) shall be 160,000,000 Shares.

The full text of the Ordinary Resolution to be proposed at the AGM in relation to the Issue Mandate is set out in resolution 4(a) in the AGM Notice set out on pages 15 to 19 of this circular.

4. PROPOSED GENERAL MANDATE TO REPURCHASE SHARES

At the annual general meeting held on 21 May 2008, an ordinary resolution was passed to grant a general and unconditional mandate to the Directors to repurchase Shares on the Stock Exchange of up to 10% of the aggregate nominal amount of the issued share capital of the Company as at 21 May 2008. No Share has been repurchased pursuant to such mandate.

As the existing Repurchase Mandate is going to expire at the conclusion of the AGM, the Directors believe that renewal of such mandate is in the interests of the Company and Shareholders as a whole. 5. AGM

At the AGM, Ordinary Resolutions will be proposed to approve, inter alia, the following:

DETAILS OF RETIRING DIRECTORS PROPOSED FOR RE-ELECTION AT AGM

Details of the followings Directors who will retire and eligible for re-election at the AGM in accordance with the Articles of Association are set out as follows:

1. MR. CAO YU

Mr. Cao Yu (曹榆), aged 46, is an executive Director and president of the Company and one of the founding shareholders of the Group. Mr. Cao graduated from Tianjin University (天津大學) with a master's degree in communications and electronic systems in 1987 and a bachelor's degree in electronic engineering in 1982. Mr. Cao has been a director of Gulf Security Technology Company Limited ("GST") and has served in various management positions in the Group since 1993. 1. SHARE CAPITAL

As at the Latest Practicable Date, there was a total of 800,000,000 Shares in issue. Subject to the passing of the resolution granting the Repurchase Mandate and on the basis that no further Shares are issued or repurchased before the AGM, the Company will be allowed to repurchase a maximum of 80,000,000 Shares during the period ending on the earliest of the conclusion of the next annual general meeting of the Company or the expiration of the period within which the next annual general meeting of the Company is required by any applicable law of the Cayman Islands or the Articles of Association to be held or when revoked or varied by an ordinary resolution of the Shareholders in general meeting.

2. REASONS FOR REPURCHASES

The Directors believe that it is in the best interests of the Company and the Shareholders to seek the Repurchase Mandate from the Shareholders. Such repurchase may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value of the Company and/or earnings per Share and will only be made when the Directors believe that such repurchase will benefit the Company and the Shareholders.

3. FUNDING OF REPURCHASES

Repurchases made pursuant to the Repurchase Mandate would be funded out of funds legally available for the purpose in accordance with the Company's memorandum and articles of association and the applicable laws and regulations of the Cayman Islands. There might be material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the audited accounts contained in the annual report of the Company for the year ended 31 December 2008) in the event that the Repurchase Mandate were to be carried out in full at any time during the proposed repurchase period. However, the Directors do not propose to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse impact on the working capital requirements of the Company or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Company.

4. SHARE PRICES

5. DISCLOSURE OF INTERESTS

None of the Directors or (to the best of the knowledge of the Directors, having made all reasonable enquiries) any associates of Directors has a present intention, in the event that the proposed Repurchase Mandate is approved by Shareholders, to sell Shares to the Company.

No connected persons of the Company have notified the Company of a present intention to sell Shares to the Company and no such persons have undertaken not to sell any Shares to the Company in the event that the Repurchase Mandate is granted by the Shareholders.

6. DIRECTORS' UNDERTAKING

The Directors have undertaken to the Stock Exchange that, so far as the same may be applicable, they will exercise the power of the Company to make purchases pursuant to the Repurchase Mandate in accordance with the Listing Rules, the Articles of Association and the applicable laws of the Cayman Islands.

7. TAKEOVERS CODE CONSEQUENCE

If, as a result of a repurchase of Shares, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition for the purposes of the Takeovers Code. Accordingly, a Shareholder, or a group of Shareholders acting in concert, depending on the level of shareholding interest, could obtain or consolidate control of the Company and become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code. The term "acting in concert" shall have the meaning as defined under the Takeovers Code and the term "concert party(ies)" shall be construed accordingly. Currently, the Directors have no intention to exercise the Repurchase Mandate to the extent as to further reduce the amount of Shares held by the public which is currently less than 25%.

As at the Latest Practicable Date, to the best knowledge of the Directors, GST International Management Limited ("GST International") held 427,479,369 Shares, representing approximately 53.43% of the issued share capital of the Company. On the basis that there is no further issue or repurchase of Shares and the holding by GST International in the number of Shares remains the same, in the event that the Directors exercise the power under the Repurchase Mandate in full, the percentage of shareholding of GST International would be increased to 59.37%. Such increase will not give rise to an obligation on the part of GST International to make a mandatory offer under Rule 26 of the Takeovers Code.

As at the Latest Practicable Date, to the best knowledge of the Directors, United Technologies Far East Limited ("UTFE") and its concert parties held 232,208,631 Shares, representing approximately 29.03% of the issued share capital of the Company. On the basis that there is no further issue or repurchase of Shares and the holding by UTFE and its concert parties in the number of Shares remains the same, in the event that the Directors exercise the power under the Repurchase Mandate in full, the percentage of shareholding of UTFE and its concert parties would be increased to 32.25%. Such increase will give rise to an obligation on the part of UTFE and its concert parties to make a mandatory offer under Rule 26 of the Takeovers Code.

According to the joint announcement dated 3 December 2008, UTFE has also announced a possible voluntary conditional cash offers to acquire all the issued shares in the capital of the Company held by GST International (other than those shares already held by UTFE and parties acting in concert with it), and for the cancellation of all the outstanding share options of the Company (the "Offers"). The Offers, if and when made, will be made on HK\$3.38 in cash for each share of the Company and HK\$0.58 in cash for each share option of the Company. The making of the Offers is conditional upon any applicable waiting periods for a response from the relevant governmental or regulatory body having expired or being terminated and/or any consent or approval (including without limitation any approval in relation to the PRC Antitrust Filing and national security approval, as may be necessary) of any governmental or regulatory body in relation to the Offers or the completion thereof having been obtained in terms reasonably satisfactory to UTFE pursuant to the provisions of any laws or regulations in the PRC and other relevant jurisdictions, in each case where necessary for completion of the Offers. As at the Latest Practicable Date, the application of the Offers has been submitted to the relevant governmental body of the PRC for approval.

Save as disclosed above, the Directors are currently not aware of any consequences which will arise under the Takeovers Code as a result of any repurchase made under the Repurchase Mandate.
