## **PARTNER COMMUNICATIONS ANNOUNCES FILING OF SHELF PROSPECTUS IN ISRAEL**

***ROSH HA'AYIN, Israel, September 2, 2009*** - Partner Communications Company Ltd ("Partner" or "the Company") (NASDAQ and TASE: PTNR), a leading Israeli mobile communications operator, announced today that it has filed a shelf prospectus with the Israeli Securities Authority and the Tel Aviv Stock Exchange. The filing of the shelf prospectus allows the Company the flexibility to offer from time to time ordinary shares, debt securities, debt securities convertible into ordinary shares, warrants to purchase ordinary shares, debt securities and commercial paper. Any future offering of these securities will be made pursuant to a supplemental shelf offering report which will describe the terms of the securities being offered and the specific details of the offering.

Securities may not be sold in the United States absent registration under the Securities Act of 1933, as amended (the "Securities Act") or without an application for exemption from the registration requirements of the Securities Act. Any offering of securities pursuant to the shelf prospectus and any supplemental shelf offering report will be made only in Israel to residents of Israel, will not be registered under the U.S. Securities Act, and will not be offered or sold in the United States or to U.S. Persons (as defined in Regulation "S" of the Securities Act).
