* In anticipation of the issue of the Conversion Shares upon Conversion of the Convertible Bonds, the Directors proposed to increase the authorised share capital of the Company from HK\$100,000,000.00 divided into 10,000,000,000 Shares of HK\$0.01 each to HK\$150,000,000.00 divided into 15,000,000,000 Shares of HK\$0.01 each by creation of an additional HK\$50,000,000.00 divided into 5,000,000,000 Shares of HK\$0.01 each. The increase in the authorised share capital of the Company is conditional upon the passing of an ordinary resolution by the Shareholders at the EGM. Please refer to the Company's announcement dated 11 January 2010 for more details.

** On 7 January 2010 (after trading hours), the Company entered into the Placing Agreement with the Placing Agent pursuant to which the Placing Agent agreed to procure, on a best effort basis, the Placee(s) to subscribe in cash for the Convertible Bonds up to a principal amount of HK\$264,000,000.00.
