POLL RESULTS AT THE ANNUAL GENERAL MEETING

The board of directors (the “**Board of Directors**”) of 洛陽樂川鉬業集團股份有限公司 China Molybdenum Co., Ltd.* (the “**Company**”) is pleased to announce that the Annual General Meeting of the Company for the year 2010 (the “**AGM**”) was held at 9:00 a.m. on Sunday, 6 June 2010 at the Meeting Room, 10th Floor, China Molybdenum Group Building, Luoyang City, Henan Province, the People's Republic of China (the “**PRC**”).

The number of issued shares of the Company as at the date of the AGM was 4,876,170,525 shares, being the total number of shares entitling the holders to attend and vote for or against any of the resolutions proposed at the AGM. There was no rejection or amendment to resolution at the AGM, and there was no other business proposed at the AGM. There were no restrictions on any shareholder casting votes on any of the proposed resolutions at the AGM. Shareholders of the Company and authorised proxies holding an aggregate of 3,750,954,432 shares, representing approximately 76.92% of the total issued shares of the Company were present at the AGM.

The holding of the AGM was in compliance with the requirements of the Company Law of the PRC and the provisions of the Articles of Association of the Company. The AGM was chaired by Mr Duan Yuxian, the Chairman of the Board.

Deloitte Touche Tohmatsu in this respect did not constitute an assurance engagement in accordance with Hong Kong Standards on Auditing, Hong Kong Standards on Review Engagements or Hong Kong Standards on Assurance Engagements issued by the Hong Kong Institute of Certified Public Accountants nor did it include provision of any assurance or advice on matters of legal interpretation or entitlement to vote.

PAYMENT OF THE FINAL DIVIDEND

The Board wishes to inform the Company's shareholders that the details of the payment of the final dividend are as follows:

The Company will pay a final dividend of RMB0.08 per share (including tax) for the year ended 31 December 2009 to shareholders whose names appeared on the register of members of the Company on 6 June 2010. Such final dividend shall be calculated on the average of the mean exchange rate of the conversion of RMB to Hong Kong dollars announced by the People's Bank of China one calendar week preceding 6 June 2010.

The Company will appoint a receiving agent in Hong Kong (the "**Receiving Agent**") and will pay to such Receiving Agent the final dividend declared for payment to holders of H shares. The final dividend will be paid by the Receiving Agent on or about Friday, 23 July 2010. The cheques will be dispatched to holders of H shares by ordinary post at their own risk.
