Reference is made to the announcement (the “**Announcement**”) of the Company dated 19 October 2010 relating to, among other matters, the placing of up to 400,000,000 Placing Shares and the Subscription of up to 400,000,000 Subscription Shares. Unless otherwise stated, capitalised terms used in this announcement shall have the same meanings as those defined in the Announcement.

The Board is pleased to announce that, following the completion of the Placing on 1 November 2010 (an aggregate of 400,000,000 Placing Shares have been so placed) and the granting of the listing of and permission to deal in the Subscription Shares by the Listing Committee of the Stock Exchange, all conditions under the Subscription Agreement have been fulfilled and completion of the Subscription took place on 1 November 2010. An aggregate of 400,000,000 Subscription Shares were issued to the Vendor and his nominee in accordance with the terms of the Placing and Subscription Agreement at completion of the Subscription.

As at the date of this announcement and after completion of the Subscription, there were 4,129,946,286 Shares in issue and the Vendor together with Ever Source Enterprises Limited are interested in 573,033,011 issued Shares, representing approximately 13.88% of the issued share capital of the Company.
