



# Chairman's Statement 主席報告書 · Minds

I am pleased to submit to the shareholders the annual report of the Company and its subsidiaries (collectively known as the "Group") for the financial year ended 31 December 2010.

本人欣然提呈本公司及附屬公司(合稱「本集團」)截至 二零一零年十二月三十一日止年度報告,敬請各位股 東瀏覽。

#### **Annual Results and Review**

The Group recorded a turnover of approximately RMB1,098,701,000 for the year ended 31 December 2010, representing an increase of approximately 84% over the previous year. The profit attributable to equity shareholders was approximately RMB49,215,000, and basic earnings per share was approximately RMB0.0115.

As over 90% of the domestic apple juice concentrate products are for export purpose, the global economic situation has a strong impact on the domestic apple juice concentrate industry. Given the current global economic recovery, export price of domestic apple juice concentrate has shown a steady upward trend. In 2010, exports of China's apple juice concentrate industry amounted to 784,150 tonnes (2009: 795,700 tonnes), representing a slight decrease compared with 2009. As the management of the Company adjusted the pace of product sales in 2009 while the selling price was low with a view to selling more such products when the price recovers, this led to a visible significant upward trend in both selling price and sales volume in the Group's products in 2010.

Under the trend of steady appreciation of Renminbi against US dollar, the Group has enhanced its cooperation with international renowned financial institutions and entered into term loan agreements with certain financial institutions to appropriately adjust the proportion of Renminbi and US dollar loans. The Directors believe that maintaining an appropriate proportion of US dollar loans can reduce the Group's exchange rate risk and finance costs, and can facilitate better business development. In expanding the domestic market sales, the Group continued to

#### 全年業績及回顧

本集團截至二零一零年十二月三十一日止年度實現本 集團收入約為人民幣1,098,701,000元,比去年同期上 升約84%; 實現股東應佔溢利約為人民幣49,215,000 元,每股基本盈利約為人民幣0.0115元。

由於國內濃縮蘋果汁行業產品90%以上用於出口, 受國際經濟形式影響較大。在目前全球性經濟復蘇的 帶動下,國內濃縮蘋果汁的出口價格已呈現穩步回升 趨勢。二零一零年年度中國濃縮蘋果汁行業出口量為 784,150噸,與二零零九年795,700噸相比略有下降。 由於公司管理層有意在二零零九年年度市場價格低迷 時調整了銷售速度,在二零一零年果汁價格回升後, 再進行銷售,這致使本集團產品在的銷售量和銷售價格 在二零一零年年度內呈現明顯上升的趨勢。

在人民幣對美元升值趨穩的形勢下,本集團繼續加強 了與國內外著名金融機構的合作,並與若干金融機構 訂立了定期貸款協議,適度調整了人民幣和美元貸款 之間的比例,董事相信,通過保持適度美元貸款的比 例,可有效降低本集團匯率風險和融資成本,以及更 好地促進業務的發展。在擴大國內市場銷售方面,本 集團積極致力於與國內著名飲料加工生產商保持優 質、穩定的合作關係,並積極開發新的優良客戶,開 拓新的銷售渠道,二零一零年年度,蘋果汁、梨汁和 香精的國內銷售均比二零零九年有所增加,銷售量佔 國內市場份額亦有大幅提升。在產業鏈延伸方面,本

maintain close and stable business relationships with certain renowned beverage manufacturers in China and has developed new good customers with broadened sales channels. In 2010, domestic sales of apple juice, pear juice and essence all increased as compared with the previous year; its market share in terms of sales volume in the domestic market also increased significantly from the previous year. For extension of the industrial chain, the Company, Andre Juice Co., Ltd. ("Andre BVI") and Chengdu President Enterprises Food Co., Ltd., a wholly-owned subsidiary of Uni-President China Holdings Limited ("Uni-President"), established a joint venture company, Yantai Tongli Beverage Industries Co., Ltd., to engage in the business of OEM processing and sales of various types of beverages, fruit juice, tea, dairy drinks, mineral water, jelly, flummery, cereal products, fruit puree, soybean milk, PET molding and stretching and contracted processing and sales of other products. The commencement of production of the joint venture company in May 2010 will further enhance the position and market share of our products in the domestic market. For research and development, the Group began to undertake the "Different Maturity Degree Apple Processing and Tank Farms Sterilized Storage Comprehensive Technology Development" project in the National Spark Program; the "Research and Development for Stable Clear Apple Juice Concentrate Processing Technology using Multivarieties and Immature Apples" in the International Cooperation Projects of Shandong Province; and the "Research and Development for Stable Clear Apple Juice Concentrate Processing Technology Using Multivarieties and Immature Apples" in the Yantai Municipal Science and Technology Development Plan. The Group has also completed the pilot processing technology research for the production of liquid apple aroma concentrate under low temperature and industrialization research for stable clear apple juice concentrate using multi-varieties and immature apples.

公司、Andre Juice Co., Ltd. (「安德利BVI」)及統一企業 中國控股有限公司(「統一企業」)之全資附屬公司成都 統一企業食品有限公司成立的合營企業烟台統利飲料 工業有限公司於二零一零年五月正式投入生產,該合 營企業,從事各類飲料、果汁、茶飲料、乳飲料、礦 質水、果凍、布丁、穀物製品、果漿、豆漿、PET瓶裝 注塑及吹瓶以及其他產品的代加工及銷售業務,合營 企業正式生產經營後,將進一步提高本集團產品在國 內市場的影響力,並推動內銷市場佔有率的增長。在 研發方面:本集團開始承擔國家星火計劃重點項目中 的「不同成熟度蘋果加工及大罐群無菌貯存綜合技術開 發」項目;山東省國際科技合作項目「多品種不成熟蘋 果加工穩定濃縮清汁技術研究開發」; 烟台市科技發展 計劃「多品種不成熟蘋果加工穩定濃縮清汁技術研究開 發」。完成了蘋果芳香液低溫濃縮生產技術的中試研究 和完成多品種不成熟蘋果加工穩定濃縮清汁技術的產 業化研究。

#### **Analysis of Industry and Our Market Share**

In 2010, the total volume of China's apple juice concentrate exports was approximately 784,150 tonnes, representing a slight decrease of 1.45% as compared to 795,700 tonnes in 2009. Although the Chinese apple juice concentrate industry has only begun mass production since the late 90's of last century, the industry grew at a tremendous rate and has claimed a world market share of over 50% within just a decade, owing to the abundant apple supplies in the PRC. In 2008, the global financial crisis had led the export-oriented Chinese juice concentrate industry into recession. The severe market condition continued until the third guarter of 2009. From the fourth guarter of 2009, as the global apple juice consumption gradually recovered, sales market also started to recover. In 2010, the demand for apple juice further increased, and the sales market continuously improved. Since the fourth guarter of 2010, the demand for the apple juice was resumed to the normal level before the economic crisis.

In fact, there remains ample of market demand for apple juice. Since apple juice itself is nutritious, people's increasing pursuit for green and healthy food, is bound to bring more rooms for development for the apple juice market. Currently, 85% of the world's apple juice consumer market is concentrated in the developed countries and their demand has basically become saturated with relatively stable growth. In these major consumer countries, we already have relatively fixed market share and customer base. Meanwhile, we believe that the developing countries are highly populated and people have increasingly focused on nutrition in diet and pure apple juice will undoubtedly be the best option. This growing consumer market will surely become a take-off area of future apple juice consumption. Being a leader in the Chinese apple juice concentrate industry and through our proactive and visionary leadership, we have gradually expanded the market share of our products and will seek to secure our leading position in the industry for more rapid and

#### 行業和本公司市場份額分析

二零一零年年度,中國濃縮蘋果汁出口量約為784,150 噸,與二零零九年年度出口量795,700噸相比下降了 1.45%。中國濃縮蘋果汁行業的大規模生產起始於上世 紀九十年代後期,但由於中國有著豐富的蘋果資源, 發展速度十分驚人,僅十年左右就佔據了世界濃縮果 汁市場超過50%的份額。二零零八年年度,全球經濟 危機導致以出口為主的中國濃縮蘋果汁行業處於極不 景氣的低谷,這種低迷的市場行情一直持續至二零零 九年第三季度。自二零零九年第四季度開始,世界蘋 果汁消費市場開始回暖,銷售市場也漸漸好轉。二零 一零年年度,蘋果汁的市場需求量日趨回升,銷售市 場持續好轉。自二零一零年第四季度,蘋果汁的需求 已開始恢復至經濟危機前的正常水平。

事實上,蘋果汁市場的需求空間仍然很大。由於蘋果 汁本身具有多種營養功能,隨著人們對綠色、健康食 品的不斷追求,必將給蘋果汁市場帶來更大的發展空 間。目前世界蘋果汁消費市場有85%集中在發達國 家,發達國家對蘋果汁的需求已經基本形成剛性,需 求量也保持較為穩定的增長態勢,在這些主要的消費 國家,我們都已擁有比較固定的市場份額和客戶群 體。同時,我們認為發展中國家人口眾多,人們也越 來越注重飲食的營養搭配,天然無添加的蘋果汁無疑 將是最好的選擇之一。這個正慢慢成熟的消費市場必 將成為未來蘋果汁消費的騰飛區。作為中國濃縮果汁 行業龍頭企業,本公司領導審時度勢,逐步擴大本公

better development. The export volume of the Group's products represented approximately 11% on the whole industry in 2009. In 2010, such percentage has increased to approximately 17%.

**Prospect and Outlook** 

With the rising demand brought by the global economic recovery and the demand for apple juice concentrate was stimulated by the current large price spread between orange juice and apple juice, we expect both the export volume and export price of apple juice will remain steady in the normal level. In addition, with the gradual implementation of specific measures favourable to the agricultural industry under the PRC government's macroeconomic policies as well as the gradual improvement of various relevant PRC laws and regulations, the Group will enjoy better development and financing opportunities. Aiming at enlarging its business scale, the Group will strive to further enlarge its market, enhance productivity, diversify products, expand sales, disperse markets and to develop financing channels, etc.



#### 前景與展望

In terms of juice production capacity, volatility in the industry will force some of the small and medium domestic enterprises out of the market. Moderate reshuffle in the industry will increase concentration in the industry and improve the industry competition. The Group will continue to target small and medium enterprises in the industry, domestic or abroad, to further increase the Group's annual production capacity for juice concentrate through capital activities such as merger and acquisition, and to strengthen its leading position in the industry. On domestic market sales, as the domestic consumer market for apple juice concentrate gradually expands, the Group will continue to maintain good business relationships with existing customers in the coming year while actively exploring new customers through our prime product quality and comprehensive services, with a view to opening a new page in our domestic market sales. On extension of the industrial chain, with the joint venture company jointly established and invested by the Group and Uni-President reaching full production capacity in 2011, the position of our products in the domestic market will be further enhanced, which will help drive our market share in the domestic market. On research and development of new products, in 2011, the Company will complete the industrialization research for the production technology of liquid apple aroma concentrate under low temperature and the industrialization of technology for stable clear apple juice processing using different variety and immature apples. In 2011, the Group will also strive to participate in the research projects under the National Science and Technology Support Program of the "12th Five-Year Plan".

For the year ended 31 December 2010, the Group's turnover increased to approximately RMB1,098,701,000 as compared to approximately RMB597,252,000 in 2009, representing a significant increase of approximately RMB501,449,000 or 84%. The Group's turnover was principally derived from the manufacture and sale of apple juice concentrate, pear juice concentrate, apple essence, feedstuff and related products. The sale of apple juice concentrate accounted for approximately 93% of the total turnover of the Group for the year ended 31 December 2010 (2009: approximately 94%). The increase in turnover was mainly attributable to the increase in sales volume and selling price of apple juice concentrate. The increase in sales volume and selling price was mainly caused by the increase in apple juice consumer sales since the fourth quarter of 2009 due to the recovery of the apple juice sales market.

For the year ended 31 December 2010, the Group's gross profit was approximately RMB150,493,000 and the gross profit margin was approximately 14%. For the corresponding period in 2009, the gross profit was approximately RMB89,015,000 and gross profit margin was approximately 15%.

#### 業績

For the year ended 31 December 2010, the Group's net profit (i.e. the profit for the year attributable to equity shareholders of the Company) decreased to approximately RMB49,215,000 as compared to approximately RMB64,382,000 for the corresponding period in 2009, representing a decrease of approximately RMB15,167,000 or 24%. The significant decrease in net profit was mainly attributable to the decrease in grants from the government and the income tax income.

#### Other Income

For the year ended 31 December 2010, other income of the Group was approximately RMB42,924,000, as compared to approximately RMB72,583,000 for the corresponding period in last year, representing a decrease of approximately RMB29,659,000. The decrease in other income was mainly due to the decrease in royalty fee received from an exclusive distributor to distribute products of the Group in US and Canada, and the decrease in grants from the PRC government.

#### **Distribution Costs and Administrative Expenses**

For the year ended 31 December 2010, the Group incurred distribution costs of approximately RMB76,609,000, as compared to approximately RMB44,478,000 in 2009, representing an increase of approximately RMB32,131,000 or 72%. The Group's distribution costs mainly included transport, export inspection and marketing expenses. Such increase was mainly attributable to the increase in sales volume and cost of transportation, causing the increase in transportation and export related expenses.

For the year ended 31 December 2010, the Group incurred administrative expenses of approximately RMB29,299,000 as compared to approximately RMB44,163,000 in 2009, representing a decrease of approximately RMB14,864,000 or 34%. Such decrease was mainly attributable to the strengthened cost control and the reduction in administrative expenditures by the Group.

截至二零一零年十二月三十一日止年度,本集團的管 理費用約為人民幣29,299,000元。與二零零九年約人 民幣 44,163,000 元相比,減少約人民幣 14,864,000 元 或34%。管理費用減少主要是由於集團加大成本控制 力度,減少各類行政開支所致。

#### **Net Finance Costs**

For the year ended 31 December 2010, the net finance costs of the Group were approximately RMB38,384,000, as compared to approximately RMB41,034,000 for the corresponding period in 2009, representing a decrease of approximately RMB2,650,000 or 6%. Such decrease was mainly due to the decrease in average loan balance and bank charges during the year.

#### **Investment Income**

For the year ended 31 December 2010, investment income recognised by the Group was approximately RMB9,181,000. Investment income mainly includes the increase in the carrying amount in share of total shareholders' equity of Yantai Andre Pectin Co., Ltd.\* (烟台安德利果膠有限公司)("Andre Pectin") by the Company. In 2010, since there was capital injection by a new investor to Andre Pectin, the equity interest of the Company in Andre Pectin was diluted from 20% to 18.95%. However, as the amount injected by the new investor was more than the share of the issued capital acquired by the investor, share premium was recorded. As a result, there was an increase in the carrying amount in the share of the total shareholders' equity in Andre Pectin by the Company. For the year ended 31 December 2009, investment income recognised by the Group was approximately RMB14,900,000. On 11 November 2009, Andre BVI, a wholly owned subsidiary of the Company, disposed of its 20% equity interest in Andre Pectin to Shandong Andre Group Co., Ltd.\* (山東安德利集團有限公司) ("Andre Group") and an independent third party for a total consideration of RMB50,000,000. The investment income derived from the disposal amounted to approximately RMB10,112,000, representing the difference between the consideration received and the carrying amount of the interests disposed of.

#### 財務成本淨額

#### Share of Profit from Associates

For the year ended 31 December 2010, share of profit from associates of the Group was approximately RMB4,043,000, as compared to approximately RMB12,544,000 in 2009, representing a decrease of approximately RMB8,501,000 or 68%. Such decrease was mainly due to the decrease in the equity interest held by the Company in Andre Pectin resulting from the disposals by Andre BVI of 20% equity interest in Andre Pectin to Andre Group and an independent third party on 11 November 2009.

#### Income Tax

For the year ended 31 December 2010, the income tax expense of the Group was approximately RMB6,665,000. For the corresponding period in 2009, the income tax income was approximately RMB7,687,000. During the year ended 31 December 2009, the production of condensed juice and biofeedstuff by the Company and certain of its subsidiaries and jointly controlled entities, including Baishui Andre Juice Co., Ltd.\* (白水安德利果蔬汁有限公司), Xuzhou Andre Juice Co., Ltd.\* (徐州安德利果蔬汁有限公司), Yantai Longkou Andre Juice Co., Ltd.\* (烟台龍口安德 利果汁飲料有限公司), Dalian Andre Juice Co., Ltd.\* (大連安德利果蔬汁有限公司), Binzhou Andre Juice Co., Ltd.\* (濱州安德利果汁飲料有限公司), Xianyang Andre Juice Co., Ltd.\* (咸陽安德利果蔬汁有限公司), Baishui Andre Bio-feedstuff Co., Ltd.\* (白水安德利生物 飼料有限公司), Longkou Andre Bio-feedstuff Co., Ltd.\* (龍口安德利生物飼料有限公司), were recognized as primary processing of agricultural produce under the Corporate Income Tax Law of the PRC and therefore were exempt from the PRC income tax. #### **Business Review**

#### Stabilising Market Coverage

During 2010, by adapting to the market demand and leveraging on its advanced production technology, superb product quality and comprehensive customer service, the Group maintained steady and recoverable market growth in overseas markets sales. The market share in terms of sales volume in the international market increased significantly from the pervious year.

#### **Expanding Domestic Sales Market**

The Group continued to maintain close and stable business relationships with certain renowned beverage manufacturers in the PRC and has developed new good customers with broadened sales channels. In 2010, domestic sales of apple juice, pear juice and essence all increased as compared with the previous year; its market share in terms of sales volume in the domestic market also increased significantly from the previous year.

#### **Commencement of Production of Joint Venture**

Yantai Tongli Beverage Industries Co., Ltd., a joint venture company established by the Company, Andre BVI and Chengdu President Enterprises Food Co., Ltd., a wholly-owned subsidiary of Uni-President, commenced production in May 2010. The joint venture company is engaged in the business of OEM processing and sales of various types of beverages, fruit juice, tea, dairy drinks, mineral water, jelly, flummery, cereal products, fruit puree, soybean milk, PET molding and stretching and contracted processing and sales of other products. The commencement of production of the joint venture company will further enhance the position of our products and help drive our market share in the domestic market.

#### 穩定市場覆蓋

#### Share of Investment Cost in Two Pomace Companies

On 10 February 2010, each of Xuzhou Andre Juice Co., Ltd.\* (徐州安德利果蔬汁有限公司) ("Xuzhou Andre Juice") and Baishui Andre Juice Co., Ltd.\* (白水安德利 果蔬汁有限公司) ("Baishui Andre Juice"), two whollyowned subsidiaries of the Company, entered into an equity transfer agreement with Andre Pectin to sell its 75% equity interest in each of Xuzhou Andre Pomace Products Co., Ltd.\* (徐州安德利果渣制品有限公司) ("Xuzhou Andre Pomace") and Baishiu Andre Biofeedstuff Co., Ltd.\*(白水安德利生物飼料有限公司) ("Baishui Andre Bio-feedstuff"), respectively, to Andre Pectin.

The Directors believed that the manufacture of pomace products and bio-feedstuff requires advanced technological know-how and support for market promotions, which involve substantial capital investments. It would be more cost-effective for the Group to have other investors to share the costs of investments and hence decided to transfer 75% equity interest in each of Xuzhou Andre Pomace and Baishui Andre Bio-feedstuff to Andre Pectin. Andre Pectin has ample experience in developing pomace products manufacture technologies. The Directors are therefore of the view that the cooperation with Andre Pectin will facilitate the business development of the Group.

#### Research and Development

The Group began to undertake the "Different Maturity Degree Apple Processing and Tank Farms Sterilized Storage Comprehensive Technology Development" project in the National Spark Program; the "Research and Development for Stable Clear Apple Juice Concentrate Processing Technology Using Multivarieties and Immature Apples" in the International Cooperation Projects of Shandong Province; and the "Research and Development for Stable Clear Apple Juice Concentrate Processing Technology Using Multivarieities and Immature Apples" in the Yantai Municipal Science and Technology Development Plan. The Group has also completed the pilot processing technology research for the production of liquid apple aroma concentrate under low temperature and industrialization research for stable clear apple juice concentrate using multi-varieties and immature apples.

#### **Future Prospects**

#### Market Expansion and Product Diversification

Currently the Group has established relatively stable market penetration and customers groups in major consumer markets of apple juice concentrate in the world, namely the US, European, Oceania, African countries and Japan. The Company will put more efforts in the development of various emerging markets, with a view to breaking through these markets. On the other hand, the Company has in recent years explored the market opportunities for its new products and niche products as well as the development of new customers groups. This will satisfy both the needs of the market and our customers, as well as fulfill our target of product mix expansion.

#### Continue the Development of Traceability and Farm Management Improvement Linkages Project

In the coming year, the Group will more strictly implement the GLOBALGAP standardisation in the regulation and development of existing and newly established recognition bases. Improvements will be made in the areas of production, management, storage and sales, etc. to generate more revenue from the GLOBALGAP bases, with a view to building up modelling status so that surrounding fruityards will follow the GLOBALGAP standardisation.

#### **Develop Financing Channels**

The Group will closely monitor the trend of Renminbi exchange rate against US dollar and adjust the proportion of Renminbi and US dollar loans. The Group will continue to actively engage in cooperation with domestic and international financial institutions to diversify its financing channels and increase the variety of financing products, in order to reduce the Group's exchange rate risk and finance cost, improve capital structure and facilitate better business development.

#### **Term Facility Agreement with Certain Financial Institutions**

#### **Capital Structure**

The H shares of the Company were listed on the Growth Enterprise Market of the Stock Exchange (the "GEM") on 22 April 2003. On 19 January 2011, the H shares of the Company were transferred and listed on the Main Board of the Stock Exchange (the "Main Board") and de-listed from GEM. The capital of the Company comprises only ordinary shares (comprising domestic shares and H shares). Details of the share capital of the Company are set out in note 34 to the Financial Statements.

#### **Liquidity and Financial Resources**

The Group generally financed its operations and investing activities by internally generated financial resources and loans from banks. As at 31 December 2010, the Group had outstanding short-term and longterm bank loans of approximately RMB740,742,000 and RMB136,593,000 respectively. As at 31 December 2010, the short-term bank loans of RMB619,878,000 bore interest at rates ranging from 4.29% to 6.38% per annum and the short-term bank loans of RMB66,227,000 bore floating interest rate of higher of SIBOR + 1.3% or USD best lending rate. Short-term bank loans of RMB54,637,000 bore floating interest rate of LIBOR +3.2%. The long-term bank loans bore floating interest rate of LIBOR +3.2%, with maturity in 2012. In the year 2010, the Group repaid on time the loans due for repayment. The Directors consider that the Group has sufficient financial resources to meet its ongoing operation requirements.

#### **Gearing Ratio**

As at 31 December 2010, the Group had cash and cash equivalents of approximately RMB142,906,000. The Group's gearing ratio as at 31 December 2010 was approximately 49% (2009: approximately 49%) which is calculated by dividing the Group's total liabilities of approximately RMB1,141,302,000 (2009: RMB1,137,412,000) by the Group's total assets of approximately RMB2,340,447,000 (2009: RMB2,302,316,000).

#### **CORPORATE GOVERNANCE PRACTICES**

The articles of association, the terms of reference of the Audit Committee and the terms of reference of the Supervisory Committee of the Company form the framework for the code of corporate governance practice of the Company.

The Board has reviewed its corporate governance documents and is of the view that such documents have incorporated all of the principles and code provisions in the "Code on Corporate Governance Practices" (the "CG Code") of The Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Listing Rules"). The followings are the major aspects in which the Company's own corporate governance code exceed the code provisions in the CG Code:

- the Company has established a nomination committee in accordance with the recommended best practices of the CG Code; and
- the Board held 7 meetings during 2010.

The Board will constantly monitor and, if necessary, revise the corporate governance documents of the Company, and assess the effectiveness of the Company's corporate governance practices in order to adapt to changes in the environment and requirements under the CG Code, so as to ensure that the Company's corporate governance documents and practices are in line with the expectations and interests of the shareholders and comply with the CG Code.

The Company has complied with all the code provisions set out in the CG Code during the period under review.

#### **BOARD OF DIRECTORS**

The Company is managed by a Board of Directors, which has the responsibility for leadership and control of the Company. Through the Board, the Directors are collectively responsible for promoting the success of the Company by directing and supervising the Company's affairs.

#### The Directors

As at the date of this annual report, the Board comprised a total of nine Directors, including two executive Directors, namely, Mr. Wang An (Chairman) and Mr. Zhang Hui (Chief Executive Officer); three nonexecutive Directors, namely, Mr. Lin Wu-Chung, Mr. Liu Tsung-Yi and Mr. Jiang Hong Qi; and four independent non-executive Directors, namely, Ms. Yu Shou Neng, Ms. Qu Wen, Mr. Gong Fan and Mr. Chow Kam Hung.

Except for Mr. Gong Fan and Mr. Chow Kam Hung, each of the Directors has entered into a service contract with the Company for a term of three years. Each of Mr. Gong Fan and Mr. Chow Kam Hung has entered into a service contract with the Company for a term commencing from 18 January 2011 until the conclusion of the Company's annual general meeting to be held in the year of 2013. All Directors are appointed by the shareholders at the shareholders' meeting with formal letters of appointment setting out the key terms and conditions relative to their appointment.

The independent non-executive Directors possess a wide range of skill and experience. They serve the important function of providing adequate monitoring and balances for safeguarding the interests of the shareholders and the Company as a whole. The Board considers that they can make independent judgment effectively and fulfill the independence guidelines set out in Rule 3.13 of the Listing Rules.

The biographical details of the Directors are set out on pages 25 to 30 of this report.

The Board is also responsible for preparing the financial accounts of the Company. The day-to-day management of the Company's business is delegated to the chief executive officer and the management. The functions of the Board and the powers delegated to the chief executive officer are reviewed periodically to ensure that they remain appropriate.

To ensure a balance of power and authority, the role of the chairman is separate from that of the chief executive officer. The chairman of the Company is Mr. Wang An. The chairman is responsible for convening and holding general meetings and Board meetings, tracking the progress of implementation of the resolutions passed by the Board, signing the securities issued by the Company and carrying out other powers conferred by the Board. Mr. Zhang Hui is the chief executive officer of the Company. The chief executive officer and the management are responsible for the production, operation and management of the Company, implementation of the resolutions passed by the Board, implementation of annual business plans and investment proposals, formulation of the internal management structure, the basic management system and the specific governance of the Company. In particular, the chief executive officer is responsible for proposing to the Board for appointment or dismissal of deputy general manager, financial controller and other senior management of the Company, appointment or dismissal of other management staff whose appointment and dismissal does not require approval from the Board and carrying out other powers conferred by the Board and the articles of association.

#### **Board Meetings**

The chairman is responsible for the leadership of the Board, ensuring the effectiveness of the Board in all aspects of its role, setting agenda for board meetings, and taking into account any matters proposed by other Directors for inclusion in the agenda. Agenda and accompanying board papers are circulated where possible at least 3 days before the time of a board or committee meeting. The chairman is also responsible for making sure all Directors are properly briefed on issues arising at board meetings. The chairman ensures that the Directors receive accurate, timely and clear information. Directors are encouraged to update their skills, knowledge and familiarity with the Company through their initial induction, ongoing participation at board and committee meetings, and through meeting key people at head office and in the divisions.

All Directors have access to the services of the company secretary who regularly updates the Board on governance and regulatory matters. Any Director, who wishes to do so in the furtherance of his or her duties, may seek independent professional advice through the chairman at the Company's expense. The availability of professional advice extends to the Audit, Remuneration and other Committees.

Minutes of Board meetings are taken by the company secretary or the secretary to the Board and, together with any supporting Board papers, are available to all Board members. Board meetings are structured to encourage open and frank discussions to ensure the non-executive Directors provide effective enquiries to each executive Director. When necessary, the independent non-executive Directors meet privately to discuss matters which are relevant to their specific responsibility.

When the Board considers any proposal or transaction in which a Director has conflict of interest, the Director declares his interest and is required to abstain from voting and withdraw from the meetings as appropriate. The Company seeks confirmation from the Directors annually in respect of any transactions of the Company or its subsidiaries which are related to Directors or their associates.

### **DIRECTORS' SECURITIES TRANSACTIONS**

Prior to the transfer and listing of the H shares of the Company on the Main Board on 19 January 2011, the Company had adopted a code of conduct regarding Directors' securities transactions (the "Securities Code") pursuant to The Rules Governing the Listing of Securities on the Growth Enterprise Market of The Stock Exchange of Hong Kong Limited (the "GEM Listing Rules") on terms no less exacting than the required standard of dealings contained in Appendix 10 of the Listing Rules. A copy of the Securities Code is sent to each Director upon his appointment and thereafter four times annually, that is one month before the date of the Board meetings to approve the Company's quarterly results and half year results and two months before the date of the Board meetings to approve the Company's annual results, with a reminder that the Director cannot deal in the securities and derivatives of the Company until after such results have been published.

Having made specific enquiry of all Directors, all Directors have confirmed that they have complied with the required standard of dealings and the requirements in the Securities Code during 2010.

Specific employees who are likely to be in possession of unpublished price-sensitive information of the Company are also subject to compliance with the Securities Code. No incident of non-compliance was noted by the Company in 2010.

#### SUPERVISORY COMMITTEE

The Supervisory Committee of the Company comprises three members of which two are recommended by shareholders and one is an employee representative elected by the employees. The Supervisory Committee is responsible for supervision of the Board, members of the Board and senior management, to prevent authority abuse, shareholders' interest infringement and to protect legal interest of the Company and its employees. During 2010, the Supervisory Committee held one meeting, during which the committee members reviewed the Company's financial position, legal compliance of the Company's operations and diligence of the senior management.

#### **INTERNAL CONTROL**

#### Internal control system

The Board has the overall responsibility for setting and reviewing the Company's system of internal control. The Audit Committee will also review the effectiveness of such system periodically. Procedures applied by the Audit Committee for reviewing the effectiveness of the Company's internal control system include: discussion with the management on the risky areas arising from auditing and/or raised by the management, reviewing material issues arising from internal or external audit report and reviewing material matters identified by internal auditors and risk assessment manager of the Group. The internal control system of the Company plays an effective role in risk management which is a very important factor for ensuring the achievement of operational goal. The establishment of internal control system is for safeguarding assets against unauthorised use or disposition; for maintaining proper accounting records; and for the reliability of financial information used within the business or for publication. However, the procedures provide reasonable but not absolute assurance against material errors, losses or fraud. Procedures for the Company's internal control system have been designed in accordance with the applicable laws, rules and regulations.

A review of the Company's internal control system covering financial, operational, compliance and risk management is conducted annually. In particular, the Board has considered the adequacy of resources, qualification and experience of staff of the Company's accounting and financial reporting function, and their training programmes and budget. The Board has conducted a review of the effectiveness of the Group's system of internal control. The result has been reported to the Board.

The Board confirms that systems and procedures are in place to identify, control and report on significant risks involved in achieving the Company's strategic objectives. Exposures to these risks are monitored by the Board with the support of various committees and senior management. For the year under review, the Board considered that the Company's internal control system was adequate and the Company had complied with the code provisions on internal control under the CG Code.

#### **INTERNAL AUDIT**

The Internal Audit Department provides an independent review of the adequacy and effectiveness of the internal control system. The department is headed by a manager who is familiar with the Company's operation. Its scope of work mainly includes auditing of financial and operational systems, observance of relevant policies and regulations, regular and special auditing, auditing of production effectiveness, etc. The audit plan, which is prepared based on risk assessment methodology, is discussed and agreed every year with the Audit Committee. In addition to its agreed annual schedule of work, the Internal Audit Department conducts other special reviews as required.

The primary reporting line of the Internal Audit Department is to the chairman of the Board but there is also direct access to the Audit Committee. Internal audit reports are sent to the chief executive officer, the financial controller, external auditors and the relevant management of the departments under audit. A summary of major audit findings is reported to the Audit Committee. The Board and the Audit Committee actively monitor the number and seriousness of findings raised by the Internal Audit Department and also the corrective actions taken by relevant departments.

#### **RISK MANAGEMENT**

Risk management is concerned with the identification and effective management of business risks, including safety and security, legal, environmental and reputational risks.

#### **Risk Management Committee**

The Company has established a Risk Management Committee which coordinates the proper application of operational risk management procedures throughout the Company. The Committee assists the Board to fulfill its oversight role over the Company and its subsidiaries in, among others, the following areas:

- establishment of the risk approach and risk management strategy of the Company to formulate its risk profile;
- identification, assessment and management of the material risks faced by the various business units of the Company;
- reviewing and assessment of the adequacy of the Company's risk management process, system and internal control; and
- reviewing and monitoring the Company's risk management process, system and internal control, including whether the development of the Company's business is prudent and in compliance with the legal requirements.

#### **AUDIT COMMITTEE**

The Audit Committee is responsible for reviewing the Group's financial reporting, internal controls and corporate governance issues and making relevant recommendations to the Board. All of its members are independent non-executive Directors (namely Mr. Wu Jian Hui (retired on 30 June 2010), Ms. Qu Wen, Ms. Yu Shou Neng, Mr. Xu Guang Zhou (appointed on 30 June 2010 and resigned on 18 January 2011), Mr. Gong Fan (appointed on 18 January 2011) and Mr. Chow Kam Hung (appointed on 18 January 2011)) and its current chairman, Mr. Gong Fan, is an independent non-executive Director.

The terms of reference of the Audit Committee are based on the guidelines recommended by the Hong Kong Institute of Certified Public Accountants.

The Audit Committee met four times in 2010. During 2010, it met to review the internal and external audit findings, the accounting principles and practices adopted by the Group, internal control and listing rules and statutory compliance, and to discuss auditing, internal controls, risk management and financial reporting matters. The quarterly, interim and annual accounts for 2010 were recommended to the Board for approval after discussion of the Audit Committee.

#### **EXTERNAL AUDITOR**

In 2010, the total remuneration paid to the external auditor amounted to approximately RMB1,830,000, of which RMB1,480,000 was for audit services provided by external auditor. The audit fee and other service fee were approved by the Audit Committee and endorsed by the Board.

#### **Remuneration Policy for Directors**

Remuneration of Directors is subject to annual assessment and recommendation by the Remuneration Committee to the Board for further review and approval, which subsequently require approval by the shareholders at annual general meeting. The primary goal of the remuneration policy on executive remuneration packages is to enable the Company to retain and motivate executive Directors by linking their compensation with performance as measured against corporate objectives. Under the policy, a Director is not allowed to approve his own remuneration.

The elements of the Company's executive remuneration package include basic compensation (comprising of director fee) and discretionary bonus without capping. In determining guidelines for each compensating element, the Company refers to remuneration surveys conducted by independent external consultants on companies operating in similar businesses.

#### **Basic Compensation**

The Remuneration Committee annually reviews and approves the basic compensation of each Director in accordance with the Company's remuneration policy. In accordance with the service contracts entered into by the Company and each of the Directors, all Directors have the right to receive fixed basic compensation.

#### **Discretionary Bonus**

Under the service contracts between the Company and each of the Directors, the Directors are entitled to a discretionary bonus based on the Company's results and the degree of responsibilities of each of the Directors. During the year ended 31 December 2010, the Directors did not receive any discretionary bonus.

The amounts paid to each Director of the Company for 2009 and 2010 are disclosed in note 12 to the Financial Statements. Messrs Lin Wu-Chung and Liu Tsung-Yi, two non-executive Directors, have waived their director's emoluments with effect from 1 April 2010.

#### **NOMINATION COMMITTEE**

The Nomination Committee is chaired by Mr. Wang An, an executive Director, and comprises Mr. Wu Jian Hui (retired on 30 June 2010), Ms. Qu Wen and Ms. Yu Shou Neng (appointed on 30 June 2010) as members. The role of the Committee is to make recommendations to the Board on the appointment of Directors, evaluation of Board composition and the management of Board succession with reference to certain guidelines as endorsed by the Nomination Committee. These guidelines include appropriate professional knowledge and industry experience, personal ethnics, integrity and personal skills, and time commitments of members. The Nomination Committee carries out the process of selecting and recommending candidates for directorship including the consideration of referrals and engagement of external recruitment professional when necessary. #### **INVESTOR RELATIONS**

The Company is committed to fair disclosure and comprehensive, transparent reporting. The chairman of the Company is ultimately responsible for ensuring that there is effective communication with investors and that the Board understands the views of the major shareholders. The chairman therefore makes himself available to meet with the shareholders for this purpose. On a day-to-day basis, the Board's primary contact with the major shareholders is through the chief executive officer and financial controller of the Company.

The sales attributable to the top five customers of the Group accounted for about 49.51% of the Group's total turnover and sales to the largest customer included therein amounted to about 12.20%.

Any insufficiency will be distributed from the profit for distribution to the shareholders of the Company generated in or after 2008. The proposal to declare and pay this final dividend will be submitted to the shareholders of the Company at the forthcoming annual general meeting to be held on 28 June 2011. Final dividend for Domestic Shares will be distributed and paid in Renminbi whereas dividend for H Shares will be declared in Renminbi and paid in Hong Kong dollars. The register of holders of H Shares of the Company will be closed from 28 May 2011 (Saturday) to 28 June 2011 (Tuesday) (both days inclusive) during which no transfer of H Shares will be registered. In order to qualify for entitlement to the proposed final dividend and for attending and for voting in the forthcoming annual general meeting of the Company, all transfers of H Shares accompanied by the relevant share certificates and transfer forms must be lodged with the Company's H Share Registrar, Tricor Tengis Limited at 26/F., Tesbury Centre, 28 Queen's Road East, Wanchai, Hong Kong for registration not later than 4:30 p.m. on 27 May 2011 (Friday). The final dividend will be distributed within one month from the conclusion of the forthcoming annual general meeting.

Pursuant to the Corporate Income Tax Law, any Chinese domestic enterprise (including our Company) which pays dividend to a nonresident enterprise shareholder shall withhold corporate income tax at 10% for and pay by the Company on behalf of such shareholder. At the same time, pursuant to the provisions of the "Preferential Policy on Profit Earned by Foreign Investors from Foreign Investment Enterprises" in the Circular of the Ministry of Finance and the State Administration of Taxation Concerning Several Preferential Policies Relevant to Corporate Income Tax, any profit accumulated and not yet distributed before 1 January 2008 by foreign investment enterprise when distributed to non-resident enterprise in or after 2008, will be exempted from corporate income tax. Any dividend distributed to non-resident enterprises from profit accumulated since 2008 will be subject corporate income tax.

For this purpose, any H Shares registered under the name of non-natural persons in the H Share register of members of the Company on 27 May 2011 (Friday), including HKSCC Nominees Limited, other nominees, trustees or other groups and organizations, will be treated as non-resident enterprise shareholders.

This arrangement is conditional upon obtaining the final approval from the relevant tax authority. If the Company cannot obtain final approval from the relevant tax authorities regarding the exemption of corporate income tax for non-resident enterprise shareholders as mentioned above, the Company will distribute the final dividend to such non-resident enterprise shareholders after withholding corporate income tax of 10% as required by the Corporate Income Tax Law. The Company will issue a separate announcement regarding the withholding of 10% corporate income tax issue after consultation with the relevant tax authority.

The Company will have no liability in respect of any claims arising from any delay in, or inaccurate determination of the status of the shareholders or any disputes over the mechanism of withholding.

These share transfers were completed in April 2010. Andre Pectin currently owns 75% equity interest in each of Xuzhou Andre Pomace and Baishui Andre Bio-feedstuff and the remaining 25% equity interest in each of Xuzhou Andre Pomace and Baishui Andre Biofeedstuff are indirectly held by the Company. Mr. Wang An, a Director of the Company, through his controlled corporation, Andre Group has 37.9% equity interest in Andre Pectin.

Following the completion of the restructuring of Andre Pectin in 2005, Andre Pectin ceased to be a subsidiary of the Company, and was owned as to 40% by Andre BVI, a wholly-owned subsidiary of the Company, and as to 35% by Bytetron Limited and 25% by Richride Investments Limited, both strategic investors. Further information about such restructuring has been disclosed in the relevant announcement and circular of the Company dated 16 March 2005 and 4 April 2005 respectively.

On 24 December 2010, Andre Pectin increased its registered share capital, which was contributed entirely by a new investor. On the same date, Richride Investments Limited transferred its 25% equity interests in Andre Pectin to the new investor who contributed to the new capital increased and two other new investors. Upon completion of the capital increase and transfers, Andre Pectin is owned as to 37.90% by Andre Group, 18.95% by the Company, 4.74% by Yantai Anlin Fruit Industry Co., Ltd.\* (烟台安林果業有限公司), 9.47% by Meng Yu Corporation Pte. Ltd., and the remaining 28.94% equity interests in Andre Pectin are held by the three new investors, who are independent investors.

### **Organisation and principal activities** 1

Yantai North Andre Juice Company Limited (the "Company") was established in the form of a Sino-foreign equity joint venture in Yantai, Shandong province, the People's Republic of China (the "PRC") on 30 March 1996.

With the approval from the Ministry of Commerce (formerly the Ministry of Foreign Trade and Economic Cooperation) of the PRC, the legal form of the Company was changed from that of a Sino-foreign equity joint venture to a Sino-foreign joint stock limited company on 26 June 2001.

The Company and its subsidiaries (collectively referred to as the "Group") are principally engaged in the production and sale of condensed juice.

### Significant accounting policies

These financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRSs") promulgated by the International Accounting Standards Board ("IASB"). IFRSs include all applicable individual International Financial Reporting Standards, International Accounting Standards ("IASs") and related interpretations. These financial statements also comply with the disclosure requirements of the Hong Kong Companies Ordinance and the applicable disclosure provisions of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited. A summary of the significant accounting policies adopted by the Group is set out below.

The IASB has issued certain new and revised IFRSs that are first effective or available for early adoption for the current accounting period of the Group and the Company. Note 3 provides information on any changes in accounting policies resulting from initial application of these developments to the extent that they are relevant to the Group for the current and prior accounting periods reflected in these financial statements.

### Basis of preparation of the financial (a) statements

The consolidated financial statements as at and for the year ended 31 December 2010 comprise the Company, its subsidiaries and the Group's interests in jointly controlled entities and associates.

The financial statements are prepared on the historical cost basis, except where stated otherwise in the accounting policies set out below.

The preparation of the financial statements in accordance with IFRSs requires management to make judgments, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenses. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgments about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

Judgments made by management in the application of IFRSs that have significant effect on the financial statements and estimates with a significant risk of material adjustment in the next year are disclosed in Note 40.

Control exists when the Group has the power to govern the financial and operating policies of an entity so as to obtain benefits from its activities. The financial statements of subsidiaries are included in the consolidated financial statements from the date that control commences until the date that control ceases.

Minority interests represent the portion of the net assets of subsidiaries attributable to interests that are not owned by the Company, whether directly or indirectly through subsidiaries, and in respect of which the Group has not agreed any additional terms with the holders of those interests which would result in the Group as a whole having a contractual obligation in respect of those interests that meets the definition of a financial liability. Minority interests are presented in the consolidated statement of financial position within equity, separately from equity attributable to the equity shareholders of the Company. Minority interests in the results of the Group are presented on the face of the consolidated statement of comprehensive income as an allocation of the total profit or loss for the year between minority interests and the equity shareholders of the Company.

Investments in subsidiaries, jointly controlled entities and associates in the Company's statement of financial position are stated at cost less impairment losses (Note 2 (j)).

Profits or losses on disposal of investments in subsidiaries, jointly controlled entities and associates are determined as the difference between the net disposal proceeds and the carrying amount of the investments and are accounted for in profit or loss as they arise.

On disposal of a cash-generating unit during the year, any attributable amount of purchased goodwill is included in the calculation of the profit or loss on disposal.

#### (f) Lease prepayments

Lease prepayments represent payments made to acquire land use rights. Land use rights are carried at cost less accumulated amortisation and impairment losses (Note 2(j)). Amortisation is charged to profit or loss on a straight-line basis over the respective periods of the land use rights.

Deferred tax is provided using the balance sheet liability method, providing for temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the amounts used for taxation purposes. No segment information is presented during the year as the Group is principally engaged in one operating segment which is the manufacture and sale of condensed juice and related products. The Group operates in the PRC and its major assets are located in the PRC.

The Group's customer base is diversified and includes two customers with whom transactions have exceeded 10% of the Group's revenues. In 2010 revenues from sales of condensed juice to these customers amounted to approximately RMB264 million (2009: Nil). The revenue from each of the two customers is RMB134 million and RMB130 million respectively. Details of concentrations of credit risk arising from these customers are set out in note 36(a).

As stipulated by the regulations of the PRC, the Group participates in various defined contribution retirement plans organised by municipal governments for its staff. The Group is required to make contributions to the retirement plans at 20% (2009: 20%) of the salaries, bonuses and certain allowances of its staff of last year. A member of the plan is entitled to a pension, to be paid by the municipal governments, equal to a fixed proportion of the salary prevailing at his retirement date. The Group has no other material obligation for the payment of pension benefits associated with these plans beyond the annual contributions described above.

Baishui Andre Juice Co., Ltd. and Xianyang Andre Juice Co., Ltd. can continue to enjoy a preferential tax rate of 15% till the end of 2010. For those enterprises whose preferential tax treatment had not commenced due to lack of taxable profit, such preferential tax treatment would have commenced from 1 January 2008.

The Group's cash-generating unit ("CGU") to which the goodwill is allocated is Yantai Longkou Andre Juice Co., Ltd.

The recoverable amount of the CGU is determined based on value-in-use calculations. These calculations use cash flow projections based on actual operating results and financial forecasts less than five years. Cash flows beyond the period covered by the financial forecasts are kept constant which management determined to be no higher than the long-term growth rate of the industry. A pre-tax discount rate of 3.98 per cent has been used in discounting the projected cash flows.

Consistent with industry practice, the Group monitors its capital structure on the basis of a gearing ratio, as defined by the Group, being the total liabilities divided by the total assets. At 31 December 2010, the gearing ratio of the Group was 48% (2009: 49%).

At 31 December 2010, the Group's financial assets included cash and cash equivalents, restricted deposits, trade receivables and other receivables. At the same date, the Group's financial liabilities included bank borrowings, trade and bills payable, other payables and accrued expenses, and dividends payable. The Group did not hold nor has it issued financial instruments for trading purposes as at 31 December 2010.

Exposure to credit, liquidity, interest rate and currency risks arises in the normal course of the Group's business. The Group's exposure to these risks and the financial risk management policies and practices used by the Group to manage these risks are described below.

#### (a) Credit risk

The Group's credit risk is primarily attributable to trade receivables. Management has a credit policy in place and the exposures to these credit risks are monitored on an ongoing basis.

In respect of trade receivables, individual credit evaluations are performed on all customers requiring credit over a certain amount. These evaluations focus on the customers' past history of making payments when due and current ability to pay, and take into account information specific to the customers as well as pertaining to the economic environment in which the customers operates. Trade receivables are due within one to six months from the date of billing. Debtors with balances past due are requested to settle all outstanding balances before any further credit is granted.

The Group's exposure to credit risk is influenced mainly by the individual characteristics of each customer rather than the industry or country in which the customers operate and therefore significant concentrations of credit risk primarily arise when the Group has significant exposure to individual customers. As at 31 December 2010, 42% (2009: 26%) and 54% (2009: 55%) of the total trade receivables was due from the Group's largest two customers and the five largest customers respectively.

The maximum exposure to credit risk is represented by the carrying amount of trade receivables in the consolidated statement of financial position.

Further quantitative disclosures in respect of the Group's exposure to credit risk arising from trade receivables are set out in Note 25.

### Liquidity risk

Individual operating entities within the Group are responsible for their own cash management, including the raising of borrowings to cover expected cash demands, subject to approval by the Company's board of directors when the borrowings exceed certain predetermined levels of authority. The Group's policy is to regularly monitor its liquidity requirements and its compliance with lending covenants, to ensure that it maintains sufficient reserves of cash and adequate committed lines of funding from major financial institutions to meet its liquidity requirements in the short and longer term.

RMB is not freely convertible into foreign currencies. All foreign exchange transactions involving RMB must take place through PBOC or other institutions authorised to buy and sell foreign exchange. The exchange rate adopted for the foreign exchange transactions are the rates of exchange quoted by the PBOC that would be subject to a managed float against an unspecified basket of currencies.

The Group is exposed to currency risk primarily through borrowings and sales which give rise to bank borrowings, trade receivables and cash balances that are denominated in a foreign currency, i.e. a currency other than the functional currency of the operations to which the transactions relate. ## Accounting estimates and judgements

The Group's financial condition and results of operations are sensitive to accounting methods, assumptions and estimates that underlie the preparation of the financial statements. Management bases the assumptions and estimates on historical experience and on various other assumptions that it believes to be reasonable and which form the basis for making judgements about matters that are not readily apparent from other sources. On an ongoing basis, management evaluates its estimates. Actual results may differ from those estimates as facts, circumstances and conditions change.

The selection of critical accounting policies, the judgements and other uncertainties affecting application of those policies and the sensitivity of reported results to changes in conditions and assumptions are factors to be considered when reviewing the financial statements. Management believes the following critical accounting policies involve the most significant judgements and estimates used in the preparation of the financial statements.

#### (a) Depreciation

Property, plant and equipment are depreciated on a straight-line basis over the estimated useful lives of the assets, after taking into account the estimated residual value. Management reviews the estimated useful lives of the assets regularly in order to determine the amount of depreciation expense to be recorded during any reporting period. The useful lives are based on the Group's historical experience with similar assets and take into account anticipated technological changes. The depreciation expense for future periods is adjusted if there are significant changes from previous estimates.

#### Impairment for bad and doubtful debts (b)

The Group estimated impairment losses for bad and doubtful debts resulting from the inability of the customers to make the required payments. The Group bases the estimates on the ageing of the accounts receivable balance, customer credit-worthiness, and historical write-off experience. If the financial condition of the customers were to deteriorate, actual writeoffs would be higher than estimated.

#### Income taxes (c)

The Group is subject to income taxes in various jurisdictions. Significant judgment is required in determining the provision for income taxes. There are transactions during the ordinary course of business, for which calculation of the ultimate tax determination is uncertain during the ordinary course of business. Where the final tax outcome is different from the amounts that were initially recorded, such differences will impact the income tax and deferred tax provisions in the year in which such determination is made.

Recognition of deferred tax assets, which principally related to tax losses, depends on the management's expectation of future taxable profit that will be available against which the tax losses can be utilized. The outcome of their actual utilization may be different.

#### (d) Write-down of inventories

If the costs of inventories fall below their net realisable values, a write-down loss of inventories is recognised. Net realisable value represents the estimated selling price in the ordinary course of business, less the estimated costs of completion and the estimated costs necessary to make the sales. The Group based the estimates on all available information, including the current market prices of the finished goods and raw materials, and historical operating costs. If the actual selling prices were to be lower or the costs of completion and other distribution costs were to be higher than estimated, the actual write-down loss of inventories could be higher than estimated.

#### (e) Impairment for non-current assets

If circumstances indicate that the net book value of a non-current asset may not be recoverable, the asset may be considered "impaired", and an impairment loss may be recognised in accordance with IAS 36 "Impairment of Assets". The carrying amounts of non-current assets are reviewed periodically in order to assess whether the recoverable amounts have declined below the carrying amounts. These assets are tested for impairment whenever events or changes in circumstances indicate that their recorded carrying amounts may not be recoverable. When such a decline has occurred, the carrying amount is reduced to recoverable amount. The recoverable amount is the greater of the net selling price and the value in use. It is difficult to precisely estimate selling price because quoted market prices for the Group's assets are not readily available. In determining the value in use, expected cash flows generated by the asset are discounted to their present value, which requires significant judgement relating to level of sales volume, selling price and amount of operating costs. The Group uses all readily available information in determining an amount that is a reasonable approximation of recoverable amount, including estimates based on reasonable and supportable assumptions and projections of sale volume, selling price and amount of operating costs.
