Completion and return of the form of proxy will not preclude a member of the Company from attending the Annual General Meeting in Munich, Germany and vote in person, or viewing the Annual General Meeting at the Hong Kong venue and vote in person. In such event, his form of proxy will be deemed to have been revoked.
- 10. In the case of joint holders of a share, the joint holders can only vote through a joint representative who has been granted a proxy by the joint holders or whose authority to represent the joint holders is based on legal statutes. The proxy can either be one of the joint holders or a third party.
- 11. Any vote in respect of the resolutions to be put forward for consideration at the Annual General Meeting will be taken by poll.
- 12. The proxy need not be a member of the Company but must attend the Annual General Meeting in person to represent you. The Annual General Meeting is expected to last for half a day. Shareholders or persons attending the Annual General Meeting to be held in Munich, Germany shall be responsible for their own travel and accommodation expenses.
