UPDATE OF NUMBER OF RELEVANT SECURITIES

This announcement is made pursuant to Rule 3.8 of the Hong Kong Takeovers Code.

Reference is made to the joint announcement issued by the Offeror and Alibaba.com Limited (the “**Company**”) regarding the Proposal dated February 21, 2012 (the “**Joint Announcement**”). Unless the context otherwise requires, capitalized terms used in this announcement shall have the same meanings as defined in the Joint Announcement.

The Board announces that on March 5, 2012, the Company has issued a total of 21,000 Shares to certain holders of Outstanding Share Options pursuant to the exercise of Outstanding Share Options under the Share Option Scheme, with an exercise price of HK\$5.54 per Share.

In addition, on March 5, 2012, a total of 10,000 Outstanding Share Options have lapsed and a total of 119,865 RSUs have been cancelled following the termination of employment of the holders of these options and RSUs respectively.

As a result, the total number of Shares in issue has increased from 5,004,243,002 Shares as at March 2, 2012 to 5,004,264,002 Shares as at the date of this announcement, the number of Outstanding Share Options under the Share Option Scheme was reduced from 28,188,808 as at March 2, 2012 to 28,157,808 as at the date of this announcement, and the number of RSUs under the RSU Scheme was reduced from 41,838,179 as at February 29, 2012 to 41,718,314 as at the date of this announcement.

In accordance with Rule 3.8 of the Hong Kong Takeovers Code, associates of the Company or the Offeror (including persons holding 5% or more of a class of relevant securities of the Company or the Offeror) are reminded to disclose their dealings in the securities of the Company pursuant to the Hong Kong Takeovers Code.
