BY WAY OF A SCHEME OF ARRANGEMENT**

UPDATE OF NUMBER OF RELEVANT SECURITIES

This announcement is made pursuant to Rule 3.8 of the Hong Kong Takeovers Code.

Reference is made to the joint announcement issued by the Offeror and Alibaba.com Limited (the “**Company**”) regarding the Proposal dated February 21, 2012 (the “**Joint Announcement**”). Unless the context otherwise requires, capitalized terms used in this announcement shall have the same meanings as defined in the Joint Announcement.

The Board announces that on March 12, 2012, the Company has issued a total of 50,000 Shares to certain holders of Outstanding Share Options pursuant to the exercise of Outstanding Share Options under the Share Option Scheme, with an exercise price ranging from HK\$5.54 to HK\$12.74 per Share.

In addition, on March 12, 2012, a total of 14,000 Outstanding Share Options have lapsed and a total of 160,725 RSUs have been cancelled following termination of employment of the holders of these options and RSUs respectively.

As a result, the total number of Shares in issue has increased from 5,004,365,910 Shares as at March 9, 2012 to 5,004,415,910 Shares as at the date of this announcement, the number of Outstanding Share Options under the Share Option Scheme was reduced from 28,050,900 as at March 9, 2012 to 27,986,900 as at the date of this announcement, and the number of RSUs (including RSUs which have vested but in respect of which Shares have not been issued as of the date of this announcement) under the RSU Scheme was reduced from 41,708,489 as at March 9, 2012 to 41,547,764 as at the date of this announcement.

In accordance with Rule 3.8 of the Hong Kong Takeovers Code, associates of the Company or the Offeror (including persons holding 5% or more of a class of relevant securities of the Company or the Offeror) are reminded to disclose their dealings in the securities of the Company pursuant to the Hong Kong Takeovers Code.
