  - have been allocated or have applied for any International Offer Shares under the International Offering or otherwise participate in the International Offering.

##### B. If you are a nominee

- If you are a nominee, you may both give **electronic application instructions** to HKSCC via CCASS (if you are a CCASS Participant) and lodge more than one Application Form in your own name if each application is made on behalf of different beneficial owners. ##### D. Allocation of Hong Kong Offer Shares — Pools A and B

There will initially be a total of 31,220,000 Hong Kong Offer Shares to be offered for subscription by members of the public under the Hong Kong Public Offering, representing approximately 10% of the total number of Offer Shares being offered under the Global Offering. The total number of the Hong Kong Offer Shares will be divided equally into two pools for allocation purposes: pool A and pool B. For the purpose of this paragraph only, the "price" for Hong Kong Offer Shares means the price payable on application therefor (without regard to the Offer Price as finally determined). You should be aware that the allocation ratios for applications in pool A and applications in pool B may be different. If the Hong Kong Offer Shares in one (but not both) of the pools are under-subscribed, the unsubscribed Hong Kong Offer Shares will be transferred to the other pool to satisfy demand in that other pool and be allocated accordingly. The Company expects to release and announce the Offer Price and to release the level of indications of interest in the International Offering, the level of applications in the Hong Kong Public Offering and basis of allotment under the Hong Kong Public Offering on Tuesday, May 29, 2012 in the South China Morning Post (in English), the Hong Kong Economic Times (in Chinese), on the website of the Company ([www.ydauto.com.cn](http://www.ydauto.com.cn)) and on the website of the Hong Kong Stock Exchange at [www.hkexnews.hk](http://www.hkexnews.hk). Results of allocations of the Hong Kong Public Offering, and the Hong Kong Identity Card/passport/Hong Kong Business Registration numbers of successful applicants (where appropriate) will be made available through various channels as described in the section headed "How to Apply for Hong Kong Offer Shares — Publication of Results" in the Prospectus on Tuesday, May 29, 2012.
