**UPDATE OF NUMBER OF RELEVANT SECURITIES**

Reference is made to the joint announcement issued by the Offeror and Alibaba.com Limited (the “**Company**”) regarding the Proposal dated February 21, 2012 (the “**Joint Announcement**”). Unless the context otherwise requires, capitalized terms used in this announcement shall have the same meanings as defined in the Joint Announcement.

The Board announces that on May 22, 2012, the Company has issued a total of 16,250 Shares to certain holders of Outstanding Share Options pursuant to the exercise of Outstanding Share Options under the Share Option Scheme, with an exercise price ranging from HK\$5.71 to HK\$7.25 per Share.

As a result, the total number of Shares in issue has increased from 5,005,814,170 Shares as at May 21, 2012 to 5,005,830,420 Shares as at the date of this announcement, and the number of Outstanding Share Options under the Share Option Scheme was reduced from 26,624,100 as at May 21, 2012 to 26,607,850 as at the date of this announcement.

In accordance with Rule 3.8 of the Hong Kong Takeovers Code, associates of the Company or the Offeror (including persons holding 5% or more of a class of relevant securities of the Company or the Offeror) are reminded to disclose their dealings in the securities of the Company pursuant to the Hong Kong Takeovers Code.
