

- (ii) up to one-third of the Shares that are subject to the Option (the "Second Option Shares"), together with the First Option Shares, so granted to him/her (rounded down to the nearest whole number), less the number of Shares in respect of which the Option has been exercised during the First Period with respect to the First Option Shares, at any time during the period commencing from 5 July 2014 and ending on 4 July 2015 (the "Second Period"); and
- (iii) up to one-third of the Shares that are subject to the Option, together with the First Option Shares and the Second Option Shares, so granted to him/her (rounded down to the nearest whole number), less the number of Shares in respect of which the Option has been exercised during the First Period and the Second Period with respect to the First Option Shares or the Second Option Shares, as the case may be, at any time during the period commencing from 4 July 2015 and ending on the expiration of the Option Period.

No Option will be exercisable after the expiry of its term.
