## PERSONAL DATA

### Personal Information Collection Statement

The main provisions of the Personal Data (Privacy) Ordinance (Chapter 486 of the Laws of Hong Kong) (the "Ordinance") came into effect in Hong Kong on 20 December 1996. This Personal Information Collection Statement informs the applicant for and holder of the Hong Kong Public Offer Shares of the policies and practices of the Company and Tricor Investor Services Limited (the "Hong Kong Branch Share Registrar") in relation to personal data and the Ordinance.

#### 1 Reasons for the collection of your personal data

From time to time it is necessary for applicants for Hong Kong Public Offer Shares or registered holders of Shares to supply their latest correct personal data to the Company and the Hong Kong Branch Share Registrar when applying for securities or transferring securities into or out of their names or in procuring the services of the Hong Kong Branch Share Registrar.

Failure to supply the requested data may result in your application for Hong Kong Public Offer Shares being rejected or delay or the inability of the Company and the Hong Kong Branch Share Registrar to effect transfers or otherwise render their services. It may also prevent or delay registration or transfer of Hong Kong Public Offer Shares which you have successfully applied for and/or the despatch of share certificate(s) and/or e-Auto Refund payment instructions and/or the despatch or encashment of refund cheque(s) (if any) to which you are entitled.

It is important that holders of Shares inform the Company and the Hong Kong Branch Share Registrar immediately of any inaccuracies in the personal data supplied.

#### 2 Purposes

The personal data of the holders of Shares may be used, held and/or stored (by whatever means) for the following purposes:

- making disclosures as required by laws, rules or regulations (whether statutory or otherwise), the Stock Exchange, the SFC and any other statutory or governmental bodies;
- disclosing identities of successful applicants by way of announcement(s) or otherwise;
- disclosing relevant information to facilitate claims on entitlements; and
- any other incidental or associated purposes relating to the above and/or to enable the Company and the Hong Kong Branch Share Registrar to discharge their obligations to holders of Shares and/or regulators and any other purpose to which the holders of securities may from time to time agree.

#### 3 Transfer of personal data
