The Company's share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, acted as scrutineer for the poll at the AGM.

## 2. PAYMENT OF DIVIDEND

In respect of the distribution of the final dividend of RMB0.0461 per share with par value of US\$0.0025 each for the year ended 31 December 2012 to all shareholders of the Company whose names appeared on the register of members of the Company as at the close of business on 4 June 2013, the board of directors of the Company hereby announces that:-

- a. for the payment of dividend in HK\$, the average mid exchange rate of RMB to HK\$ as quoted by the People's Bank of China for the five business days prior to the date of the AGM (which was HK\$100: RMB79.7028) was adopted by the board of directors of the Company. Accordingly, the final dividend for each share with par value of US\$0.0025 would be HK\$0.0578; and
- b. the payment date will be 26 July 2013.
