1. INTRODUCTION

At a meeting of the Board held on 25 June 2013, the Directors announced the audited consolidated results of the Group for the year ended 31 March 2013. The purpose of this circular is to provide the Shareholders with details relating to the resolutions to be proposed at the Annual General Meeting to be held on Friday, 27 September 2013 for granting to the Directors the general mandates to issue Shares and to repurchase Shares and re-election of retiring Director.

2. PROPOSED GRANTING OF GENERAL MANDATES TO ISSUE AND REPURCHASE SHARES

At the Annual General Meeting, separate ordinary resolutions will be proposed to renew the general mandates given to the Directors (i) to allot, issue or deal with additional Shares not exceeding 20% of the aggregate nominal amount of the issued share capital of the Company as at the date of the passing of such resolution and Shares representing the aggregate nominal amount (up to a maximum of 10% of the aggregate nominal amount of the Company's then issued share capital as at the date of passing of such resolution) of any Shares repurchased by the Company subsequent to the passing of such resolution ("Issuance Mandate"); and (ii) to repurchase Shares comprising the aggregate nominal amount of which does not exceed 10% of the aggregate nominal amount of the issued share capital of the Company as at the date of passing of such resolution ("Repurchase Mandate").

Accordingly, on the basis of 2,400,001,640 Shares in issue as at 8 July 2013, being the Latest Practicable Date prior to the printing of this circular, and assuming that no Shares will be issued or repurchased prior to the Annual General Meeting, (i) exercise in full of the 20% Issuance Mandate will result in up to 480,000,328 Shares being issued by the Company during the Relevant Period (as defined in the Resolution); and (ii) exercise in full of the 10% Repurchase Mandate will result in up to 240,000,164 Shares being repurchased by the Company during the Relevant Period (as defined in the Resolution).

An explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the granting of the Repurchase Mandate is set out in Appendix I of this circular.

3. PROPOSED RE-ELECTION OF RETIRING DIRECTOR

Pursuant to the Bye-law 110A of the Bye-laws, Miss Wing Yan AU will retire and, being eligible, will offer herself for re-election at the Annual General Meeting.

Separate resolution will be put forward at the Annual General Meeting for the re-election of Miss Wing Yan AU as Director. Information of the retiring Director as required to be disclosed under the Listing Rules is set out in Appendix II of this circular.

4. ANNUAL GENERAL MEETING AND PROXY ARRANGEMENT

A notice of the Annual General Meeting is set out on pages 8 to 10 of this circular. At the Annual General Meeting, in addition to the ordinary business of the meeting, Resolutions Nos. 4 and 5 will be proposed to approve the general mandates for the issue of Shares and repurchase of Shares.

A copy of the 2012/2013 Annual Report of the Company incorporating copies of the Audited Accounts of the Group for the year ended 31 March 2013 and the Directors' and Auditors' Reports therein has been despatched to all the Shareholders together with this circular.

5. RECOMMENDATION

The Board is of the opinion that the proposals referred to above in relation to the granting of Issuance Mandate and Repurchase Mandate and the re-election of retiring Director are in the best interests of the Company and its Shareholders as a whole and therefore recommend you to vote in favour of the relevant resolutions to be proposed at the Annual General Meeting.

The following is an explanatory statement required by the Listing Rules to provide the Shareholders with requisite information reasonably necessary for them to make an informed decision on whether to vote for or against the ordinary resolution to be proposed at the Annual General Meeting in relation to the granting of the Repurchase Mandate:

1. SHARE CAPITAL

As at the Latest Practicable Date, the issued share capital of the Company comprised 2,400,001,640 Shares of HK\$0.10 each.

Subject to the passing of the ordinary resolution in relation to the granting of the Repurchase Mandate and on the basis that no Shares are issued or repurchased by the Company since the Latest Practicable Date and up to the Annual General Meeting, the Company will be allowed under the Repurchase Mandate to repurchase a maximum of 240,000,164 Shares, representing 10% of the aggregate nominal amount of Shares in issue of HK\$0.10 each.

2. REASONS FOR SHARE REPURCHASE

The Directors believe that the granting of the Repurchase Mandate is in the best interests of the Company and the Shareholders.

Repurchases of Shares will only be made when the Directors believe that such a repurchase will benefit the Company and its Shareholders. Such repurchases may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the net asset value per Share of the Company and/or its earnings per Share.

3. FUNDING OF REPURCHASE

In repurchasing Shares, the Company may only apply funds legally available for such purpose in accordance with its memorandum of association and Bye-laws, the laws of Bermuda and/or any other applicable laws.

4. IMPACT OF REPURCHASE

There might be a material adverse impact on the working capital or gearing position of the Company (as compared with the position disclosed in the Audited Accounts for the year ended 31 March 2013 contained in the annual report of the Company) in the event that the Repurchase Mandate was to be carried out in full at any time during the proposed repurchase period. However, the Directors do not intend to exercise the Repurchase Mandate to such extent as would, in the circumstances, have a material adverse effect on the working capital requirements of the Group or the gearing levels which in the opinion of the Directors are from time to time appropriate for the Group.

5. GENERAL

To the best of their knowledge and having made all reasonable enquiries, none of the Directors nor any of their respective associates (as defined in the Listing Rules) have any present intention to sell any Shares to the Company in the event that the granting of the Repurchase Mandate is approved by the Shareholders.

The Directors have undertaken to the Stock Exchange to exercise the power of the Company to make repurchase of Shares pursuant to the Repurchase Mandate in accordance with the Listing Rules, its memorandum of association and Bye-laws and the applicable laws of Bermuda.

The Company has not been notified by any connected persons (as defined in the Listing Rules) of the Company that they have a present intention to sell any Shares to the Company, or that they have undertaken not to sell any Shares held by them to the Company in the event that the granting of the Repurchase Mandate is approved by the Shareholders.

6. TAKEOVERS CODE

If as a result of a repurchase of Shares pursuant to the Repurchase Mandate, a Shareholder's proportionate interest in the voting rights of the Company increases, such increase will be treated as an acquisition of voting rights for the purposes of the Takeovers Code. Accordingly, a Shareholder or a group of Shareholders acting in concert (within the meaning under the Takeovers Code), depending on the level of increase in the Shareholders' interest, could obtain or consolidate control of the Company and thereby become obliged to make a mandatory offer in accordance with Rule 26 of the Takeovers Code.

To the best knowledge of the Company, as at the Latest Practicable Date, Coralbells Investments Limited, the substantial shareholder of the Company (as defined in the Listing Rules), was interested in 1,795,000,000 Shares representing approximately 74.79% of the total issued share capital of the Company. In the event that the Directors exercise the proposed Repurchase Mandate in full, the shareholding of Coralbells Investments Limited would be increased to approximately 83.1% of the issued share capital of the Company.

The Directors are not aware of any consequences which may give rise to an obligation to make a mandatory offer under Rule 26 of the Takeovers Code. The Directors do not propose to exercise the Repurchase Mandate to such an extent as would, in the circumstances, give rise to an obligation to make a mandatory offer in accordance with Rule 26 of the Takeovers Code and/or result in the aggregate number of shares held by the public shareholders falling below the prescribed minimum percentage required by the Stock Exchange.

7. SHARE REPURCHASE MADE BY THE COMPANY

No repurchases of Shares have been made by the Company during the six months prior to the Latest Practicable Date, whether on the Stock Exchange or otherwise.

The Shares in the Company have been suspended from trading since 5 July 2010.

Miss Wing Yan AU, aged 38, was appointed as the executive Director and also as the authorised representative of the Company in June 2003. Miss AU was appointed as director of Coralbells Investments Limited, the substantial shareholder of the Company, in September 2006. She is also a director of various subsidiaries of the Company. Miss AU is responsible for the treasury functions and strategic planning of the Group. Miss AU joined the Company in June 2000. Miss AU has extensive experience in financial management, having worked in major brokerage houses in Hong Kong as an investment advisor. Miss AU received her Master of Business (Electronic Commerce) from Curtin University of Technology and BA in Business and Commercial Studies from the University of Western Ontario, Canada.

Miss AU does not have any relationship with any other Directors, senior management, substantial shareholders or controlling shareholders of the Company as defined in the Listing Rules.
