If the Offer Price is not agreed between the Company, and the Sole Global Coordinator (on behalf of the underwriters) on or before Monday, November 4, 2013, the Global Offering will not proceed.

Applications for Hong Kong Public Offer Shares will not be processed and no allotment of any Hong Kong Public Offer Shares will be made until the application lists close.
