Chairman's statement 主席報告

Dear Shareholders,

On behalf of the Board of Directors (the "Board"), I am pleased to present the annual results of Dragon Crown Group Holdings Limited (the "Group" or "Dragon Crown") for the year ended 31 December 2013.

OVERCOMES CHALLENGES THROUGH OUTSTANDING RESULTS

During the year, the global economy continued to experience a modest recovery. A slight improvement in consumer confidence and employment figures were recorded in the US, and was followed by a corresponding though marginal pickup in the eurozone. Economic growth in China has slightly slowed down, although there is still quite an encouraging GDP growth. China's chemical industry continued to exhibit growth. We were able to leverage our leading position as a liquid chemical storage and integrated terminal service provider to sustain our long-term strategic business relationships with world-class chemical enterprises, such as Celanese Corporation. This meant a guaranteed minimum income for our business; sufficient in itself for achieving promising financial results.

Dragon Crown recorded satisfactory results, with revenue rising by 4.8% to HK\$270.0 million (2012: HK\$257.8 million) and net profit up 3.8% to HK\$118.3 million (2012: HK\$113.9 million) in 2013. The sterling results highlight our ability to perform resiliently and meet the growing demand for our services. A visionary management team can also be credited with the Group's continuous success; employing unique approaches to enhance our existing business model and ensuring sustainable and foreseeable earnings. Given that the liquid chemicals handled by the Group are applicable to the production of various daily consumer products on the market; demand will grow from players in the plastics, paints, textiles and solvents industries.

It is worth noting as well that Phase III of our facility at the Nanjing terminal has commenced operation and is expected to have a full impact on the Group's revenue in 2014. The construction of our second cryogenic ethylene tank has begun, thus far achieving good progress. We believe that expanding storage capacity will enable us to grasp further opportunities available within China's liquid chemical industry.

致列位股東:

本人謹代表董事會(「董事會」) 欣然呈報龍翔集團控股有限公司(「本集團」或「龍翔」) 截至2013年12月31日止年度之年度業績。

克服挑戰贏得驕人業績

於本年度,全球經濟繼續緩慢復甦。美國 消費者信心及就業指數錄得輕微改善,隨 後歐元區經濟亦有所改善。儘管中國經濟 的增長輕微放緩,但國內生產總值的增長 仍十分理想。中國化工行業持續發展。作 為液體化學品儲存及綜合碼頭服務的供應 商,我們利用自身的領先地位來維持與世 界級化工企業(如塞拉尼斯)的長期戰略 務關係,從而保證了業務收入,並實現理 想財務業績。

龍翔取得滿意業績,收入於2013年增長4.8%至2.7億港元(2012年:2.578億港元),及淨溢利上升3.8%至1.183億港元(2012年:1.139億港元)。出色的業績凸顯我們有能力靈活應對並滿足對本集團服務不斷增長的需求。本集團的持續成功有式提升現有業務模式,確保可持續及可預見的盈利。鑒於本集團處理的液體化學品適用於生產市場上各類日常消費品,因此來自塑料、塗料、紡織品及工業溶劑行業廠商的需求將增加。

值得一提的是,南京碼頭第三期設施已開始營運,並預計將為本集團2014年全面貢獻收入。我們已開始建造第二個低溫乙烯儲罐,迄今為止已取得良好進展。我們相信擴展儲存容量將能讓我們進一步把握中國液體化工行業的機遇。

During the year, we paid close attention to our cash flow and maintained a healthy financial position characterized by sound liquidity. As a result, we have sufficient capital to support the sustained growth of the Group.

DIVIDENDS

In recognition of the support of our shareholders, an interim dividend of HK2.0 cents (2012: nil) per share was declared and paid during the year. In addition, the Board has proposed a final dividend of HK3.8 cents (2012: HK5.5 cents) per ordinary share. The total dividends per share in 2013 increased to HK5.8 cents, which represent 61.8% of the profit attributable to shareholders for the year. This is consistent with the Group's dividend payout policy.

SAFETY

Employee safety has been our top priority for many years. We provide regular training to all of our staff members, as well as develop and implement HSE (Health, Safety and Environment) policies in accordance with national and industry standards. Due to our careful attention to safety, we did not experience any material incidents in 2013. We intend to seek further improvements in this area, with the ultimate goal of providing safe and quality services to our customers.

PROMISING OUTLOOK TO SUPPORT THE RAPIDLY EXPANDING MARKET

Despite the challenging economic environment, we remain positive and confident about the prospects for the liquid chemical industry. With support from an expanding consumer market for basic chemical materials and chemical products in China, we believe that demand for our services will continue to grow.

Furthermore, with our world-class expertise and excellent facilities and services, we have built a strong reputation and earned the trust of our customers, which include renowned large-scale multinational chemical enterprises. Capitalizing on the global trend for outsourcing logistics arrangements, we see the opportunity to introduce new cost-effective solutions that enable our customers to reduce costs, increase business flexibility and enhance logistic efficiency.

於本年度,本集團密切關注現金流,確保 流動資金充裕以保持穩健財務狀況。因 此,本集團擁有足夠的資本支持本集團的 可持續發展。

股息

為感謝股東作出的支持,我們於本年度宣派及派付中期股息每股2.0港仙(2012年:零)。此外,董事會建議宣派末期股息每股普通股3.8港仙(2012年:5.5港仙),2013年每股股息總額增加至每股5.8港仙,佔本年度股東應佔溢利的61.8%,與本集團股息派發政策一致。

安全

本集團多年來一向將員工安全置於首位。 本集團向所有員工提供定期培訓,並根據 國家及行業標準制定及執行健康、安全及 環保的政策。由於我們高度重視安全,本 集團於2013年並未於經營過程中遭遇任何 重大事故。本集團將進一步致力於改善及 貫徹向客戶提供安全及優質服務的宗旨。

前景亮麗推動行業發展

儘管經濟環境充滿挑戰,我們對液體化工 行業的前景仍樂觀及有信心。受惠於中國 基礎化學材料及化學品消費市場的擴張, 我們相信對本集團服務的需求將繼續攀升。

此外,憑藉我們世界級水平的專業知識、 高標準的設施及服務,本集團建立了良好 的聲譽並贏得包括知名大型跨國化工企業 在內的客戶的信任。隨着外包物流業務成 為全球趨勢,本集團緊握商機,引入有成 本效益的解決方案,使客戶降低成本、增 加業務靈活性及提升物流效率。

The commencement of Phrase III terminal operations in Nanjing is another positive development, leading to additional profit contributions to the Group as expected. We have secured long-term terminal service contracts for over 63% storage capacity of our new tanks with customers and believe that the new tanks will continue reinforcing the Group's influence in Nanjing. Construction of the second cryogenic ethylene tank, which will commence operation in third quarter of 2014, will help Dragon Crown to further capture rapid demand for liquid chemical terminal services from current and potential customers in China.

Mr. NG, Wai Man, aged 57, is an executive Director and the chairman of the Company. Mr. NG is the founder of our Group and is principally responsible for operation of our Board and is the key decision-maker of our Group. He is responsible for formulating the overall business strategic development for our Group. Mr. NG has accumulated around 25 years of management and operation experience in the terminal and storage of liquid chemical products industry. Mr. NG is the founder of Dragon Source Industrial Limited and its invested entity, Ningbo Haixiang Liquid Chemical Store Co., Ltd. (the predecessor of Ningbo Xinxiang Liquid Chemical Store Co., Ltd. ("Ningbo Xinxiang")), and has managed its operation since 1988. Mr. NG was the president and legal representative of Nanjing Dragon Crown Liquid Chemicals Terminal Co., Ltd from April 2004 to 2007 responsible for overseeing strategic development and management of resources. From December 1993 to September 2004, Mr. NG was a director of Ningbo Huaxiang Inspection Co., Ltd, a company which provides inspection, certification and testing services. He served as the chairman and general manager from October 1997 to October 2006 and legal representative from October 1997 to October 2007 for Ningbo Free Trade Zone Dragon Crown Chemical International Trade Company Ltd., a trading company, responsible for strategic business management. Mr. NG was appointed as our Director on 16 July 2010 and was re-designated as our executive Director on 30 November 2010.

Mr. TING Yian Ann, aged 53, is an executive Director and the chief executive officer of the Company. Mr. TING is principally responsible for overall management and strategic development, major decisionmaking and communications with our key customers. Mr. TING joined our Group in 2003. BUSINESS REVIEW

Dragon Crown is one of China's leading integrated service providers that specialises in the handling and storage of liquid chemical products at three terminals in Nanjing, Tianjin and Ningbo. Strategically located in one of the major petrochemical industry clusters in China, the Group has set up jetties and tank farms ("Terminals") along the coastal area to seize the rising demand of the petroleum and chemical industries. Dragon Crown offers a high quality and comprehensive range of liquid chemical terminal and storage services to customers through its own jetties, storage tanks and dedicated pipelines.

During the year ended 31 December 2013, the Group's throughput volume of liquid chemical products handled by Nanjing, Tianjin and Ningbo terminals reached 1,722,100 metric tonnes, 170,000 metric tonnes and 253,500 metric tonnes (2012: 1,717,700 metric tonnes, 67,100 metric tonnes and 329,300 metric tonnes) respectively, with a combined throughput volume amounting to 2,145,600 metric tonnes (2012: 2,114,100 metric tonnes). The following table provides an overview of the existing terminals and facilities as at 31 December 2013:

Situated in the Nanjing Chemical Industry Park, the Group's flagship terminal is the main source of revenue and profit, accounting for 94.3% (2012: 96.6%) of the Group's total profit during the year. The Group's major customer, Celanese Corporation (NYSE: CE), a world leading producer of acetyl products, is also situated in the industrial park and accounted for 86.9% of the Group's total revenue during the year – equivalent to HK\$234.5 million (2012: HK\$227.8 million).

The construction of Nanjing Terminal Phase III has been completed and commenced operation in June 2013, which has helped further expand and achieve a storage capacity of 190,000 m³. Comprising eleven tanks with a total capacity of 38,000 m³, the new facility began generating revenue in June 2013.

The Group started work on the assembly of its second cryogenic ethylene tank during the first quarter of 2013, which will be able to store deep cooled liquids at-104° C. With the smooth progress in the construction to date, the 20,000 m³ tank is scheduled to be operational by the third quarter of 2014, and requires not only specific expertise to construct but also to maintain and operate.

Dragon Crown continues to maintain stable financial health, with total assets of more than HK\$1,229.0 million (2012: HK\$1,042.0 million) and total equity of HK\$1,011.5 million (2012: HK\$958.6 million). The Group is in a strong financial position with cash balance of HK\$320.5 million (2012: HK\$265.7 million) and the gearing ratio has remained at a healthy level of 12.1% (2012: 1.2%).

BUSINESS OUTLOOK

The Group remains positive about the future outlook of the chemical storage and logistics industry continuing to ride on its existing successful business model and enhance its infrastructure to facilitate future growth initiatives. The Group has completed the construction of its Nanjing Terminal Phase III in mid 2013 and is expected to make a full contribution in 2014.

Dragon Crown's main business objective is to enhance its leading position in the coastal regions of China, particularly along the Yangtze River Delta region. As a result, besides strengthening its existing infrastructure, the Group will also explore and nurture new and existing business partnerships and collaboration opportunities.

By relying on the Group's successful management and operational excellence, Dragon Crown will continue to excel as it maintains its leading position as an integrated terminal service provider in China, as well as delivering the best results to its shareholders.

FINANCIAL PERFORMANCE REVIEW

Revenue

For the year ended 31 December 2013, the revenue of the Group increased by 4.8% to HK\$270.0 million from HK\$257.8 million in 2012. The increase was mainly due to the HK\$12.0 million new revenue generated from Nanjing terminal. The remaining was mainly due to the combined effects of the appreciation in Renminbi ("RMB") and the decrease in excess throughput revenue from the major customer.

Gross profit

For the year ended 31 December 2013, gross profit increased by 5.5% from HK\$153.4 million in 2012 to HK\$161.9 million. The gross profit margin slightly increased by 0.5% to 60.0%.

The cost of services provided increased to HK\$108.1 million in 2013 compared with HK\$104.4 million in 2012 which was mainly due to the combined effects of the appreciation in RMB, increase in depreciation and decrease in total cost of diesel fuel.

Other income

Other income decreased to HK\$13.0 million from HK\$22.1 million in 2012. The decrease was mainly due to the decrease in arbitration income from a debtor, and the entire amount has been settled before 31 December 2013.

Administrative expenses

Administrative expenses slightly increased by 0.8% to HK\$34.2 million from HK\$34.0 million in 2012.

Finance costs

Finance costs for the year dropped sharply to HK\$3.3 million from HK\$5.7 million in 2012. The decrease was due to the decrease in bank interest rate during the year.

Share of profits of joint ventures and associates

The business of the joint ventures achieved stable growth during the year.

The business of the associates turned into making profits during the year.

Tax expense

The tax expense for the year decreased slightly to HK\$25.8 million from HK\$26.0 million in 2012. It was mainly due to the decrease in the other income, which was not entitled to preferential tax treatment and was subject to a PRC Enterprise Income Tax rate of 25%. This led to a decrease in the effective tax rate to 17.9% in the year, compared with 18.6% in 2012.

CORPORATE GOVERNANCE PRACTICES

The Group is committed to achieving high standards of corporate governance to safeguard the interests of shareholders and to enhance corporate value and accountability.

The Company has applied the principles as set out in the Corporate Governance Code (the "CG Code") contained in Appendix 14 of the Rules Governing the Listing of Securities on The Stock Exchange Hong Kong Limited (the "Stock Exchange") (the "Listing Rules").

In the opinion of the directors, throughout the year, the Company has complied with all the code provisions as set out in the CG Code.

The Company regularly reviews its corporate governance practices to ensure compliance with the CG Code.

MODEL CODE FOR SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the "Model Code") as set out in Appendix 10 to the Listing Rules.

Specific enquiry has been made of all the directors and the directors have confirmed that they have complied with the Model Code throughout the year ended 31 December 2013.

The Company has also established written guidelines on no less exacting terms than the Model Code (the "Employees Written Guidelines") for securities transactions by employees who are likely to be in possession of inside information of the Company.

No incident of non-compliance of the Employees Written Guidelines by the employees was noted by the Company.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The Company fully supports the division of responsibility between the Chairman of the Board and the Chief Executive Officer to ensure a balance of power and authority. The positions of Chairman and Chief Executive Officer are held by Mr. NG Wai Man and Mr. TING Yian Ann respectively. Their respective responsibilities are clearly defined and set out in writing.

Currently, the Chairman provides leadership and is responsible for the effective functioning of the Board in accordance with good corporate governance practice whereas the Chief Executive Officer focuses on implementing objectives, policies and strategies approved and delegated by the Board.

INDEPENDENT NON-EXECUTIVE DIRECTORS

During the year ended 31 December 2013, the Board at all times met the requirements of the Listing Rules relating to the appointment of at least three independent non-executive directors representing one-third of the Board with at least one of whom possessing appropriate professional qualifications or accounting or related financial management expertise.

The independent non-executive directors bring a wide range of business and financial expertise, experience and independent judgment to the Board. Through active participation at Board meetings, taking the lead in managing issues involving potential conflict of interests, all independent non-executive directors have made various contributions to the effective direction of the Company.

The Company has received written annual confirmation from each independent non-executive director of his independence pursuant to the requirements of the Listing Rules. The Company considers all independent non-executive directors to be independent in accordance with the independence guidelines as set out in the Listing Rules.

NON-EXECUTIVE DIRECTORS, APPOINTMENT AND RE-ELECTION OF DIRECTORS

The procedures and process of appointment, re-election and removal of directors are laid down in the Company's Articles of Association. The Nomination Committee is responsible for reviewing Board composition, monitoring the appointment of directors and assessing the independence of independent non-executive directors.

Code provision A.4.1 of the CG Code stipulates that non-executive directors shall be appointed for a specific term, subject to reelection, whereas code provision A.4.2 states that all directors appointed to fill a casual vacancy shall be subject to election by shareholders at the first general meeting after appointment and that every director, including those appointed for a specific term, shall be subject to retirement by rotation at least once every three years.

Each of the independent non-executive directors of the Company is appointed for a specific term of one year and is subject to retirement by rotation once every three years.

In accordance with the Company's Articles of Association, all directors of the Company are subject to retirement by rotation at least once every three years and any new director appointed to fill a causal vacancy shall submit himself/herself for re-election by shareholders at the first general meeting after appointment.

At the forthcoming annual general meeting of the Company, Mr Ng Wai Man, Mr Ting Yian Ann and Mr Lau Sik Yuen shall retire by rotation and being eligible, offer themselves for re-election pursuant to the Company's Articles of Association.

RESPONSIBILITIES, ACCOUNTABILITIES AND CONTRIBUTIONS OF THE BOARD AND MANAGEMENT

The Board is responsible for leadership and control of the Company and oversees the Group's businesses, strategic decisions and performance. The Board has delegated to the Chief Executive Officer, and through him, to the senior management the authority and responsibility for the day-to-day management and operation of the Group.

All directors have carried out their duties in good faith, in compliance with applicable laws and regulations and in the interests of the Company and its shareholders at all times.

DELEGATION OF MANAGEMENT FUNCTIONS

The Board reserves for its decision all major matters of the Company, including: approval and monitoring of all policy matters, overall strategies and budgets, internal control and risk management systems, material transactions (in particular those that may involve conflict of interests), financial information, appointment of directors and other significant financial and operational matters.

All directors have full and timely access to all relevant information as well as the advice and services of the Company Secretary, with a view to ensuring that Board procedures and all applicable laws and regulations are followed. Each director is normally able to seek independent professional advice in appropriate circumstances at the Company's expense, upon making request to the Board.

The day-to-day management, administration and operation of the Company are delegated to the Chief Executive Officer and the senior management. The delegated functions and responsibilities are periodically reviewed. Approval has to be obtained from the Board prior to any significant transactions entered into by the aforesaid officers.

Directors keep abreast of responsibilities as a director of the Company and of the conduct, business activities and development of the Company.

Each newly appointed director receives formal, comprehensive and tailored induction on the first occasion of his/her appointment to ensure appropriate understanding of the business and operations of the Company and full awareness of director's responsibilities and obligations under the Listing Rules and relevant statutory requirements.

Continuing briefing and professional development for directors will be arranged where necessary.

Directors should participate in appropriate continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant.

The majority of the members of each Board committee are independent non-executive directors and the list of the chairman and members of each Board committee is set out under "Corporate Information" on page 143.

Board committees are provided with sufficient resources to discharge their duties and, upon reasonable request, are able to seek independent professional advice in appropriate circumstances at the Company's expense.

The principal duties of the Nomination Committee include reviewing the Board composition, developing and formulating relevant procedures for the nomination and appointment of directors, making recommendations to the Board on the appointment and succession planning of directors, and assessing the independence of independent non-executive directors.

The Nomination Committee has adopted a set of nomination procedures for selection of candidates for directorship of the Company by making reference to the skills, experience, professional knowledge, personal integrity and time commitments of such individuals, the Company's needs and other relevant statutory requirements and regulations.

In assessing the Board composition, the Nomination Committee would take into account various aspects set out in the Board diversity policy, including but not limited to gender, age, cultural and educational background, professional qualifications, skills, knowledge and industry and regional experience. The Nomination Committee would discuss and agree on measurable objectives for achieving diversity on the Board, where necessary, and recommend them to the Board for adoption.

The Nomination Committee met once during the year under review to review the structure, size and composition of the Board and the independence of the independent non-executive directors, and to consider the qualifications of the retiring directors standing for election at the Annual General Meeting. The Nomination Committee considered an appropriate balance of diversity perspectives of the Board is maintained.

REMUNERATION COMMITTEE

The Remuneration Committee comprises five members, namely, Mr. LAU Sik Yuen (chairman), Mr. LUO Shijie, Mr. ZHU Wujun, Mr. NG Wai Man and Mr. TING Yian Ann, the majority of which are independent non-executive directors.

- To review the relationship with the external auditors by reference to the work performed by the auditors, their fees and terms of engagement, and make recommendations to the Board on the appointment, re-appointment and removal of external auditors
- To review the adequacy and effectiveness of the Company's financial reporting system, internal control system and risk management system and associated procedures

DEED OF NON-COMPETITION

Each of the executive directors (collectively the "Covenantors") have entered into a Deed of Non-Competition in favour of the Company (on behalf of itself and the Group) dated 23 May 2011 (the "Deed"). Pursuant to the Deed, each of the Covenantors shall procure that their respective associates shall not directly or indirectly engage in any business in competition with the existing business activity of the Group. Relevant information on the Deed was disclosed in the Prospectus in the section headed "Relationship with Controlling Shareholders".

The Company has received confirmations from the Covenantors of their compliance with the terms of the Deed. The Covenantors declared that they have fully complied with the Deed for the year ended 31 December 2013. The independent non-executive directors have reviewed on the confirmations from the Covenantors and concluded that the Deed has been complied with and has been effectively enforced.

CONNECTED TRANSACTIONS

The Group entered into the following non-exempt continuing connected transactions during the year. The Stock Exchange has granted to the Company a conditional waiver from strict compliance with the announcement and/or independent shareholders' approval requirement for the following transactions subject to (i) the directors confirming that those transactions have been entered into in the ordinary and usual course of business of the Group, on normal commercial terms that are fair and reasonable and in the interests of the shareholders of the Company as a whole; and (ii) the proposed annual caps for those transactions are fair and reasonable and in the interests of the shareholders of the Company as a whole.

不競爭契據

本公司各執行董事(統稱為「契諾人」)已訂立以本公司(代表其本身及本集團)為受益人之日期為2011年5月23日之不競爭契據(「契據」)。根據契據,各契諾人將促致彼等各自之聯繫人士不會直接或間接參與與本集團現有業務活動構成競爭之任何業務。有關契據之相關資料於招股章程「與控股股東的關係」一節中披露。

本公司已收到契諾人就其遵守契據之條款 而發出之確認。契諾人表明於截至2013年 12月31日止年度內,彼等已完全遵守契 據。獨立非執行董事已審核來自契諾人之 確認並認為契據已獲遵守及有效執行。

關連交易

(A) Related Party Terminal Service Agreements

The Group entered into two related party terminal service agreements, namely Renewed Nanjing Phenol Storage Agreement and Ningbo Storage Agreements (collectively the "Related Party Terminal Service Agreements"), which constitute continuing connected transactions under the Listing Rules. Pursuant to Listing Rules 14A.25 and 14A.26, the transactions under the Related Party Terminal Service Agreements and the annual cap amounts of the transactions thereunder have been aggregated. Details of the Related Party Terminal Service Agreements are as follows:

(a) Renewed Nanjing Phenol Storage Agreement

On 3 December 2012, Nanjing Dragon Crown Liquid Chemical Terminal Company Limited ("Nanjing Dragon Crown") and DC Investments entered into the Renewed Nanjing Phenol Storage Agreement pursuant to which Nanjing Dragon Crown agreed to provide DC Investments with terminal and storage services for Phenol at the terminal of Nanjing Dragon Crown. The term of the Renewed Nanjing Phenol Storage Agreement is for the period from 1 January 2013 to 31 December 2015.

DC Investments is owned as to 98% by Mr. NG, a director and a controlling shareholder of the Company. It is principally engaged in trading of chemicals and investment holdings. According to the Listing Rules, DC Investments is an associate of Mr. NG and thus a connected person. As DC Investments is a connected person of the Company, the Renewed Nanjing Phenol Storage Agreement constitutes a continuing connected transaction of the Company under Rule 14A.14 of the Listing Rules.

(A) 關聯人士碼頭服務協議

本集團訂立兩份關聯人士碼頭服務協議,即經更新南京苯酚儲存協議和該等寧波儲存協議(統稱「關聯人士碼頭服務協議」),該等協議根據上市規則構成持續關連交易。根據上市規則第14A.25及14A.26條,於關聯人士碼頭服務協議下的交易和其項下交易的年度上限額已合併計算。關聯人士碼頭服務協議之詳情載列如下:

(a) 經更新南京苯酚儲存協議

於2012年12月3日,南京龍翔液體化工儲運碼頭有限公司 (「南京龍翔」)與龍翔化工國際訂立經更新南京苯酚儲在其 議,據此,南京龍翔同意在其 碼頭為龍翔化工國際提供有關 苯酚的碼頭及儲存服務。經期由 2013年1月1日起至2015年12 月31日止。

The fees for the services provided are principally determined by (i) the storage capacity of the tank to be provided by the Group to DC Investments; and (ii) the duration for the storage of Phenol at the Group's terminal in Nanjing with reference to the market price. The terms offered by DC Investments to Nanjing Dragon Crown are no less favourable than those offered by other Independent Third Parties in the ordinary course of business.

Pursuant to the mutual agreement between the parties, the Renewed Nanjing Phenol Storage Agreement was terminated with effect from 27 October 2013.

(b) Ningbo Storage Agreements

On 3 December 2012, Ningbo Ningxiang and Ningbo DC entered into the Ningbo Storage Agreement, pursuant to which Ningbo Ningxiang agreed to provide Ningbo DC with terminal and storage services at the Group's terminal in Ningbo. The term of the Ningbo Storage Agreement is for the period of three years from 1 January 2013 to 31 December 2015.

On 16 July 2013, Ningbo Ningxiang and Ningbo DC entered into an additional order for terminal and storage services for Methanol (together with the Ningbo Storage Agreement, the "Ningbo Storage Agreements") at the Group's terminal in Ningbo.

Ningbo DC is a wholly-owned subsidiary of DC Investments which in turn is owned as to 98% by Mr. NG, a director and a controlling shareholder. It is principally engaged in trading of chemicals. According to the Listing Rules, Ningbo DC is an associate of Mr. NG and thus a connected person. As Ningbo DC is a connected person of the Company, the Ningbo Storage Agreements constitute continuing connected transactions of the Company under Rule 14A.14 of the Listing Rules.

提供服務的費用主要按(i)本集團 向龍翔化工國際提供的儲罐儲量;及(ii)在本集團於南京的碼頭 儲存苯酚的時間並參考市場價 釐定。龍翔化工國際提供予南 京龍翔的條款當不遜於其他獨 立第三方於日常業務過程中所 提供的條款。

根據雙方共同協議,經更新南京苯酚儲存協議已終止,自 2013年10月27日起失效。

(b) 該等寧波儲存協議

於2012年12月3日,寧波寧翔 與寧波龍翔訂立寧波儲存協議, 據此寧波寧翔同意在本集團於寧 波的碼頭為寧波龍翔提供碼頭及 儲存服務。寧波儲存協議的年期 為三年,由2013年1月1日起至 2015年12月31日止。

於2013年7月16日,寧波寧翔 及寧波龍翔就於本集團寧波碼 頭提供甲醇的碼頭及儲存服務 簽訂額外訂單(與寧波儲存協議 統稱「該等寧波儲存協議」)。

The fees for the services provided are principally determined by (i) the quantity of the liquid chemical products handled by the Group; and (ii) the period for the storage of the liquid chemical products at the terminal with reference to the market price. The terms offered by Ningbo DC to Ningbo Ningxiang are no less favourable than those offered by other Independent Third Parties in the ordinary course of business.

提供服務的費用主要按照(i)本集團所處理液體化學品的數量:及(ii)在碼頭儲存液體化學品的期間並參考市場價釐定。寧波龍翔提供予寧波寧翔的條款當不遜於其他獨立第三方於日常業務過程中所提供的條款。

(B) Pipe Racks Agreements

The Group entered into the Pipe Racks Services Agreements and the Security Services Agreement (collectively the "Pipe Racks Agreements"), which constitute continuing connected transactions under the Listing Rules. Pursuant to the Listing Rules 14A.25 and 14A.26, the transactions under the Pipe Racks Agreements and the annual cap amounts of the transactions thereunder have been aggregated.

(B) 管架協議

本集團已訂立管架服務協議及保安服務協議(統稱為「管架協議」),根據上市規則,交易構成持續關連交易。根據上市規則14A.25及14A.26條,於管架協議下的交易和其項下交易的年度上限額已合併計算。

In March 2007, the Group and Nanjing CIPC entered into a pipe racks services agreement (the "Pipe Racks Services Agreement"), pursuant to which Nanjing CIPC agreed to lease to the Group the pipe racks for the Acetic Acid pipelines and Methanol pipelines at the Nanjing Chemical Industry Park. The Pipe Racks Services Agreement was supplemented by (i) a supplemental agreement dated 28 September 2007, pursuant to which Nanjing CIPC agreed to lease to the Group the pipe racks for the Vinyl Acetate and Acetic Anhydride pipelines at the Nanjing Chemical Industry Park; (ii) a supplemental agreement dated 12 October 2007, pursuant to which Nanjing CIPC agreed to lease to the Group the pipe racks for the Ethylene pipelines at the Nanjing Chemical Industry Park; (iii) a supplemental agreement dated June 2008, pursuant to which Nanjing CIPC agreed to lease to the Group the pipe racks for the sub-pipelines of the Group connecting to the pipelines of two customers of Celanese; (iv) the Fourth Supplemental Pipe Racks Agreement entered into between the Group and Nanjing CIPC on 3 December 2012, pursuant to which Nanjing CIPC agreed to lease to the Group the pipe racks for the Ethyl Acetate and Ethanol pipelines at the Nanjing Chemical Industry Park. The Fourth Supplemental Pipe Racks Agreement shall be with effect from 1 March 2013; and (v) the Fifth Supplemental Pipe Racks Agreement entered into between the Group and Nanjing CIPC in August 2013, pursuant to which Nanjing CIPC agreed to lease the Group the pipe racks for cryogenic ethylene at Nanjing Chemical Industry Park. The Fifth Supplemental Pipe Racks Agreement were effective from 1 October 2013 and was entered into to modify the previous pipe racks agreements with an additional annual cost of approximately RMB956,000 for renting additional pipe racks. The Pipe Racks Services Agreements are for a period of 15 years from 15 March 2007 to 14 March 2022 and can be extended for a further five years upon expiry unless the parties thereto terminate the Pipe Racks Services Agreements. The fees payable for the pipe racks rental by the Group are principally determined by the occupied area of pipelines in the pipe racks rented to the Group by Nanjing CIPC subject to adjustment with reference to bank lending interest rate, consumer price index, inflation, etc.. The terms offered by Nanjing CIPC to the Group are no less favourable than those offered by other Independent Third Parties in the ordinary course of business.

於2007年3月,本集團與南京CIPC訂 立管架服務協議(「管架服務協議」), 據此,南京CIPC同意向本集團出租在 南京化學工業園區的醋酸管道及甲醇 管道。管架服務協議(i)經日期為2007 年9月28日的補充協議所補充,據 此,南京CIPC 同意向本集團出租管 架,供南京化學工業園區的醋酸乙烯 酯及醋酐管道之用;(ii)經日期為2007 年10月12日的補充協議所補充,據 此,南京CIPC 同意向本集團出租管 架,供南京化學工業園區的乙烯管道 之用;(iii)經日期為2008年6月的補充 協議所補充,據此,南京CIPC同意向 本集團出租管道,供與兩家塞拉尼斯 客戶連接的本集團分管道之用; (iv)本 集團與南京CIPC於2012年12月3日 訂立管架補充服務協議四,據此,南 京CIPC同意向本集團出租管架,供南 京化學工業園區的醋酸乙酯及乙醇管 道之用。管架補充服務協議四由2013 年3月1日起生效;及(v)本集團與南 京CIPC於2013年8月訂立管架補充 服務協議五,據此,南京CIPC同意向 本集團出租管架,供南京化學工業園 區的低溫乙烯管道之用。管架補充服 務協議五由2013年10月1日起生效及 其訂立乃為修改先前之管架協議,租 賃新增管架之年度額外成本為人民幣 956,000元。管架服務協議自2007年 3月15日至2022年3月14日止為期 十五年,除非訂約各方終止該管架服 務協議,否則可於到期後進一步延長 五年。本集團就租賃管架而應付的費 用主要按南京CIPC出租予本集團的管 架佔用的管道面積釐定,並可按銀行 貸款利率、消費價格指數及通貨膨脹 率等予以調整。南京CIPC提供予本集 團的條款不遜於其他獨立第三方於日 常業務過程中所提供的條款。

In addition, in March 2007, the Group and Nanjing CIPPS, a wholly-owned subsidiary of Nanjing CIPC, entered into a security services agreement (the "Security Services Agreement"), pursuant to which Nanjing CIPPS agreed to provide security services for the pipe racks rented by the Group at the Nanjing Chemical Industry Park. Nanjing CIPPS shall provide security, patrol and monitor services of the Group's pipelines at the Nanjing Chemical Industry Park. The Security Services Agreement is for a period of 15 years from 15 March 2007 to 14 March 2022 and can be extended for a further five years upon expiry unless the parties thereto terminate the Security Services Agreements.

Nanjing CIPC is interested in 11.39% equity interest in Nanjing Dragon Crown, which is a non-wholly owned subsidiary of the Company. Nanjing CIPC is thus a connected person of the Company solely by reason that it is a substantial shareholder of Nanjing Dragon Crown. In addition, since Nanjing CIPPS is a wholly-owned subsidiary of Nanjing CIPC, it is thus a connected person of the Company by reason that it is a wholly-owned subsidiary of Nanjing CIPC, a substantial shareholder of Nanjing Dragon Crown.

As each of Nanjing CIPC and Nanjing CIPPS is a connected person of the Company, each of the Pipe Racks Agreements constitutes a continuing connected transaction of the Company under Rule 14A.14 of the Listing Rules.

The fees payable for the security services by the Group under the Security Services Agreement are principally determined by the length of pipe racks at a maximum of 10 kilometres which requires the provision of security services by Nanjing CIPPS. The terms offered by Nanjing CIPPS to the Group are no less favourable than those offered by other Independent Third Parties in the ordinary course of business.

此外,於2007年3月,本集團與南京 CIPPS(南京CIPC 的全資附屬公司)訂 立保安服務協議(「保安服務協議」),據此,南京 CIPPS 同意在南京化學工業園區為本集團租賃的管架提供保安 服務。南京 CIPPS 將為本集團在南京化學工業園區的管道提供保安、巡邏及監察服務。保安服務協議的年期由 2007年3月15日至2022年3月14日止,為期十五年,除非訂約各方終止保安服務協議,否則可於到期後進一步延長五年。

南京CIPC擁有本公司的非全資附屬公司南京龍翔11.39%權益。由於南京CIPC為南京龍翔的主要股東,因而屬本公司的關連人士。此外,由於南京CIPPS為南京CIPC的全資附屬公司,因此,其為本公司的關連人士,乃因其為南京CIPC(南京龍翔的主要股東)的全資附屬公司。

由於南京CIPC與南京CIPPS各自均為本公司的關連人士,各管架協議構成本公司於上市規則第14A.14條下的持續關連交易。

本集團根據保安服務協議就保安服務應付的費用主要按需要由南京CIPPS提供保安服務的管架長度釐定,最長為10公里,南京CIPPS提供予本集團的條款不遜於其他獨立第三方於日常業務過程中所提供的條款。

(C) Renewed Office Lease Agreement

On 3 December 2012, the Renewed Office Lease Agreement was entered into between DC Investments as landlord and the Group as tenant in respect of the premises located at Unit No. 3 on the 18th Floor of Convention Plaza, Office Tower, No. 1 Harbour Road, Hong Kong, with a gross floor area of approximately 2,227 square feet for a fixed term of three years from 1 January 2013 to 31 December 2015. The property is currently occupied by the Group for office use.

The annual rent payable to DC Investments was determined at arm's length negotiation between the parties to the Renewed Office Lease Agreement with reference to the valuation made by the independent property valuer of the Company, Savills Valuation and Professional Services Limited, and the previous transaction between the parties.

The independent non-executive directors of the Company have, for the purpose of Rule 14A.37 of the Listing Rules, reviewed the continuing connected transactions set out above and have confirmed that these continuing connected transactions have been entered into by the Group (i) in the ordinary and usual course of its business; (ii) on normal commercial terms or on terms no less favourable to the Group than terms available to or from independent third parties; and (iii) in accordance with the terms of the agreements governing such transactions that are fair and reasonable and in the interests of the Company's shareholders as a whole.

Pursuant to Rule 14A.38 of the Listing Rules, the Company's auditors were engaged to report on the Group's continuing connected transactions in accordance with Hong Kong Standard on Assurance Engagements 3000 "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information" and with reference to Practice Note 740 "Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules" issued by the Hong Kong Institute of Certified Public Accountants. The auditors have not qualified its report in respect of the continuing connected transactions disclosed above by the Group. A copy of the auditor's letter has been provided by the Company to the Stock Exchange.

(C) 經更新辦公室租賃協議

於2012年12月3日,龍翔化工國際 (作為業主)與本集團(作為承租人) 就位於香港港灣道1號會展廣場辦公 大樓18樓3室的物業訂立一份經更 新辦公室租賃協議,總建築面積約為 2,227平方呎,固定年期為3年,由 2013年1月1日起至2015年12月31 日止。該物業目前由本集團佔用作辦 公用途。

應付予龍翔化工國際的年度租金乃由 經更新辦公室租賃協議各方經公平磋商並參考本公司獨立物業估值師第一太平戴維斯估值及專業顧問有限公司的估值以及各方之間的交易而釐定。

就上市規則第14A.37條而言,本公司獨立 非執行董事已審核上述所載的持續關連交 易,並確認該等持續關聯交易已由本集團 於下列情況中訂立(i)屬本集團日常及一般業 務:(ii)按一般商業條款或對本集團而言不遜 於獨立第三方所提供的條款:及(iii)根據規 管該等交易的協議條款,而有關條款屬公 平合理並符合股東的整體利益。

根據上市規則第14A.38條,本公司之核數師已獲聘依照香港會計師公會頒佈的《香港核證工作準則》第3000號「對過往財務資料進行審核或審閱以外的核證工作」及參照應用指引第740號「關於香港《上市規則》所述持續關連交易的核數師函件」報告本集團的持續關連交易。就本集團以上披露的持續關連交易,核數師於其報告內並未發出保留意見。核數師函件副本已由本公司提交予聯交所。

RELATED PARTY TRANSACTIONS

The details of the related party transactions are set out in note 35 to the financial statements.

1. CORPORATE INFORMATION

The Company was incorporated on 16 July 2010 as an exempted company with limited liability under Companies Law of the Cayman Islands. The address of its registered office is Cricket Square, Hutchins Drive, P.O. Box 2681, Grand Cayman KY1-1111, Cayman Islands. The address of its principal place of business in Hong Kong is Unit No.3, 18th Floor, Convention Plaza, Office Tower, No.1 Harbour Road, Hong Kong. The Group is principally engaged in terminal storage and handling of liquid chemicals.

In the opinion of the directors of the Company, the ultimate holding company of the Company is Lirun Limited, which is a limited liability company incorporated in the British Virgin Islands (the "BVI").

2.1 BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") (which include all Hong Kong Financial Reporting Standards, Hong Kong Accounting Standards ("HKASs") and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants, accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention. These financial statements are presented in Hong Kong dollars and all values are rounded to the nearest thousand except when otherwise indicated.

1. 公司資料

2.1 編製基準

該等財務報表乃根據香港會計師公會 頒佈之香港財務報告準則(「香港財務 報告準則」)(包括所有香港財務報告 準則、香港會計準則(「香港會計準 則」)及詮釋)、香港公認會計原則及 香港公司條例之披露規定而編製。該 等財務報表乃按歷史成本慣例編製。 除另有指明外,該等財務報表以港元 呈列,而所有金額均調整至最接近千 港元。

2.1 BASIS OF PREPARATION (continued)

Basis of consolidation

The consolidated financial statements include the financial statements of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2013. The financial statements of the subsidiaries are prepared for the same reporting period as the Company, using consistent accounting policies. The results of subsidiaries are consolidated from the date on which the Group obtains control, and continue to be consolidated until the date that such control ceases.

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests, even if this results in the non-controlling interests having a deficit balance. All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control described in the accounting policy for subsidiaries below. A change in the ownership interest of a subsidiary, without a loss of control, is accounted for as an equity transaction.

If the Group loses control over a subsidiary, it derecognises (i) the assets (including goodwill) and liabilities of the subsidiary, (ii) the carrying amount of any non-controlling interest and (iii) the cumulative translation differences recorded in equity; and recognises (i) the fair value of the consideration received, (ii) the fair value of any investment retained and (iii) any resulting surplus or deficit in profit or loss. 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Business combinations and goodwill

Business combinations are accounted for using the acquisition method. The consideration transferred is measured at the acquisition date fair value which is the sum of the acquisition date fair values of assets transferred by the Group, liabilities assumed by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree that are present ownership interests and entitle their holders to a proportionate share of net assets in the event of liquidation either at fair value or at the proportionate share of the acquiree's identifiable net assets. All other components of non-controlling interests are measured at fair value. Acquisition-related costs are expensed as incurred.

When the Group acquires a business, it assesses the financial assets and liabilities assumed for appropriate classification and designation in accordance with the contractual terms, economic circumstances and pertinent conditions as at the acquisition date. This includes the separation of embedded derivatives in host contracts by the acquiree.

If the business combination is achieved in stages, the previously held equity interest is remeasured at its acquisition date fair value and any resulting gain or loss is recognised in profit or loss.

Any contingent consideration to be transferred by the acquirer is recognised at fair value at the acquisition date. Contingent consideration classified as an asset or liability that is a financial instrument and within the scope of HKAS 39 is measured at fair value with changes in fair value either recognised in profit or loss or as a change to other comprehensive income. If the contingent consideration is not within the scope of HKAS 39, it is measured in accordance with the appropriate HKFRS. Contingent consideration that is classified as equity is not remeasured and subsequent settlement is accounted for within equity.

Goodwill is initially measured at cost, being the excess of the aggregate of the consideration transferred, the amount recognised for non-controlling interests and any fair value of the Group's previously held equity interests in the acquiree over the identifiable net assets acquired and liabilities assumed. If the sum of this consideration and other items is lower than the fair value of the net assets acquired, the difference is, after reassessment, recognised in the statement of profit or loss as a gain on bargain purchase.

After initial recognition, goodwill is measured at cost less any accumulated impairment losses. Goodwill is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. The Group performs its annual impairment test of goodwill as at 31 December. For the purpose of impairment testing, goodwill acquired in a business combination is, from the acquisition date, allocated to each of the Group's cashgenerating units, or groups of cash-generating units, that are expected to benefit from the synergies of the combination, irrespective of whether other assets or liabilities of the Group are assigned to those units or groups of units.

Impairment is determined by assessing the recoverable amount of the cash-generating unit (group of cash-generating units) to which the goodwill relates. Where the recoverable amount of the cash-generating unit (group of cash-generating units) is less than the carrying amount, an impairment loss is recognised. An impairment loss recognised for goodwill is not reversed in a subsequent period.

Where goodwill has been allocated to a cash-generating unit (or group of cash-generating units) and part of the operation within that unit is disposed of, the goodwill associated with the operation disposed of is included in the carrying amount of the operation when determining the gain or loss on the disposal. Goodwill disposed of in these circumstances is measured based on the relative value of the disposed operation and the portion of the cash-generating unit retained.

Subsidiaries

A subsidiary is an entity (including a structured entity), directly or indirectly, controlled by the Company. Control is achieved when the Group is exposed, or has rights, to variable returns from its involvement with the investee and has the ability to affect those returns through its power over the investee (i.e., existing rights that give the Group the current ability to direct the relevant activities of the investee).

When the Company has, directly or indirectly, less than a majority of the voting or similar rights of an investee, the Group considers all relevant facts and circumstances in assessing whether it has power over an investee, including:

- (a) the contractual arrangement with the other vote holders of the investee;
- (b) rights arising from other contractual arrangements; and
- (c) the Group's voting rights and potential voting rights.

The results of subsidiaries are included in the Company's statement of profit or loss to the extent of dividends received and receivable. The Company's investments in subsidiaries that are not classified as held for sale in accordance with HKFRS 5 are stated at cost less any impairment losses.

Investments in associates and joint ventures

An associate is an entity in which the Group has a long term interest of generally not less than 20% of the equity voting rights and over which it is in a position to exercise significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee, but is not control or joint control over those policies.

A joint venture is a type of joint arrangement whereby the parties that have joint control of the arrangement have rights to the net assets of the joint venture. Joint control is the contractually agreed sharing of control of an arrangement, which exists only when decisions about the relevant activities require the unanimous consent of the parties sharing control.

The Group's investments in associates and joint ventures are stated in the consolidated statement of financial position at the Group's share of net assets under the equity method of accounting, less any impairment losses. The Group's share of the post-acquisition results and other comprehensive income of associates and joint ventures is included in the consolidated statement of profit or loss and consolidated other comprehensive income, respectively. In addition, when there has been a change recognised directly in the equity of the associate or joint venture, the Group recognises its share of any changes, when applicable, in the consolidated statement of changes in equity. Unrealised gains and losses resulting from transactions between the Group and its associates or joint ventures are eliminated to the extent of the Group's investments in the associates or joint ventures, except where unrealised losses provide evidence of an impairment of the asset transferred. Goodwill arising from the acquisition of associates or joint ventures is included as part of the Group's investments in associates or joint ventures.

If an investment in an associate becomes an investment in a joint venture or vice versa, the retained interest is not remeasured. Instead, the investment continues to be accounted for under the equity method. In all other cases, upon loss of significant influence over the associate or joint control over the joint venture, the Group measures and recognises any retained investment at its fair value. Any difference between the carrying amount of the associate or joint venture upon loss of significant influence or joint control and the fair value of the retained investment and proceeds from disposal is recognised in profit or loss.

Impairment of non-financial assets

Where an indication of impairment exists, or when annual impairment testing for an asset is required (other than inventories, financial assets and goodwill), the asset's recoverable amount is estimated. An asset's recoverable amount is the higher of the asset's or cash-generating unit's value in use and its fair value less costs of disposal, and is determined for an individual asset, unless the asset does not generate cash inflows that are largely independent of those from other assets or groups of assets, in which case the recoverable amount is determined for the cash-generating unit to which the asset belongs.

An impairment loss is recognised only if the carrying amount of an asset exceeds its recoverable amount. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. An impairment loss is charged to the statement of profit or loss in the period in which it arises.

An assessment is made at the end of each reporting period as to whether there is an indication that previously recognised impairment losses may no longer exist or may have decreased. If such an indication exists, the recoverable amount is estimated. A previously recognised impairment loss of an asset other than goodwill is reversed only if there has been a change in the estimates used to determine the recoverable amount of that asset, but not to an amount higher than the carrying amount that would have been determined (net of any depreciation/amortisation) had no impairment loss been recognised for the asset in prior years. A reversal of such an impairment loss is credited to the statement of profit or loss in the period in which it arises.

Property, plant and equipment and depreciation

Property, plant and equipment, other than construction in progress, are stated at cost less accumulated depreciation and any impairment losses. The cost of an item of property, plant and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use.

Expenditure incurred after items of property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of profit or loss in the period in which it is incurred. In situations where the recognition criteria are satisfied, the expenditure for a major inspection is capitalised in the carrying amount of the asset or as a replacement. Where significant parts of property, plant and equipment are required to be replaced at intervals, the Group recognises such parts as individual assets with specific useful lives and depreciates them accordingly.

Depreciation is calculated on the straight-line basis to write off the cost of each item of property, plant and equipment to its residual value over its estimated useful life. The principal annual rates used for this purpose are as follows:

Buildings and structures 3.17%-19%

Motor vehicles 19%
Office equipment 19%

Where parts of an item of property, plant and equipment have different useful lives, the cost of that item is allocated on a reasonable basis among the parts and each part is depreciated separately. Residual values, useful lives and the depreciation method are reviewed, and adjusted if appropriate, at least at each financial year end.

An item of property, plant and equipment including any significant part initially recognised is derecognised upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss on disposal or retirement recognised in the statement of profit or loss in the period the asset is derecognised is the difference between the net sales proceeds and the carrying amount of the relevant asset.

Construction in progress represents the infrastructure of a terminal under construction, which is stated at cost less any impairment losses, and is not depreciated. Cost comprises the direct costs of construction and capitalised borrowing costs on related borrowed funds during the period of construction.

Construction in progress is reclassified to the appropriate category of property, plant and equipment when completed and ready for use.

Operating leases

Leases where substantially all the rewards and risks of ownership of assets remain with the lessor are accounted for as operating leases. Where the Group is the lessor, assets leased by the Group under operating leases are included in non-current assets, and rentals receivable under the operating leases are credited to the statement of profit or loss on the straight-line basis over the lease terms. Where the Group is the lessee, rental payables under operating leases net of any incentives received from the lessor are charged to the statement of profit or loss on the straight-line basis over the lease terms.

Prepaid land lease payments under operating leases are initially stated at cost and subsequently recognised on the straight-line basis over the lease terms.

Investments and other financial assets

Financial assets are classified at initial recognition, as loans and receivables. The Group determines the classification of its financial assets at initial recognition. When financial assets are recognised initially, they are measured at fair value plus transaction costs that are attributable to the acquisition of the financial assets, except in the case of financial assets recorded at fair value through profit or loss.

All regular way purchases and sales of financial assets are recognised on the trade date, that is, the date that the Group commits to purchase or sell the asset. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the period generally established by regulation or convention in the marketplace.

資產所有權的絕大部分回報及風險由 出租人保留的租賃乃列為經營租賃。 倘本集團是出租人,由本集團以經營 租賃出租的資產會在非流動資產內列 賬,而經營租賃的應收租金按租約年 期以直線法列入損益表內。倘本集團 是承租人,經營租賃的應付租金扣除 自出租人收取的任何優惠,按租約年 期以直線法列支於損益表。

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. After initial measurement, such assets are subsequently measured at amortised cost using the effective interest rate method less any allowance for impairment. Amortised cost is calculated by taking into account any discount or premium on acquisition and includes fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in other income and gains in the statement of profit or loss. The loss arising from impairment is recognised in the statement of profit or loss in finance costs for loans and in other operating expenses for receivables.

Impairment of financial assets

The Group assesses at the end of each reporting period whether there is objective evidence that a financial asset or a group of financial assets is impaired. An impairment exists if one or more events that occurred after the initial recognition of the asset have an impact on the estimated future cash flows of the financial asset or the group of financial assets that can be reliably estimated. Evidence of impairment may include indications that a debtor or a group of debtors is experiencing significant financial difficulty, default or delinquency in interest or principal payments, the probability that they will enter bankruptcy or other financial reorganisation and observable data indicating that there is a measurable decrease in the estimated future cash flows, such as changes in arrears or economic conditions that correlate with defaults.

Financial assets carried at amortised cost

For financial assets carried at amortised cost, the Group first assesses whether impairment exists individually for financial assets that are individually significant, or collectively for financial assets that are not individually significant. If the Group determines that no objective evidence of impairment exists for an individually assessed financial asset, whether significant or not, it includes the asset in a group of financial assets with similar credit risk characteristics and collectively assesses them for impairment. Assets that are individually assessed for impairment and for which an impairment loss is, or continues to be, recognised are not included in a collective assessment of impairment.

The amount of any impairment loss identified is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred). The present value of the estimated future cash flows is discounted at the financial asset's original effective interest rate (that is, the effective interest rate computed at initial recognition).

The carrying amount of the asset is reduced through the use of an allowance account and the loss is recognised in the statement of profit or loss. Interest income continues to be accrued on the reduced carrying amount and is accrued using the rate of interest used to discount the future cash flows for the purpose of measuring the impairment loss. Loans and receivables together with any associated allowance are written off when there is no realistic prospect of future recovery and all collateral has been realised or has been transferred to the Group.

If a write-off is later recovered, the recovery is credited to the statement of profit or loss.

Derecognition of financial assets

A financial asset (or, where applicable, a part of a financial asset or part of a group of similar financial assets) is derecognised (ie. removed from the Group's consolidated statement of financial position) when:

- the rights to receive cash flows from the asset have expired; or
- the Group has transferred its rights to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under a "pass-through" arrangement; and either (a) the Group has transferred substantially all the risks and rewards of the asset, or (b) the Group has neither transferred nor retained substantially all the risks and rewards of the asset, but has transferred control of the asset.

When the Group has transferred its rights to receive cash flows from an asset or has entered into a pass-through arrangement, it evaluates if and to what extent it has retained the risk and rewards of ownership of the asset. When it has neither transferred nor retained substantially all the risks and rewards of the asset nor transferred control of the asset, the Group continues to recognise the transferred asset to the extent of the Group's continuing involvement. In that case, the Group also recognises an associated liability. The transferred asset and the associated liability are measured on a basis that reflects the rights and obligations that the Group has retained.

Financial liabilities at amortised cost

Financial liabilities which include other payables and accruals, and interest-bearing bank loans are initially stated at fair value and net of directly attributable transaction costs. After initial recognition, financial liabilities are subsequently measured at amortised cost, using the effective interest rate method unless the effect of discounting would be immaterial, in which case they are stated at cost.

Gains and losses are recognised in the statement of profit or loss when the liabilities are derecognised as well as through the effective interest rate amortisation process.

Amortised cost is calculated by taking into account any discount or premium on acquisition and fees or costs that are an integral part of the effective interest rate. The effective interest rate amortisation is included in finance costs in the statement of profit or loss.

A financial liability is derecognised when the obligation under the liability is discharged or cancelled, or expires.

When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as a derecognition of the original liability and a recognition of a new liability, and the difference between the respective carrying amounts is recognised in the statement of profit or loss.

Financial guarantee contracts

Financial guarantee contracts issued by the Group are those contracts that require a payment to be made to reimburse the holder for a loss it incurs because the specified debtor fails to make a payment when due in accordance with the terms of a debt instrument. A financial guarantee contract is recognised initially as a liability at its fair value, adjusted for transaction costs that are directly attributable to the issuance of the guarantee. Subsequent to initial recognition, the Group measures the financial guarantee contract at the higher of: (i) the amount of the best estimate of the expenditure required to settle the present obligation at the end of the reporting period; and (ii) the amount initially recognised less, when appropriate, cumulative amortisation.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the consolidated statement of financial position if there is currently an enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

Cash and cash equivalents

For the purpose of the consolidated statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments that are readily convertible into known amounts of cash, are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the Group's cash management.

For the purpose of the statement of financial position, cash and cash equivalents comprise cash on hand and at banks, including term deposits and asset similar in nature to cash, which are not restricted as to use.

Inventories

Inventories represent consumables, tools and parts for use in the operation, and are stated at the lower of cost and net realisable value. Cost is determined on the first-in, first-out basis. Net realisable value is based on estimated selling prices less any estimated costs to be incurred to completion and disposal.

Income tax

Income tax comprises current and deferred tax. Income tax relating to items recognised outside the profit or loss is recognised outside the profit or loss, either in other comprehensive income or directly in equity.

Current tax assets and liabilities for the current and prior periods are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period, taking into consideration interpretations and practices prevailing in the regions in which the Group operates.

Employee benefits

Pension schemes

The Group operates a defined contribution Mandatory Provident Fund retirement benefit scheme (the "MPF Scheme") under the Mandatory Provident Fund Schemes Ordinance for those employees who are eligible to participate in the MPF Scheme. Contributions are made based on a percentage of the employees' basic salaries and are charged to the statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme.

The employees of the Group's subsidiary which operates in Mainland China are required to participate in a central pension scheme operated by the local municipal government. The subsidiary is required to contribute a certain percentage of its payroll costs to the central pension scheme. The contributions are charged to the statement of profit or loss as they become payable in accordance with the rules of the central pension scheme.

Foreign currencies

The financial statements are presented in Hong Kong dollars, which is also the Company's functional currency. Each entity in the Group determines its own functional currency and items included in the financial statements of each entity are measured using that functional currency. Foreign currency transactions recorded by the entities in the Group are initially recorded using their respective functional currency rates prevailing at the dates of the transactions. Monetary assets and liabilities denominated in foreign currencies are translated at the functional currency rates of exchange ruling at the end of each reporting period. Differences arising on settlement or translation of monetary items are recognised in the statement of profit or loss.

Non-monetary items that are measured in terms of historical cost in a foreign currency are translated using the exchange rates at the dates of the initial transactions. Non-monetary items measured at fair value in a foreign currency are translated using the exchange rates at the date when the fair value was measured. The gain or loss arising on translation of a non-monetary item measured at fair value is treated in line with the recognition of the gain or loss on change in fair value of the item (i.e., translation differences on the item whose fair value gain or loss is recognised in other comprehensive income or profit or loss, respectively).

The functional currencies of certain overseas subsidiaries, associates and joint ventures are currencies other than the Hong Kong dollar. As at the end of the reporting period, the assets and liabilities of these entities are translated into the presentation currency of the Company at the exchange rates prevailing at the end of the reporting period and their statement of profit or loss are translated into Hong Kong dollars at the weighted average exchange rates for the year. The resulting exchange differences are recognised in other comprehensive income and accumulated in the exchange fluctuation reserve. On disposal of a foreign operation, the component of other comprehensive income relating to that particular foreign operation is recognised in the statement of profit or loss.

Any goodwill arising on the acquisition of a foreign operation and any fair value adjustments to the carrying amounts of assets and liabilities arising on acquisition are treated as assets and liabilities of the foreign operation and translated at the closing rate.

For the purpose of the consolidated statement of cash flows, the cash flows of those entities comprising the Group in which their functional currencies are currencies other than the Hong Kong dollar are translated into the presentation currency of the Company at the exchange rates ruling at the dates of the cash flows. Frequently recurring cash flows of those entities which arise throughout the year are translated into Hong Kong dollars at the weighted average exchange rates for the year.

Borrowing costs

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, i.e., assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. The capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs capitalised. All other borrowing costs are expensed in the period in which they are incurred. Borrowing costs consist of interest and other costs that an entity incurs in connection with the borrowing of funds.

Dividends

Final dividends proposed by the directors are classified as a separate allocation of retained profits within the equity section of the statement of financial position, until they have been approved by the shareholders in a general meeting or in the case of subsidiaries in the People's Republic of China ("PRC"), by the board of directors. When these dividends have been approved by the shareholders and declared, they are recognised as a liability.

The preparation of the Group's financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts of revenues, expenses, assets and liabilities, and the disclosure of contingent liabilities, at the end of each reporting period. Uncertainty about these assumptions and estimates could result in outcomes that could require a material adjustment to the carrying amounts of the assets or liabilities affected in the future.

Judgements

In the process of applying the Group's accounting policies, management has made the following judgement, apart from those involving estimations, which has the most significant effect on the amounts recognised in the financial statements:

Income taxes

Significant management judgements on the future tax treatment of certain transactions are required in determining income tax provisions. The Group carefully evaluates tax implications of transactions and tax provisions are set up accordingly. The tax treatment of such transactions is reconsidered periodically to take into account all changes in tax legislation.

Estimation uncertainty

The key assumptions concerning the future and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial period, are described below.

Useful lives of property, plant and equipment

The cost of property, plant and equipment is depreciated on the straight-line basis over the property, plant and equipment's estimated economic useful lives. Management estimates the useful lives of the property, plant and equipment to be five to thirty years. Changes in the expected level of usage and/or the period over which future economic benefits are generated could impact the economic useful lives of the assets and, therefore, future depreciation charges could be revised.

Impairment of non-financial assets

The Group assesses whether there are any indicators of impairment for all non-financial assets at the end of each reporting period. Indefinite life intangible assets are tested for impairment annually and at other times when such an indicator exists. Other non-financial assets are tested for impairment when there are indicators that the carrying amounts may not be recoverable. An impairment arises when the carrying value of an asset or a cash-generating unit exceeds its recoverable amount, which is the higher of its fair value less costs of disposal and its value in use. The calculation of the fair value less costs of disposal is based on available data from binding sales transactions in an arm's length transaction of similar assets or observable market prices less incremental costs for disposal of the asset. When value in use calculations are undertaken, management must estimate the expected future cash flows from the asset or cashgenerating unit and choose a suitable discount rate in order to calculate the present value of those cash flows.

Impairment of goodwill

The Group determines whether goodwill is impaired at least on an annual basis. This requires an estimation of the value in use of the cash-generating units to which the goodwill is allocated. Estimating the value in use requires the Group to make an estimate of the expected future cash flows from the cash-generating unit and also to choose a suitable discount rate in order to calculate the present value of those cash flows. The carrying amount of goodwill at 31 December 2013 was HK\$1,210,000 (2012: HK\$1,210,000). Further details are given in note 18 to the financial statements.

Impairment of accounts receivable

The Group assesses at the end of each reporting period whether there is any objective evidence that a receivable is impaired. To determine whether there is objective evidence of impairment, the Group considers factors such as the probability of insolvency or significant financial difficulties of the debtor and default or significant delay in payments. Where there is objective evidence of impairment, the amount and timing of future cash flows are estimated based on historical loss experience for assets with similar credit risk characteristics.

The Group maintains an allowance for estimated impairment of accounts receivable arising from the inability of its debtors to make the required payments. The Group makes its estimates based on the ageing of its trade receivable balances, debtors' creditworthiness, past repayment history and historical write-off experience. If the financial condition of its debtors was to deteriorate so that the actual impairment loss might be higher than expected, the Group would be required to revise the basis of making the allowance. The carrying amount of accounts receivable at 31 December 2013 was HK\$45,633,000 (2012: HK\$40,114,000). Further details are given in note 22 to the financial statements.

Taxes on profits assessable in Mainland China have been calculated at the rates of tax prevailing in Mainland China in which the Group operates, based on existing legislation, interpretations and practices in respect thereof.

Under the new PRC Enterprise Income Tax Law and its Implementation Rules (effective from 1 January 2008), the PRC Enterprise Income Tax rates for domestic and foreign-invested enterprises are unified at 25%. The other major tax concessions applicable to the Group's Mainland China subsidiary are detailed below.

Pursuant to the tax document Guoshui Han 2007 No. 2 "Approval on Enterprise Income Tax" issued by the national tax authority of Nanjing City, Jiangsu Province, the PRC, Nanjing Dragon Crown Liquid Chemical Terminal Company Limited, a subsidiary of the Group, is entitled to preferential tax treatment with full tax exemption from PRC Enterprise Income Tax ("EIT") for the first five profitable years, commencing from 1 January 2007, and thereafter is entitled to a 50% deduction in the EIT rate for the subsequent five years. The Group's assessable income was subject to an EIT rate of 12.5% for the year ended 31 December 2013 (2012: 12.5%).

Goodwill acquired through business combinations is related to the cash-generating unit of terminal storage and the handling of liquid chemicals. Its recoverable amount has been determined based on a value in use calculation using cash flow projections based on financial budgets covering a five-year period approved by senior management. The discount rate applied to the cash flow projections is 9.5% (2012: 10.1%) and cash flows beyond the five-year period are extrapolated using an inflation rate of 5% (2012: 5%).

Assumptions were used in the value in use calculation of the cash-generating unit of terminal storage and the handling of liquid chemicals. The following describes each key assumption on which management has based its cash flow projections to undertake impairment testing of goodwill:

Discount rate – The discount rate used is before tax and reflects specific risks relating to the relevant units.

Inflation rate – The basis used to determine the value assigned to cost of sales and the revenue price are the forecast price indices during the budget year in the PRC.

Pursuant to the PRC Corporate Income Tax Law, a 5% to 10% withholding tax rate is levied on dividends declared to foreign investors from foreign investment enterprises established in Mainland China. The requirement is effective from 1 January 2008 and applies to earnings generated after 31 December 2007. A lower withholding tax rate may be applied if there is a tax treaty between Mainland China and the jurisdiction of the foreign investors. For the Group, the applicable rate is 5%. The Group is therefore liable to withholding taxes on dividends distributed by the subsidiary, associates and joint ventures established in Mainland China in respect of earnings generated from 1 January 2008.

The Group has tax losses arising in Hong Kong of HK\$22,797,000 (2012: HK\$23,886,000) that are available indefinitely for offsetting against future taxable profits of the companies in which the losses arose. Deferred tax assets have not been recognised in respect of these losses as they have arisen in subsidiaries that have been loss-making for some time and in the opinion of the directors, it is not considered probable that taxable profits will be available against which the tax losses can be utilised.

37. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Group's principal financial instruments comprise cash and cash equivalents and interest-bearing bank loans. The main purpose of these financial instruments is to finance the Group's operations. The Group has various other financial assets and liabilities such as accounts receivable, financial assets included in deposits and other receivables, and other payables and accruals, which mainly arise directly from its operations.

The main risks arising from the Group's financial instruments are interest rate risk, credit risk and liquidity risk. The board of directors reviews and agrees policies for managing each of these risks and they are summarised below.

Interest rate risk

The Group's exposure to the risk of changes in market interest rates relates primarily to the Group's net debt obligations with floating interest rates. The majority of the bank borrowings bear interest at rates with reference to the PBOC base rate and HIBOR. The Group mitigates the risk by monitoring closely the movements in interest rates and reviewing its banking facilities and borrowings regularly. The Group has not used any interest rate swap to hedge its exposure to interest rate risk.

Credit risk

The Group primarily provides services to recognised and creditworthy third parties. It is the Group's policy that advanced payments are generally required for new customers. In addition, receivable balances are monitored on an ongoing basis and the Group's exposure to bad debts is not significant. Since the Group primarily provides services to recognised and creditworthy third parties, there is normally no requirement for collateral.

The credit risk of the Group's financial assets, which comprise cash and cash equivalents, accounts receivable and financial assets included in prepayments, deposits and other receivables, arises from default of the counterparties, with a maximum exposure equal to the carrying amounts of these instruments. As at 31 December 2013, there was a concentration of credit risk as approximately 66.7% (2012: 61.7%) of the Group's accounts receivable was due from one debtor. The Company is also exposed to credit risk through the granting of guarantee, further details of which are disclosed in note 32 to the financial statements.

Further quantitative data in respect of the Group's exposure to credit risk arising from accounts receivable, and financial assets included in prepayments, deposits and other receivables are disclosed in notes 22 and 23, respectively.

Liquidity risk

The Group monitors its risk to a shortage of funds by considering the maturity of both its financial liabilities and financial assets (for example, accounts receivable) and projected cash flows from operations.

The Group's objective is to maintain a balance between continuity of funding and flexibility through the use of internal funding and bank loans to meet its working capital requirements.
