\*Note: Owing to the significant increase of stock trading value followed by the brisk market, SBI SECURITIES reserved approximately JPY 2,482 million for financial instruments transaction liability reserves under the Financial Instruments and Exchange Act in the consolidated fiscal year ended March 2014, which means posting of an extraordinary loss.
