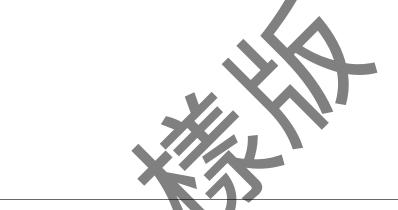

- 披露有關資料以便就權益索償;及
- 與上述有關的任何其他附帶或相關目的及/或 使本公司及H股證券登記處能解除對證券持有 人及/或監管機構承擔的責任及/或證券持 有人不時同意的任何其他目的。

3. 轉交個人資料

本公司及其H股證券登記處所持有關證券持有人的個人資料將會保密,但本公司及其H股證券登記處可以在為達到上述任何目的之必要情況下,向下列任何人士披露或轉交(無論在香港境內或境外)有關個人資料:

- 本公司委任的代理人,例如財務顧問、收款銀行和主要海外股份過戶登記處;
- (如證券申請人要求將證券存於中央結算系統) 香港結算或香港結算代理人;彼等將會就中央 結算系統的運作使用有關個人資料;
- 向本公司或H股證券登記處提供與其各自業務 營運有關的行政、電訊、電腦、付款或其他服 務的任何代理人、承包商或第三方服務供應 商;
- 香港聯交所、證監會及任何其他法定監管機關 或政府部門或其他法例、規則或法規所規定的 其他機構;及

4. 個人資料的保留
