申請人及證券持有人所提供的個人資料如有任何錯誤,須立即通知本公司及香港股份過戶登記處。

2. 目的

申請人及證券持有人的個人資料可因應以下目的使用、持有及處理及/或以任何方式儲存:

- 處理 閣下的申請及退款支票(如適用)、 核實是否符合本申請表格及招股章程載列的 條款和申請程序,以及公佈香港發售股份的 分配結果;
- 遵守香港及其他地區的適用法律及法規;
- 以證券持有人(包括香港結算代理人(如適用))的名義登記新發行證券或轉讓或受讓 證券;
- 存置或更新本公司證券持有人的名册;
- 核實證券持有人的身份;
- 確定本公司證券持有人的受益權利,例如股息、供股和紅股等;
- 分發本公司及其附屬公司的通訊;
