- 遵守香港及其他地區的適用法例、規則或規例(不 論為法定或其他規定),包括香港聯交所、證監會及 任何其他法定或政府部門之規則;

- 存置或更新本公司證券持有人的名册;

- 向本公司或香港股份過戶登記處提供與其各自業務 營運有關的行政、電訊、電腦、付款或其他服務的 任何代理人、承包商或第三方服務供應商;
- 香港聯交所 · 證監會及任何其他法定、監管機關或 政府部門或遵照其他法例、規則或法規;及
