There has been a significant decline in the retail markets in which the Group operates, particularly in Hong Kong, China and Singapore. As a result, the Group's sales and profitability have been adversely affected.

The Board of the Company announces that based on the unaudited consolidated results of the Group for the three months period ended 30th June, 2014 and the management's assessment of the current and likely market condition for the following three months, the Group may record a loss for the six months period ending 30th September, 2014 as compared to the six months period ended 30th September, 2013.

Shareholders of the Company and potential investors should exercise caution when dealing in the shares of the Company.

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited ("the Listing Rules") and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong) ("the SFO").

There has been a significant decline in the retail markets in which Dickson Concepts (International) Limited ("the Company") and its subsidiary companies (together "the Group") operate, particularly in Hong Kong, China and Singapore. As a result, the Group's sales and profitability have been adversely affected.

The board of directors (“the Board”) of the Company announces that based on the unaudited consolidated results of the Group for the three months period ended 30th June, 2014 and the management’s assessment of the current and likely market condition for the following three months, the Group may record a loss for the six months period ending 30th September, 2014 as compared to the six months period ended 30th September, 2013.

The information contained in this announcement is based only on the management’s preliminary assessment after reviewing the unaudited consolidated management accounts of the Group for the three months ended 30th June, 2014 and management’s assessment of the remaining three months up to 30th September, 2014. The Group’s half year results are subject to changes in market condition for the period ending 30th September, 2014 and further review by the management, and will be reviewed by the Company’s independent auditor prior to finalisation of such accounts. Therefore the actual results of the Group for the six months period ending 30th September, 2014 may differ from the information contained in this announcement.
