5. You must be outside the United States, not be a United States Person (as defined in Regulation S under the Securities Act) and not be a legal or natural person of the PRC.
6. Unless permitted by the Listing Rules, you cannot apply for any Public Offer Shares if you are:
  - an existing beneficial owner of shares in the Company and/or any of its subsidiaries;

  - have been allocated or have applied for or indicated an interest in any Placing Shares or otherwise participated in the Placing.
