

- 香港聯交所、證監會及任何其他法定監管機關 或政府部門或有關法例、規則或法規規定的其 他機構;及
- 證券持有人與其進行或擬進行交易的任何人士 或機構,例如彼等的銀行、律師、會計師或股 票經紀等。

### 4. 個人資料的保留
