- 與上述有關的任何其他附帶或相關目的及/ 或使本公司及香港證券登記處能履行對證 券持有人及/或監管機構承擔的責任及/ 或證券持有人不時同意的任何其他目的。

3. 轉交個人資料

本公司及其香港證券登記處所持有關證券持有 人的個人資料將會保密,但本公司及其香港證 券登記處可以在為達到上述任何目的之必要情 況下,向下列任何人士披露、取得或轉交(無論 在香港境內或境外)有關個人資料:

- 本公司委任的代理人。例如財務顧問、收款 銀行和主要海外股份過戶登記處;
- 如證券申請人要求將證券存於中央結算系統,香港結算或香港結算代理人,彼等將會就中央結算系統的運作使用有關個人資料;
- 向本公司或香港證券登記處提供與其各自業務營運有關的行政、電訊、電腦、付款或 其他服務的任何代理人、承包商或第三方 服務供應商;
- 聯交所、證監會及任何其他法定監管機關或 政府部門或遵照其他法例、規則或法規;及
- 證券持有人與其進行或擬進行交易的任何 人上或機構,例如彼等的銀行、律師、會計 師或股票經紀等。
