- 存置或更新本公司的證券持有人名册;
- 核實證券持有人身份;

3. 轉交個人資料

- 本公司委任的代理,例如財務顧問、收款銀行及海外股份過戶登記總處;
- (如證券申請人要求將證券存於中央結算系統)香港 結算或香港結算代理人;彼等將會就中央結算系統 的運作使用有關個人資料;
- 向本公司或香港證券登記處提供與其各自業務運作 有關的行政、電訊、電腦、付款或其他服務的任何 代理、承辦商或第三方服務供應商;
- 聯交所、證監會及任何其他法定監管機關或政府部 門或法例、規則或法規另行規定者;及
- 證券持有人與之有業務往來或擬有業務往來的任何人之或機構,例如彼等的銀行、律師、會計師或股票經紀等。

4. 保留個人資料
