To be valid, this proxy form (or if it is signed by his attorney duly authorised in writing pursuant to a power of attorney or other authority, then together with a notarially certified copy of such power of attorney or authority) must be deposited not later than 24 hours before the specified time of the meeting, to Computershare Hong Kong Investor Services Limited, the Company's Registrar of H Shares, at 17M Floor, Hopewell Centre, 183 Queen's Road East, Wanchai, Hong Kong. Completion and return of a proxy form will not preclude a shareholder from attending and voting in person at the H share class meeting if he so wishes.
- 8. Shareholders or their proxies attending the H share class meeting shall produce their identity documents.

In case of joint holders of any share, any one of such joint holders may vote at the H share class meeting, either personally or by proxy, in respect of such shares as if he is solely entitled thereto. However, if more than one of such joint holders are present at the H share class meeting, personally or by proxy, the vote of the joint holder whose name stands first in the register of members and who tenders a vote, whether personally or by proxy, will be accepted to the exclusion of the votes of other joint holder(s).
