**POLL RESULTS OF THE ANNUAL GENERAL MEETING
HELD ON 30 APRIL 2015**

The board of directors (the “**Board**”) of BBI Life Sciences Corporation (the “**Company**”) is pleased to announce that the Company held its annual general meeting (the “**AGM**”) on 30 April 2015, voting on all the proposed resolutions set out in the notice of the AGM dated 27 March 2015 was taken by way of polling.

As at the date of the AGM, the total number of issued shares of the Company was 524,663,100 shares, which was the total number of shares entitling the shareholders to attend and vote for or against the resolutions proposed at the AGM. No shareholders of the Company who were entitled to attend the AGM abstained from voting in favour of any resolutions proposed at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”), nor were any shareholders of the Company required under the Listing Rules to abstain from voting at the AGM.
