- 向本公司或H股證券登記處提供與其各自業務營運有關的行政、電訊、電腦、付款或其他服務的任何代理人、承包商或第三方服務供應商;
- 香港聯交所>香港證監會及任何其他法定 監管機關或政府部門或遵照其他法例、規 則或法規;及
