This announcement is made by SPT Energy Group Inc. (the “**Company**” and together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company wishes to inform the shareholders (the “**Shareholders**”) and potential investors of the Company that, based on the preliminary assessment on the unaudited and unreviewed consolidated management accounts of the Group for the six months ended 30 June 2015, the Group is expected to record a loss for the six months ended 30 June 2015 and the profit after tax will decrease by more than 360% as compared with the six months ended 30 June 2014, due to the effect of the major clients of the Group significantly reducing their investment in exploration and development as a result of the continuous weakening of the international oil prices and depression of the oil and gas field service market.

The information contained in this announcement is only based on the preliminary assessment of the information currently available by the Board, including the unaudited and unreviewed consolidated management accounts of the Group for the six months ended 30 June 2015 which have not been confirmed, reviewed or finalized by the Company’s auditor or the audit committee of the Company as at the date of this announcement. Shareholders and potential investors are advised to read carefully the interim results announcement of the Company for the six months ended 30 June 2015 which is expected to be published by the end of August 2015.
