**INSIDE INFORMATION**

This announcement is made by China Taifeng Beddings Holdings Ltd (the “**Company**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on the Stock Exchange of Hong Kong Limited and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Cap. 571 of the Laws of Hong Kong).

On 22 July 2015, the board of directors of the Company (the “**Board**”) received an order granted by the High Court of Hong Kong dated 17 July 2015 against our chairman, Mr. Liu Qingping (“**Mr. Liu**”) (the “**Order**”). The Order restrains Mr. Liu from (i) removing from Hong Kong any of his assets which are within Hong Kong, whether in his own name or not, and whether solely or jointly owned, up to the value of RMB106,842,727.31 (the “**Indebted Sum**”) or (ii) in any way dispose of or deal with or diminish the value of any of his assets, which are within Hong Kong, whether in his own name or not, and whether solely or jointly owned up to the value of the Indebted Sum. The prohibition includes shares of the Company held by Mr. Liu in his own name and through Fu Sun Development Limited (“**Fu Sun**”), a company wholly-owned by Mr. Liu.

Upon further enquiry with Mr. Liu, he confirmed that the Indebted Sum arises from his own personal dispute with a bank in the PRC. To the best knowledge of the Board, neither Mr. Liu nor Fu Sun pledged any shares in the Company in favour of the financial institution in relation to the Indebted Sum.

The Company is further informed by Mr. Liu that he will defend against the Order.

## **CONTINUED SUSPENSION OF TRADING OF THE SHARES**

As a result of the delay in publishing the 2014 Annual Results, trading in its shares on the Stock Exchange has been suspended and will remain suspended until further notice.
