On 12 August 2015, the Glass Transportation Service Agreement has been entered into pursuant to which Xinhe Logistics will, upon the request of Xinyi Solar Group, provide road and river transportation services in the PRC for the glass products produced by Xinyi Solar Group. The Glass Transportation Service Agreement is valid until 31 December 2017. The purpose of this announcement is to set forth the information on the Glass Transportation Service Agreement as required under the Listing Rules and the implications thereunder.

Currently, Xinyi Glass Group and Xinyi Solar Group are handling their glass transportation independently. Xinhe Logistics has its own fleet of trucks and vessels for road transportation and river transportation in the PRC and has its dedicated team of staff for coordinating with the third-party transportation service providers. Both Xinyi Glass Board and Xinyi Solar Board consider that the administrative cost could be reduced with the transportation services of the two group of companies to be handled and arranged by Xinhe Logistics. With the increasing demand for the transportation services, Xinhe Logistics is expected to be in a better position in negotiating lower freight rates or higher discount percentages to the standard freight rates charged by the third-party transportation service providers. These arrangements are expected to benefit Xinyi Glass Group and Xinyi Solar Group.

The Glass Transportation Service Agreement is valid until 31 December 2017. The purpose of this announcement is to set forth the information on the Glass Transportation Service Agreement as required under the Listing Rules and the implications thereunder.

PRINCIPAL TERMS OF THE GLASS TRANSPORTATION SERVICE AGREEMENT

The following sets forth the principal terms of the Glass Supply Framework Agreement:-

Date: 12 August 2015

Parties:

(a) Xinhe Logistics, a wholly-owned subsidiary of Xinyi Glass (Hong Kong), as the service provider of the Glass Transportation Services and

(b) Xinyi Solar (Wuhu), acting for itself and its subsidiaries, as the party sourcing the Glass Transportation Services.

Term:

Subject matter of the Glass Transportation Service Agreement:

Determination of the cost payable for the Glass Transportation Services and the Annual Caps:

From 12 August 2015 to 31 December 2017.

Upon the request of Xinyi Solar (Wuhu), Xinhe Logistics will provide road and river transportation services in the PRC for the glass products produced by Xinyi Solar Group. Xinyi Solar Group will not be obliged to use the Glass Transportation Services on an exclusive basis.

The expected annual transportation volume for each of (a) the period commenced from 12 August 2015 to 31 December 2015 and (b) the two years ending 31 December 2017 amounts to 0.64 million tonnes, 0.98 million tonnes and 1.04 million tonnes, respectively.

The cost for the Glass Transportation Services will be determined on an arm's length basis upon normal commercial terms with reference to, and cannot be higher and less favourable than, the standard freight rates charged by the third-party transportation service providers for comparable transactions during the same period. The cost will be settled by Xinyi Solar Group in cash on a monthly basis, free of interest on any accrued balance.

Based on the current applicable freight rates in the PRC, the estimated cost payable by Xinyi Solar Group to Xinhe Logistics for each of (a) the period commenced from 12 August 2015 to 31 December 2015 and (b) the two years ending 31 December 2017 is expected to be not more than RMB57.0 million (equivalent to HK\$68.7 million), RMB86.0 million (equivalent to HK\$103.6 million) and RMB 94.0 million (equivalent to HK\$113.3 million), respectively.

In determining the Annual Caps, Xinyi Solar Board has taken into consideration the expected annual transportation volume up to 31 December 2017 and the amount of transportation cost that may be payable to Xinhe Logistics with reference to the freight rates charged by the third-party transportation service providers for comparable transactions during the same period.
