- 如證券申請人要求將證券存於中央結算 系統,則為香港結算或香港結算代理 人。彼等將會就中央結算系統的運作使 用有關個人資料。
- 向本公司或香港股份過戶登記處提供與 其各自業務營運有關的行政、電訊、電 腦、付款或其他服務的任何代理、承包 商或第三方服務供應商;
- 聯交所、證監會及任何其他法定監管機 關或政府部門或遵照法例、規則或法規 的規定;及
- 證券持有人與其進行或擬進行交易的任何人士或機構,例如彼等的銀行、律師、會計師或股票經紀等。

4. 個人資料的保留

本公司及香港股份過戶登記處將按收集個人 資料所需的用途保留證券申請人及持有人的 個人資料。毋須保留的個人資料將會根據條 例銷毀或處理。

5. 查閱和更正個人資料
