The board of directors (the "Board") of Carry Wealth Holdings Limited (the "Company") presents the Interim Report and condensed consolidated financial information of the Company and its subsidiaries (collectively the "Group") for the six months ended 30 June 2015. The consolidated income statement, consolidated statement of comprehensive income, consolidated statement of changes in equity and consolidated cash flow statement of the Group for the six months ended 30 June 2015, and the consolidated balance sheet as at 30 June 2015 of the Group, all of which are unaudited and condensed, along with selected explanatory notes, are set out on pages 15 to 32 of this Report.

MANAGEMENT DISCUSSION AND ANALYSIS

Results and Business Review

For the six months ended 30 June 2015, the Group's revenues amounted to HK\$111.7 million (2014: HK\$78.6 million) and gross profit was HK\$42.2 million (2014: HK\$9.4 million). Profit attributable to equity holders was HK\$14.3 million (2014: loss of HK\$13.8 million). The basic and diluted earnings per share were 1.77 HK cents and 1.75 HK cents respectively (2014: basic and diluted loss per share were both 1.85 HK cents).

During the period under review, the US economy has continued its moderate growth. With the improvement in the job market, lower fuel prices and strengthening housing market, consumer sentiment has gradually revived. However, the world's second largest economy, Mainland China, was losing growth momentum. Economic data has indicated that factory activity and market consumption in the country were weakening. While in the Euro zone, consumer confidence was still weak even after the European Central Bank had launched quantitative easing to stimulate economic growth. Countries such as Greece, Spain and Italy still faced crippling levels of debt and high unemployment. Despite this unstable business environment, the Group's revenue from the garment manufacturing and trading business was maintained at HK\$79.5 million (2014: HK\$79.0 million) and the gross profit amounted to HK\$9.9 million (2014: HK\$9.8 million).

管理層討論及分析

業績及業務回顧

本集團截至二零一五年六月三十日止六個月之收益為一億一千一百七十萬港元(二零一四年:七千八百六十萬港元),毛利為四千二百二十萬港元(二零一四年:九百四十萬港元)。權益持有人應佔溢利為一千四百三十萬港元(二零一四年:虧損一千三百八十萬港元),而每股基本及攤薄盈利分別為1.77港仙及1.75港仙(二零一四年:每股基本及攤薄虧損均為1.85港仙)。

With a target to achieve GDP growth of 7%, Mainland China's government has implemented monetary policies including reduction of bank interest rates and reserve ratios to encourage funds to flow into the financial market so as to stimulate the real economy. With such a massive injection of liquidity further boosted by margin financing of stock trading, the Hong Kong Hang Seng Index and particularly the Shanghai Composite Index skyrocketed during the review period. For the six months ended 30 June 2015, the Group's securities investment business recorded a revenue and gross profit of HK\$32.3 million (2014: gross loss of HK\$0.4 million).

Despite a general increase in factory costs, the selling expenses to the garment manufacturing and trading revenue ratio was maintained at 1.8 (2014: 1.8) and the administrative expenses increased slightly to HK\$22.7 million (2014: HK\$22.3 million).

Segment Analysis

a) Garment manufacturing and trading segment

In the US, both the job and consumer markets continued their improvement. Household consumption and spending was also increasing. As a result, revenue from the US customers increased by 18.2% to HK\$29.7 million (2014: HK\$25.2 million) and accounted for 37.4% (2014: 31.8%) of the segment revenue.

Affected by the slowest economic growth rate in Mainland China since 2009, market demand and household spending dropped. However, with the concerted effort of the Group's sales team, revenue from Mainland China customers remained at HK\$39.4 million (2014: HK\$39.4 million) which accounted for 49.5% (2014: 49.8%) of the segment revenue. Revenue from European customers was HK\$7.8 million (2014: HK\$7.6 million) and accounted for 9.8% (2014: 9.6%) of the segment revenue.

儘管工廠成本整體上升,銷售開支對成 衣製造及貿易的收益比率維持於1.8(二 零一四年:1.8),惟行政開支輕微增加至 二千二百七十萬港元(二零一四年:二千 二百三十萬港元)。

分部分析

a) 成衣製造及貿易分部

美國的就業及消費市場均持續改善,家庭消費及開支亦不斷增加。受惠於此,來自美國客戶之收益增加18.2%至二千九百七十萬港元(二零一四年:二千五百二十萬港元),佔分部收益37.4%(二零一四年:31.8%)。

受中國大陸自二零零九年以來最緩慢的經濟增長率所影響,市場需求和家庭支出有所下降。然而,通過本集團的銷售團隊共同努力,來自中國大陸客戶之收益維持於三千九百四十萬港元(二零一四年:49.8%)。來自歐洲客戶之收益則為七百八十萬港元(二零一四年:七百六十萬港元),佔分部收益9.8%(二零一四年:9.6%)。

In summary, revenue from the garment manufacturing and trading segment was HK\$79.5 million (2014: HK\$79.0 million) and recorded a loss of HK\$2.3 million (2014: HK\$2.5 million).

b) Securities investment segment

In the period under review, triggered mainly by massive funds from Mainland China investors, the Hong Kong stock market surged with the Hang Seng Index reaching a seven-year high of 28,442 points on 28 April 2015. The Hang Seng Index closed at 26,250 points on 30 June 2015 (31 December 2014: 23,605 points). The Group's securities investment revenue recorded a net gain of HK\$32.3 million (2014: net loss of HK\$0.4 million) and the profit from this segment was HK\$26.1 million (2014: loss of HK\$2.1 million). As at 30 June 2015, the Group held a portfolio of Hong Kong-listed equity securities with a fair value of HK\$155.2 million (31 December 2014: HK\$113.7 million).

Liquidity and Financial Resources

Adhering to a conservative financial management methodology, the Group continued to maintain a healthy financial position. As at 30 June 2015, the Group's cash and bank deposits totalled HK\$111.5 million (31 December 2014: HK\$118.6 million). Working capital represented by net current assets amounted to HK\$266.1 million (31 December 2014: HK\$248.0 million). The Group's current ratio was 9.2 (31 December 2014: 8.1).

Capital Expenditure

For the period under review, the Group incurred a total capital expenditure of HK\$0.4 million (2014: HK\$0.1 million) for the additions of leasehold improvement and office equipment.

b) 證券投資分部

於回顧期間,主要受來自中國大陸 投資者的大量資金所刺激,香港股 市大漲,於二零-五年四月二十八 日,恒生指數升至28,442點,創七 年新高。於二零一五年六月三十日, 恒生指數收市報26,250點(二零一 四年十二月三十一日:23,605點)。 本集團的證券投資收益錄得收益 淨額三千二百三十萬港元(二零一四 年:虧損淨額四十萬港元),來自此 分部之溢利為二千六百一十萬港元 (二零一四年:虧損二百一十萬港 元)。於二零一五年六月三十日,本 集團持有之香港上市股本證券投資 組合之公允值為一億五千五百二十 萬港元(二零一四年十二月三十一 日:一億一千三百七十萬港元)。

流動資金及財務資源

本集團秉持審慎之財務管理方法,得以繼續保持健全之財務狀況。於二零一五年六月三十日,本集團之現金及銀行存款合共為一億一千一百五十萬港元(二零一四年十二月三十一日:一億一千八百六十萬港元)。營運資金(即流動資產淨值)為二億六千六百一十萬港元(二零一四年十二月三十一日:二億四千八百萬港元)。本集團之流動比率為9.2(二零一四年十二月三十一日:8.1)。

資本開支

於回顧期間內,本集團產生之資本開支 總額為四十萬港元(二零一四年:十萬港 元),用作租賃裝修及添置辦公室設備。

Foreign Exchange Exposure

The Group's sales are principally transacted in US dollars and Renminbi. With a factory located in Mainland China and offices in Hong Kong and Mainland China, operating expenses of the Group are primarily denominated in Hong Kong dollars and Renminbi with some expenses also in US dollars. The Group is mainly exposed to US dollar exchange rate risk arising from sales transactions.

The Group will closely monitor fluctuations in the value of the US dollar and, if necessary, will enter into forward exchange contracts to reduce exchange fluctuation risks.

Credit Policy

Consistent with prevailing industry practice, the Group's business was transacted on an open account basis with its long-standing customers. The credit ratings of customers are constantly reviewed and their respective credit limits adjusted, as and when necessary.

Charges on Assets

As at 30 June 2015, the Group had no charges on assets.

Contingent Liabilities

As at 30 June 2015, the Group had no contingent liabilities.

Human Resources and Remuneration Policies

The Group provides a harmonious working environment to employees whose commitment and expertise are critical to the long-term success of its business. The Group offers employees rewarding careers and provides them with a variety of training programmes aimed at enhancing their professionalism. It rewards employees according to prevailing market practices, individual experience and performance. To attract and retain high calibre employees, the Group also offers discretionary bonuses and share options to staff members based on performance of the individual as well as the Group.

As at 30 June 2015, the Group had a total of 940 (31 December 2014: 957) full-time employees in Mainland China and Hong Kong.

Outlook

At the start of second half of 2015, the volatile Mainland China stock markets and Greek rejection of the austerity measures imposed by the European Union had created instability which could adversely affect the continued global economic recovery. Looking ahead, growth in major economies could well follow divergent courses.

For the US market, the Group expects the economy there to recover gradually even if interest rates hikes are raised during 2015. With stronger economic fundamentals than before, the anticipated rise of interest rates should not significantly affect the momentum of the US recovery. Instead, the interest rate hikes would deliver a positive message that US economy is strong enough to wind down the unconventional monetary policy and return to normal.

In Mainland China, the central government had injected liquidity to the economy with an aim to meet the growth target set for 2015. While we have yet to see whether the looser monetary policy will stimulate real economic growth, money had flowed into the stock markets which subsequently experienced significant adjustments starting in mid-June 2015. Drastic administrative measures were immediately taken by the central government to avoid a further stock crash. Such measures are essential to avoid material set backs on structural reforms. Short term market disruption is unavoidable and it will take time to restore market confidence in China's stock market.

While in the Euro zone, the region has shown signs of slow recovery following the European Central Bank's large scale quantitative easing. Though Greece represents less than 2% of the Euro zone GDP, markets are concerned the recent Greek debt crisis will unleash a chain reaction in which other heavily indebted countries such as Portugal, Italy and Spain may initiate similar policies and affect Euro zone unity. Indeed, mutual commitments and trust among Euro zone countries are vital for the region's economic recovery to persist.

As for the securities investment business, the stock market in Hong Kong had been adversely affected by Mainland China's stock markets. The aggressive administrative measures

展望

於二零一五年下半年之始,中國大陸股市波動及希臘拒絕接受歐盟施加的緊縮措施均構成經濟不穩定因素,這可能嚴重影響全球經濟之持續復甦。展望未來,主要經濟體系的增長方向存在分歧。

美國市場方面,即使美國於二零一五年加息,本集團預期當地經濟仍將逐步好轉。鑑於經濟基礎較以往堅實,故預期利率趨升應不會對美國經濟復甦的勢頭造成重大影響。反而,加息將帶出美國經濟強勁而足以減少非常規貨幣政策,令經濟重回正軌的正面訊息。

於中國大陸,中央政府對經濟注入流動性,旨在達致二零一五年設定的增長的有為重要不可以與實際,實際經濟增長的有待觀望,資金已流,隨後導致於二零一五年六月中級時間,以避免股市進過,以避免股市進力的行政措施,以避免股市進軍,以避免股市進工,可避免,同時要恢復對中國股票市場的信心仍需時日。

歐元區方面,隨著歐洲央行進行大規模量化寬鬆,該區經濟出現緩慢復甦跡象。儘管希臘佔歐元區的國內生產總值少於2%,市場仍憂慮近期發生的希臘債務危機將觸發連鎖反應,即其他負債之國家如葡萄牙、意大利和西班牙等也可能採取類似政策,影響歐元區一體化。事實上,歐元區各國間的承諾及信任對該區的經濟持續復甦至關重要。

證券投資業務方面,香港股市深受中國大陸股市不利影響。中國實施進取的行政措施,以及大量中國公司暫停買賣其

executed by China and a sea of Chinese companies halting trading of their shares have aroused the concern of international investors. There were signs of capital withdrawal from Hong Kong listed A-share funds immediately after Mainland China launched harsh and direct intervention in its stock markets. On the other hand, the expected US interest rates hike and any disruption of the unity of countries within the Euro zone could well trigger disturbances in stock markets. Though the current low valuation of the Hong Kong stock market and the expected opening of the Shenzhen-Hong Kong connect could be positive factors for investment opportunities, the Group anticipates pressure on its securities investment result during the second half of 2015 in view of the recent plunge in the Hong Kong stock market.

At the same time we will carefully explore diversification into other potentially lucrative areas. As always, the Group pledges to seek and evaluate every opportunity and will strive to achieve long-term sustainable growth to maximize returns to its shareholders.

NOTES TO THE CONDENSED CONSOLIDATED FINANCIAL INFORMATION

簡明綜合財務資料附註

1. GENERAL INFORMATION

Carry Wealth Holdings Limited (the "Company") and its subsidiaries (collectively the "Group") manufacture and trade garment products and engage in securities investment. The Group has production facilities in Mainland China.

The Company is a limited liability company incorporated in Bermuda. The address of its registered office is Clarendon House, 2 Church Street, Hamilton HM11, Bermuda.

The Company is listed on the main board of The Stock Exchange of Hong Kong Limited (the "Stock Exchange").

This condensed consolidated interim financial information is presented in units of Hong Kong dollars, unless otherwise stated. This condensed consolidated interim financial information was approved for issue by the Board of Directors on 24 August 2015.

This condensed consolidated interim financial information has not been audited.

2. BASIS OF PREPARATION

The unaudited condensed consolidated interim financial information for the six months ended 30 June 2015 has been prepared in accordance with Hong Kong Accounting Standard ("HKAS") 34, 'Interim Financial Reporting' issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"). The unaudited condensed consolidated interim financial information should be read in conjunction with the annual financial statements for the year ended 31 December 2014, which have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRS").

The preparation of condensed consolidated interim financial information requires management to make judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, income and expense. Actual results may differ from these estimates.

In preparing these condensed consolidated interim financial information, the significant judgements made by management in applying the group's accounting policies and the key sources of estimation uncertainty were the same as those that applied to the consolidated financial statements for the year ended 31 December 2014, with the exception of changes in estimates that are required in determining the provision for income taxes.

1. 一般資料

2. 編製基準

截至二零一五年六月三十日止六個月之未經審核簡明綜合中期財務資料已根據香港會計師公會(「香港會計準則」)第34號「中期財務申報」要求而編製。未經審核簡明綜合中期財務資料應與根據香港財務報告準則(「香港財務報告準則」)編製之截至二零一四年十二月三十一日止年度之年度財務報表一併閱覽。

編製簡明綜合中期財務資料需要管理層對 會計政策應用、資產及負債、收入及支出 的列報額有影響的事宜作出判斷、估算及 假設。實際結果可能有別於此等估算。

編製該等簡明綜合中期財務資料時,由管理層對本集團就會計政策的應用及主要不明確數據的估計由來所作出的重要判斷與截至二零一四年十二月三十一日止年度的綜合財務報表所作出的相同,除因需要確定所得稅撥備之估算有變動則例外。

3. ACCOUNTING POLICIES

Except as noted below, the accounting policies applied in the preparation of these condensed consolidated interim financial information are consistent with those used in the preparation of the Group's audited consolidated financial statements for the year ended 31 December 2014.

The following new standards and amendments have been issued and effective for annual periods beginning on January 2015 with no impact on the Group's results of operations and financial positions:

- HKAS 19 (Amendment), 'Employee Benefits'
- Annual Improvements Project, 'Annual Improvements 2010– 2012 Cycle'
- Annual Improvements Project, 'Annual Improvements 2011– 2013 Cycle'

There are no other standards or amendments that are effective for the first time for this interim period that could be expected to have a material impact on this Group.

Taxes on income in the interim periods are accrued using the tax rate that would be applicable to expected total annual profit or loss.

4. FINANCIAL RISK MANAGEMENT AND FINANCIAL INSTRUMENTS

4.1 Financial risk factors

The Group's activities expose it to a variety of financial risks: market risk (including foreign exchange risk, interest rate risk and price risk), credit risk and liquidity risk.

The unaudited condensed consolidated interim financial information does not include all financial risk management information and disclosures required in the annual financial statements, and should be read in conjunction with the Group's annual financial statements for the year ended 31 December 2014.

There have been no changes in the risk management policies of the Group since last year end.

3. 會計政策
