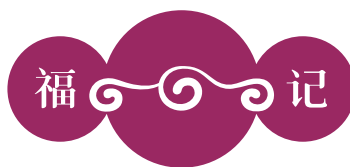

An aggregate of 107,260,000 Placing Shares were allotted and issued to not less than six Placees at the Placing Price of HK\$0.91 per Placing Share pursuant to the terms and conditions of the Placing Agreement.

Reference is made to the announcement of FU JI Food and Catering Services Holdings Limited (the “**Company**”) dated 19 November 2015 (the “**Announcement**”) in relation to, amongst other matters, the placing of new Shares under the General Mandate. Unless otherwise specified, terms used herein shall have the same meanings as defined in the Announcement.

COMPLETION OF PLACING OF NEW SHARES UNDER GENERAL MANDATE

The Board is pleased to announce that all conditions of the Placing Agreement have been fulfilled and the Completion took place on 30 November 2015. An aggregate of 107,260,000 Placing Shares were allotted and issued to not less than six Placees at the Placing Price of HK\$0.91 per Placing Share pursuant to the terms and conditions of the Placing Agreement.

The net proceeds arising from the Placing are approximately HK\$96 million. The net proceeds from the Placing will be used for general working capital of the Group.

The Placing Shares represent approximately 16.67% of the issued share capital of the Company as at the date of this announcement immediately after Completion.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiry, each of the Placees (and their respective ultimate beneficial owners) is not a connected person of the Company and is third party independent of and not connected with the Company and its connected persons or any of their respective associates, and none of the Placees has become a substantial Shareholder (as defined in the Listing Rules) immediately after Completion.
