

2. 用途

證券持有人的個人資料可以任何方式使用、持有、 處理及/或保存,以作以下用途:

- 處理 閣下的申請及退款支票(如適用)、核實 是否符合本申請表格及招股章程載列的條款和 申請程序以及公佈香港公開發售股份的分配結 果;
- 遵守香港及其他地區的適用法律及法規;
