Determination of Offer Price and Allocation of Public Offer Shares

The Offer Price is expected to be fixed on or around Friday, January 8, 2016. Applicants are required to pay the maximum Offer Price of HK\$2.92 for each Public Offer Share together with 1% brokerage, 0.0027% SFC transaction levy and 0.005% Hong Kong Stock Exchange trading fee. If the Offer Price is not agreed between the Company and the Joint Global Coordinators (on behalf of the Underwriters) on or before Wednesday, January 13, 2016, the Global Offering will not proceed.

Applications for Public Offer Shares will not be processed and no allotment of any Public Offer Shares will be made until the application lists close.
