The Board wishes to inform the Shareholders and potential investors that, based on the preliminary assessment of the Group's unaudited management accounts for the year months ended 31 December 2015 and information currently available to the Board, the Group is expected to record a significant increase of not less than 30% in the profit for the year ended 31 December 2015 as compared with profit of RMB300,150,000 for the year ended 31 December 2014.

Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.

This announcement is made by Landsea Green Properties Co., Ltd. (the "**Company**", together with its subsidiaries, the "**Group**") pursuant to Rule 13.09(2) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "**Listing Rules**") and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong) (the "**SFO**").

The board of directors (the "**Director(s)**") of the Company (the "**Board**") wishes to inform the shareholders of the Company (the "**Shareholders**") and potential investors that, based on the preliminary assessment of the Group's unaudited management accounts for the year ended 31 December 2015 and information currently available to the Board, the Group is expected to record a significant increase of not less than 30% in profit for the year ended 31 December 2015 as compared with profit of RMB300,150,000 for the year ended 31 December 2014 due to (i) the increase in fees from providing property development and management service to

independent third parties or partner companies; (ii) the significant increase in properties sales; and (iii) the unrealized exchange gain.

The Company is still in the process of finalising the annual results of the Group for the year ended 31 December 2015. The information contained in this announcement is only based on the preliminary assessment of the Group's unaudited management accounts for the year ended 31 December 2015 and information currently available to the Board, which has not been confirmed nor audited by the Company's auditors, and is subject to finalisation and adjustments where necessary.

The annual results announcement of the Company for the year ended 31 December 2015 is expected to be published in March 2016.
