Reference is made to the announcements of Central Wealth Financial Group Limited (formerly known as China For You Group Company Limited) (the “**Company**”) dated 11 December 2015 and the circular of the Company dated 21 December 2015 (the “**Circular**”) in relation to, among other things, the proposed change of company name. Capitalised terms used herein shall have the same meanings as those defined in the Circular unless otherwise stated.

CHANGE OF COMPANY NAME AND LOGO

The Board is pleased to announce that the English name of the Company has been changed from “China For You Group Company Limited” to “Central Wealth Financial Group Limited” and the Chinese name of the Company has been changed from “中國富佑集團有限公司” to “中達金融集團有限公司”. The Certificate of Incorporation on Change of Name of the Company was issued by the Registrar of Companies in the Cayman Islands on 19 January 2016 and the Certificate of Registration of Alteration of Name of Registered Non-Hong Kong Company was issued by the Registrar of Companies in Hong Kong on 4 February 2016. The logo of the Company has been changed to  .

CHANGE OF STOCK SHORT NAME

The stock short name of Shares for trading on the Stock Exchange will be changed from “CH FOR YOU GP” to “CENT WEALTH FIN” in English and from “中國富佑集團” to “中達金融集團” in Chinese with effect from 9:00 a.m. on 17 February 2016. The stock code of the Company remains as “572”.

The Change of Company Name will not affect the rights of any Shareholders. All existing share certificates of the Company in issue bearing the former name of the Company continue to be valid evidence of legal title to the shares of the Company and will continue to be valid for trading, settlement, registration and delivery purposes. Accordingly, there will not be any arrangement for the free exchange of the existing share certificates for new share certificates bearing the new name of the Company. New share certificates will be issued under the new name of the Company.
