2. You must be a holder of a Hong Kong Identity Card.
3. You can apply for Doctors and Dentist Reserved Shares if you are outside the United States (within the meaning of Regulation S) or are a person described in paragraph (h)(3) of Rule 902 of Regulation S and are not a legal or natural person of the PRC (except qualified domestic institutional investors).
4. You must be an **Eligible Doctor and Dentist** of the Group.
5. You must apply as an individual. Joint applications will not be accepted.
6. Unless permitted by the Listing Rules or pursuant to a waiver granted by the Stock Exchange, you cannot apply for Doctor and Dentist Reserved Shares if:
 - you are an existing beneficial owner of Shares in the Company and/or any of its subsidiaries;
 - you are a Director or chief executive officer of the Company and/or any of its subsidiaries;
 - you are a connected person of the Company, or a person who will become a connected person of the Company immediately upon the completion of the Global Offering;
 - you are an associate of any of the above; or
 - you have been allocated or have applied for any International Offer Shares or otherwise participate in the International Offering.

B. Lodge only one application for your benefit

Multiple applications or suspected multiple applications will be rejected. All of your applications will be rejected as multiple applications if you make more than one application for Doctor and Dentist Reserved Shares.

C. Allocation of Doctor and Dentist Reserved Shares

In order to enable Eligible Doctors and Dentists to participate in the Global Offering on a preferential basis as to allocation only, Eligible Doctors and Dentist are being invited to apply for a maximum of 3,834,000 Doctor and Dentist Reserved Shares, subject to the terms and conditions set out in the Prospectus and this Application Form. The Doctor and Dentist Reserved Shares are being offered out of the International Offering but are not subject to the clawback mechanism as set out in the section headed "Structure of the Global Offering — The Hong Kong Public Offering — Reallocation and Clawback" in the Prospectus. The Doctors and

Dentist Reserved Shares are available for subscription by the Eligible Doctors and Dentists on a preferential basis.

The 3,834,000 Doctor and Dentist Reserved Shares available for application by Eligible Doctors and Dentists on **BLUE** Application Form will be allocated to such applicants on a basis to be determined by the Hong Kong Branch Share Registrar based on the level of valid applications received under the Doctor and Dentist Preferential Offering and the number of Doctor and Dentist Reserved Shares validly applied for within each application tier. The allocation basis will be consistent with the allocation basis commonly used in the case of over subscriptions in public offerings in Hong Kong, where a higher allocation percentage will be applied in respect of smaller applications.
