The data used in the report were originally included in the Company's annual reports, official documents and statistical reports, which were mainly prepared in 2015, and some data were collected in previous years. The currency involved in this report takes RMB as accounting currency, unless it is otherwise specified.

Basis for Compilation of the Report

The Report was prepared in accordance with the SEHK Environmental, Social and Governance Reporting Guide, Sustainable Development Reporting Guidelines (G4) of the Global Reporting Initiative (GRI) and other relevant supplementary guidelines and standards. DZCSR30000 China CSR Standard System is also the main reference for the compilation of this Report. We have identified the substantive issues and disclose them in the Report according to Environmental, Social and Governance Reporting Guidelines, and provided the information about key performance indicators specified by G4 guidelines, in order to enhance transparency and accountability.

董事局主席致辭

2015年, 在黨和政府的領導和努力下,我國政治、經濟、社 會、環境均呈現出了積極的態勢, 爲"十二五"畫上一個完美的休 止符,也爲"十三五"的到來奏響了新的樂章。在這"十二五"的 收官之年中,黨和政府提出了"創新、協調、緑色、開放、共享" 的五大發展新理念, 爲企業開辟了社會責任和可持續發展的新航 道。在這場發展新思潮的洗禮中,天能一如既往地扛起社會責任的 大旗,勇往直前,如沐春風。

這一年,我們堅持責任引領,公司上下同心同力,以艱苦創業 的拼搏精神,以堅定不移的决心和毅力推動企業責任發展,在挑戰 和機遇中變革轉型、逆勢增長。2015年天能實現營業收入178億元, 净利潤6.28億元,同比增長314%,實現納税額6.2億元,爲地方經濟 發展創造了更多機會。榮獲國家循環經濟標準化試點企業、國家資 源綜合利用企業、國家知識產權優勢企業、國家首批產品生態設計 試點企業、全國電子信息行業領軍企業、輕工聯科技進步一等獎, 浙江省技術進步二等獎、專利示範企業等多項殊榮,《天能EHS一 體化管理體系的構建和應用》獲得了2014年度全國企業管理現代化 創新成果一等獎,新增國家重點扶持高新企業2家(累計8家),經 濟效益、社會效益、生態效益持續保持行業領先,爲實現二次騰飛 天能夢奠定了堅實基礎。

這一年,我們不斷提升公司責任治理和管理水平,推動企業社 會責任與企業發展戰略和經營業務的融合,以股東價值最大化爲目 標,努力實現電動車電池產業鏈的轉型升級。9月,天能動力(HK 00819)被納入"恒生可持續發展企業基準指數"(HSSUSB)成份 股,成爲國內唯一一家入選的動力電池企業。11月25日,天能動力 股價最高達7.42港元/股,創下歷史新高。

這一年,我們繼續發展緑色經濟,牽頭組織浙江省鉛蓄電池清 潔化循環回收再生體系建設,進一步擴大天能循環經濟產業園的發 展規模,努力打造國家鉛酸蓄電池回收產業循環經濟、清潔生產的

示範基地,被國家發改委評爲國家循環經濟標準化 試點企業。

這一年,我們責任品牌戰略成效顯著,通過李 晨形象代言、高鐵廣告投放、《鄉約》欄目贊助、 終端門頭廣告更新、渠道推廣活動以及新媒體宣傳 等方式,重塑天能能量無限、堅韧不摧、熱心社 會、創新進取、倡導環保的企業公民形象,使天能 的企業社會責任理念深入人心,提升了天能責任品 牌的知名度、美譽度和影響力。

2016年,天能將迎來釋煌30周年華誕,面對 新的形勢、新的任務、新的挑戰、新的責任,天能 將樹立起"大責任"觀,矢志不移地走企業社會責 任和可持續發展道路。我們將以"責任爲魂,創新 共赢" 爲核心價值觀,以 "绿色能源,驅動世界" 爲企業使命,以 "全球新能源行業引領者與規則制 定者"的企業定位,堅持創新發展、協調發展、緑 色發展、開放發展、共享發展,矢志成爲全球領先 的绿色能源方案解决商,引領行業走向综合價值最 大化的可持續發展之路。



SPEECH BY CHAIRMAN OF THE BOARD OF DIRECTORS

In 2015, under the leadership of the Party and government, China's politics, economy, society and environment demonstrated a strong development momentum, drawing a perfect conclusion to the 12th Five-Year Plan and turning a new chapter for the13th Five-Year Plan. In the last year of the 12th Five-Year Plan, the Party and the government put forward the new philosophy of achieving "innovative, coordinated, green, open and sharing" development, and expanded new channel for enterprises to implement corporate social responsibility and achieve sustainable development. In the tide of new development ideas, Tianneng continued to uphold the banner of social responsibility, and marched forward courageously. Over the past year, we adhered to the responsibility system, united all efforts in the company, adopted hardworking spirit, strong perseverance and great determination to promote the development of corporate responsibility, transformed company structure and achieved contrarian growth when encountering challenges and opportunities. In 2015, Tianneng's reverue reached 17.8 billion yuan, net profits reached nearly 0.63 billion yuan, with an increase of 314%, the Company paid tax of 0.62 billion yuan, and created more opportunities for local economic development. The Company many honors and awards, such as the National Circular Economy Standardization Pilot Enterprise, Model Enterprise for Comprehensive

Utilization of National Resources, National Enterprise with Intellectual Property Advantage, One of the First Industrial Product Eco-design Pilot Enterprises in China, Leading Enterprise in China's Electronic Information Industry, First Prize for Science and Technology Progress of Light Industry Union, Second Prize for Technology Progress of Zhejiang Province, Patent Model Enterprise; the Construction and Application of Tianneng EHS Integrated Management System won the First Prize of National Enterprise Management Modernization Innovation Achievement in 2014, became key national supporting high-tech enterprises (a total of 8 enterprises), the company's economic benefits, social benefits and ecological benefits maintained a leading position in the industry, and laid a solid foundation for the fulfillment of Tianneng Dream.

Over the past year, we constantly enhanced corporate responsibility governance and management level, promoted the integration of corporate social responsibility, corporate strategy and business development, strived hard to maximize shareholder value, and made efforts to achieve the transformation and upgrading of electric vehicle battery industry chain. In September, Tianneng Power (HK 00819) became a constituent company of the Hang Seng Corporate Sustainability Benchmark Index (HSSUSB), and became the sole battery enterprise in the list. On November 25, the stock price of Tianneng Power reached 7.42 HKD per share, creating a historic high record.

Over the past year, we constantly develop green economy, played a leading role in establishing Zhejiang Lead-acid Battery Clean Recycling System, further expanded the development scale of Tianneng Circular Economy Industrial Park, strived hard to build a national demonstration base for recycling economy and clean production in lead-acid battery recycling industry, and was awarded with National Circular Economy Standardization Pilot Enterprise by National Development and Reform Commission.

Over the past year, we made remarkable achievements in implementing responsible brand strategy. By inviting Li Chen to endorse our products, putting advertisements on high-speed railways, sponsoring Village Blind-Date program, updating the advertisement on terminals, carrying out promotional activities and adopting new media publicity, we shaped Tianneng's public image, which is durable, benevolent, innovative and eco-friendly, with infnite energy, so that the concept of Tianneng's corporate social responsibility will penetrate deeply into the minds of people, thereby enhancing visibility, reputation and influence of Tianneng responsible brand.

In 2016, we will celebrate the glorious 30th anniversary of Tianneng's founding. Facing with new situation, new tasks, new challenges and new responsibilities, Tianneng will establish the "big responsibility" concept, and uncompromisingly adhere to the road of corporate social responsibility and sustainable development. Taking "responsibility, innovation and win-win situation" as core values, taking "green energy and driving the world" as enterprise mission, and starting from the position as "the leader and rule maker in global new energy industry*, we will adhere to innovative development, coordinated development, green development, open development and shared development, strive to be the world's leading green energy solution provider, and lead the industry to achieve the sustainable development that maximizes the comprehensive values.

天能成立于1986年,地處長三角腹地——"中 國緑色動力能源中心"浙江長興,經過近三十年的 發展壯大,已發展成爲以電動車環保動力電池制造 爲主,集鋰離子電池,風能、太陽能儲能電池以及 再生鉛資源回收、循環利用等新能源的研發、生 産、銷售爲一體的實業集團,是中國最大電動車動 力電池供應商。2007年6月11日, 天能動力在香港 主板成功上市(00819.HK)。公司現已擁有浙、 蘇、皖、豫四省八大生産基地、20家全資子公司、 1家控股公司、3家境外公司、近2萬名員工,總資 産超100億元,綜合實力位居世界環保與新能源產 業中國影響力企業100强、全球新能源企業500强、 中國企業500强、中國制造業企業100强、中國民營 企業500强、中國電池工業10强,是國内唯一入選 "恒生可持續發展企業基準指數"(HSSUSB)成 份股的動力電池企業。2015年,公司銷售收入突破 178億。

Founded in 1986, Tianneng is located in Changxing, Zhejiang, which is "China Green Power Energy Center in the hinterland of the Yangtze River Delta. With nearly 30 years of development, the group has developed into a high-tech new energy enterprise that integrates the business of electric vehicle power battery, wind and solar energy storage batteries and recycling of renewable resources. On June 11, 2007, Tianneng Power was successfully listed on the Main Board of Hong Kong Stock Exchange (00819.HK). The Company now has eight production bases in Zhejiang, Jiangsu, Anhui and Henan provinces, 20 wholly-owned subsidiaries, 1 holding company, 3 overseas subsidiaries and near 20,000 employees, its total assets is about 10 billion yuan. With strong comprehensive strength, the Company is on the lists of Global Top 500 New Energy Enterprises, China Top 500 Enterprises, China Top 100 Manufacturing Enterprises, China Top 500 Private Enterprises, Top 10 Enterprises in China's Battery Industry, China Top 100 Enterprise for Influence on World Environmental Protection and New Energy Industry, and it is the sole power battery enterprise that is chosen as constituent company of the Hang Seng Corporate Sustainability Benchmark Index (HSSUSB). In 2015, the Company sales revenue exceeded 17.8 billion yuan.

在國内,天能建有近2000家獨家分銷 商,形成了經營實力雄厚、穩定扎實的營銷 合作伙伴網絡。2015年天能對國內市場渠 道精耕細作,核心市場網絡扁平化,渠道進 一步下沉。非核心市場通過加大網絡拓展力 度,市場覆蓋率進一步提升,目前全國市場 已經達到省市縣區全覆蓋,核心市場更是滲 透到鄉村市場。

The Company made more efforts to expand sales network in non-core market, and further increased market coverage. Currently our products have covered provincial, city-level and county-level markets in non-core areas, and even covered rural markets in core areas.

Entered the international market by adopting many methods such as supplementary export and selfemployed export, its business has penetrated into Europe. the Middle East, Southeast Asia, America and other markets, and laid a good foundation for the international development of Tianneng.

As the leading brand of China's power battery industry, Tianneng started from the position as "the leader and rule maker in global new energy industry", looked at new energy market from a high plane, founded the wholly owned subsidiary --Zhejiang Tianneng Energy Technology Co., Ltd. in 2004, focused on the R&D, production and sales of li-ion battery and other high-performance products, and made gratifying achievements. In addition, Tianneng actively made preparations for the listing of lithium battery business in new NEEQ, in order to achieve bigger, stronger and excellent lithium business, enhance the shareholder value of Tianneng Power, and increase its financing ability and brand influence in capital market. Tianneng clearly has sent a strong signal, and fully accelerated the development of lithium battery for new energy automobile.

Creating lithium battery smart database, strengthening research and innovation strength

Tianneng strives hard to build lithium battery smart database, and uses strong R&D capability to stimulate the innovation of lithium battery. In 2015, Tianneng accelerated the "one steady and three fast' development strategy, strengthened organizational reform and personnel adjustment, proposed the concept of "introducing global talents", and introduced the academician of China Academy of Engineering Guo Konghui, the academician of Chinese Academy of Sciences Chen Hongyuan, the professor and academician of International Academy of Sciences for Europe and Asia (IASEA) Wu Feng and other world-class experts to establish the R&D team of lithium battery industry chain, in order to grasp the four core technologies, which are lithium battery materials, electric core, PACK, management system. Currently, the Company has mastered the mainstream lithium battery technologies, such as lithium iron phosphate, ternary materials and graphene manganese-based lithium, and owned some core technologies and patents, including lithium battery materials, electric core, PACK, lithium battery management system, our products have passed TS16949, BATSO, CB, CE, ROHS, REACH, UL, UN38.3, MSDS and many other international certifications.

Tianneng lithium battery is characterized by high capacity, high specific energy, high safety factor, good consistency and long cycle life. With many performance indicators reaching domestic leading level and international advanced level, Tianneng lithium battery has been awarded Excellence Award for Electric Vehicle Technology by Electric Car Branch, Society of Automotive Engineers of China for two consecutive years, was awarded the Best Brand Award for China's New Energy Battery by FROST & SULLIVAN for four consecutive years, and won the title of China's Power Battery Leading Brand by Ipsos for three consecutive years.

Using strong economic base to support and actively expand the production capacity of lithium battery

Since its establishment, Tianneng has constantly made entrepreneurial innovation and expanded business. With huge development opportunities in Chinese electric car industry, Tianneng's sales revenue was increased from 0.52 billion yuan in 2005 to 17.8 billion yuan in 2015. representing rapid achievements over the past 10 years, and the annual compound growth rate of its sales revenue reached 42%. Under the support of such a strong economy, Tianneng actively expanded lithium battery production capacity, substantially increased the proportion of batteries for new energy automobile and other new businesses, and achieved good results in industrial upgrading and transformation. In October 2014, Tianneng added lithium battery automatic production line, and increased the production capacity of Tianneng lithium battery to 1.25GWH, ranking the sixth in China. In 2015, Tianneng started Phase III production capacity expansion, the lithium battery production capacity will increase by 80% and reach 2.25GWH after it is put into operation.

Strengthening lithium battery business layout and vigorously developing new energy market

Committed to becoming the "world's leading green energy solution provider", Tianneng constantly expands lithium battery business layout, and vigorously develops new energy market. Currently, it has begun to provide batches of lithium batteries for BAIC, Zotye, Lifan, KNDI, Chery, Hurlly and other new energy automobile enterprises. In 2015, the sales of revenue of Tianneng lithium battery products reached nearly 0.56 billion yuan, accounting for 3% of its total revenue, with increase of 208%. The adjustment of business layout and development of emerging businesses contributes to the rapid growth of Tianneng's sales revenue. In the future, the proportion of Tianneng lithium battery for new energy automobile, miniature battery, car battery and other new businesses will reach 80%.

Making use of the advantages of circular economy, exploring new road for the green development of lithium battery

With the wide application of lithium battery, more waste lithium batteries will be produced in the future, this will not only cause huge waste of resources, but also exert adverse effect on the environment.

Tianneng will take "responsibility, innovation and win-win situation" as core values, continue to take "green energy and driving the world" as enterprise mission, be committed to becoming the world's leading green energy solution provider, lead the development of recycling economy in national battery industry, give full play to professional advantages, actively explore the best method to recycle waste lithium batteries, and make greater contribution to the sustainable development of new energy electric car industry.

天能動力

2015年,公司爲深入貫徹"十三五"戰略規 劃,加快發展新能源汽車動力電池,大幅優化改組 董事會,增補公司主管新能源汽車電池的周建中先 生爲執行董事,中國電動汽車百人會發起人、中國 工程院院士郭孔輝先生以及世界鋰電池專家、國際 歐亞科學院院士吴鋒教授爲獨立董事,顯示了公司 大舉拓展新能源汽車動力電池產業鏈的堅定决心。

科學的管理决策

公司注重科學有效的管理模式,重大經營決策 均通過董事會決議。當年共召開九次董事會,主要 審議公司經營情况、資本投資方案、子公司分拆上 市、更换董事、回購股票、行權等事宜,會上通過 相關決議。

加强風險管理

本着對股東負責任的態度,天能建立起嚴格的 風險管理制度,規範組織管理,不斷强化風險管 理。公司設立審核委員會,負責審閱公司財務資 料,以及監管公司財務申報制度、風險管理和内部 監控系統等工作,并且每年會同外聘獨立第三方檢 討上市公司及其附屬公司的風險管理及内部監控系 統是否有效。

2015年召開了兩次審核委員會會議,就公司 財務管理、風險管理及内部監控等議題進行了有益 探討。12月31日按照香港聯合交易所有限公司的證 券上市規則有關風險管理及内部監控部分的修訂内 容,對審核委員會的職責範圍進行了修訂,進一步 完善了公司的風險管理制度和功能。

Optimizing and Restructuring the Board of Directors

In 2015, the Company significantly optimized and reorganized the Board of Directors, selected Mr. Zhou Jianzhong, who was in charge of the Company's batteries for new energy automobile, as the Executive Director, and invited the sponsor of China EV100 and academician of China Academy of Engineering Mr. Guo Konghui, world lithium battery expert and academician of International Academy of Professor Sciences for Europe and Asia (IASEA) Wu Feng as independent Directors, in order to thoroughly implement the strategic 13th Five-Year Plan, accelerate the development of new energy automobile power battery, and demonstrate the company's firm determination in vigorously developing new energy automobile power battery industry chain.

Scientific Management Decision-making

The Company emphasizes scientific and effective management, all major business decisions should be adopted according to the resolutions of the Board of Directors. A total of 9 meetings of the Board of Directors were held in 2015, in order to discuss the Company's business operation situation, capital investment program, separation of subsidiary company for listing, replacement of directors, stock repurchase, exercise and other issues, the meetings adopted relevant resolutions.

Strengthening Risk Management

Taking a responsible attitude to the shareholders, Tianneng has established strict risk management system, standardized organization and management, and constantly strengthened risk management. The Company has set up an audit committee, which is mainly established to review the Company's financial documents, supervise the Company's financial documents, supervise the Company's financial and cooperates with external independent third party to review and inspect whether the risk management and internal supervision systems of the listed Company and its subsidiary companies are effective each year.

In 2015, the Company convened two meetings of audit committee, and carried out useful discussion on the Company's financial management, risk management and internal control issues. On December 31, the Company modified the responsibility scope of amendments related to risk management and internal control section, the terms of the Audit Committee according to the revised contents about risk management and internal control specified in the Rules Governing the Listing of Securities of the Stock Exchange of Hong Kong Ltd., and further improved the Company's risk management system and functions.

The Development Model of Circular Economy

Since 2009 when we started to be engaged in waste lead-acid battery recycling business, we have constantly innovated and optimized the development model of circular economy, and strived hard to become a national demonstration base for recycling economy and clean production in lead-acid battery recycling industry. Facing with the severe stress from economic "new normal" and industrial situation in 2015, Tianneng Group Circular Economy Industrial Park first implemented self- management system, further tapped the internal potential, mobilized the production enthusiasm of employees, clarified the responsibilities of employees at all levels, and achieved the purpose of *reducing costs and increasing efficiency*. In 2015, Tianneng circular economy model generated sales revenue of about 1.25 billion yuan for the Company; now its annual waste battery processing capacity is 250,000 tons, including Zhejiang Wushan Base's capacity of 150,000 tons, and Henan Puyang Base's capacity of 100,000 tons; the cleaning and energy-saving production level of regenerated lead industry was further improved, regenerated lead industrial technologies have been promoted and expanded in a greater scope.

安全生產是天能可持續發展的前提和基礎, 我 們始終堅持"安全第一、預防爲主、綜合治理"的 安全生產管理方針, 深入開展安全生產標準化管理 工作, 以隱患排查治理爲基礎, 提高安全生產水 平, 减少事故發生, 保障人身安全健康, 深入貫徹 黨的十八屆五中全會精神, 始終保持憂患意識, 全 面落實安全生產管理主體責任, 共同努力推進依法 治安, 營造學法、知法、用法、守法的濃厚氛圍。 在蒙多安全機制的保障下, 2015年天能無重大安全 事件的發生。

健全安全生産管理體系

我們按國家相關規定完善及修訂了《環保安防 管理制度》,認真執行和貫徹八大安全生產管理體 系(分别是:組織保障體系、安全責任體系、管理 制度體系、技術標準體系、檢查監督體系、培訓教 育體系、安全應急管理體系、安全投入體系)。建 立起安全生產責任制,對重點消防區域進行責任分 工、責任到人。

開展安全生産月活動

根據國家、省、市關于開展2015年"安全生產 月"活動的部署安排,積極宣傳并發動各基地、子 公司進行第十四個"全國安全生產月"活動,緊緊 圍繞2015年"加强安全法制,保障安全生產"的活 動月主題,認真普及安全法律法規和安全知識,進 一步提高了廣大員工的安全生產意識,樹立起天能 良好的社會風貌。

Production safety is the premise and foundation of Tianneng's sustainable development, we always adhere to the production safety management policy, which is "safety comes first, prevention is the core, comprehensive management", carry out in-depth safety standardization management, take hazards removal and management as basis, improve safety production level, reduce accidents, protect the personal safety and health, thoroughly implement the spirit of China's 18th Central Committee, always maintain the sense of urgency, fully implement the main responsibility of production safety management, work together to promote security according to laws, and create a law-oriented, lawabiding atmosphere. Under the protection of many safety mechanisms, Tianneng had no significant safety incident in 2015.

Improving Production Safety Management System

We have improved and modified the Environmental Safety Management System according to relevant national regulations, earnestly implemented eight production safety system, safety responsibility system, management system, technical standards system, inspection and supervision system, training and education system, safety emergency management system, safe investment system), and established the responsibility system for production safety, and divided the labors and responsibilities of key fire protection areas.

Carrying out Production Safety Month Activity

According to national, provincial and municipal deployment and arrangements on carrying out "Production Safety Month" activity in 2015, the Company actively promoted and mobilized production bases and subsidiaries to carry out the fourteenth "National Production Safety Month" activity, closely focused on the theme of "strengthening safety law, ensuring production safety" in 2015, carefully publicized safety laws and regulations, and safety knowledge, further improved the safety awareness of employees, and established a good social image of Tianneng.

强化安全知識宣貫

不斷建立健全安全、職業衛生宣傳教育培訓制 度,加强三級安全培訓教育,重點崗位的培訓教 育,特種作業人員必須持證上崗。

充分利用報紙、網絡、宣傳欄等各類媒體進行 宣傳, 以强大的輿論氛圍和宣傳聲勢, 營造良好的 安全生產法制氛圍。6月舉行了集安全生產法規知識 宣傳、四不傷害注解、安全生產示範崗展示和歷年 事故案例分析爲一體的 "安全警示"巡回展, 以進 一步教育全體職工把安全生產工作入心入腦, 認真 執行規章制度, 嚴格按照規程作業, 敢于制止達章 行爲, 時時刻刻把安全生產 "警鐘長鳴", 切實把 安全生產工作融入到崗位和家庭之中。



Implementing Safety Emergency Drills

The Company established fire rescue team, and asked fire rescue team to carry out fire extinguishing process on the scene to; organized bases and subsidiaries to carry out emergency drills, enhanced employees' awareness of reporting hazards immediately, inspected the coordination and rapid response capability of the Company's fire rescue team, enabled fire rescue personnel to get familiar with fire-fighting procedures and the use of fire-fighting equipment, and ensure "early prevention, timely detection, rapid response and proper handling" for electrical fire.

Publicizing and Strengthening Safety Knowledge The Company constantly establishes and improves

safety, occupational health education and training system, strengthens three-level safety training and education, focuses on job training and education, and forces special operation personnel to obtain certificate before taking the job.

We make full use of newspapers, Internet, billboards and other media to carry out publicity, use strong atmosphere of public opinions and publicity momentum to create a good legal atmosphere of production safety. In June 2015, the Company held a "safety warning" tour exhibition that integrates publicity of production safety regulations, explanations to four no-harms, display of production safety demonstration position, and case study of accidents occurred in previous years, further educated all employees to bring work safety into their mind, conscientiously implement regulations, strictly operate according to specifications, bravely stop the illegal behaviors, always pay attention to safety production, and effectively integrate production safety work with specific positions and families.

環境保護 ENVIRONMENTAL PROTECTION

我們一貫堅持企業與環境的和諧發 展,在管理實踐中,開創性地構建了行 之有效的EHS一體化管理體系,逐級分 解EHS目標,促使生產模式從粗放型向 集約型轉化,發展循環經濟,踐行生態 文明的綠色發展。

天能嚴格按照環境保護的要求及行 業準入條件的標準,制定環保計劃,提 升工藝技術、現場管理,加强内部檢測 隊伍、能力的建設,開展内外部培訓, 提升公司整體環保管理水平。截至 2015年底,各子公司(除新建項目以 外)均通過ISO14000認證,其中部分體 系認證時間到期企業已完成新一輪評 價,并通過ISO14000認證;按要求每年 均編制年度環境報告書,完成環境信息 披露。 We always adhere to harmonious development of corporate and environment. In management practice, we creatively build effective EHS Integrated Management System, gradually break down EHS goals, promote the transition from extensive production model to intensive production model, develop recycling economy, and implement the green development of ecological civilization.

Strictly in accordance with the requirements of environmental protection standards and industry access conditions, Tianneng develops environmental programs, upgrades processing technology and on-site management, strengthens internal inspection team and capacity construction, carries out internal and external trainings, and enhances the company's overall environmental management level. By the end of 2015, its subsidiaries (excluding new projects) passed the ISO14000 certification, some certification expired, then the company completed a new round of evaluation, and passed ISO14000 certification; the Company compiled Annual Environmental Report according to the requirements each year, and completed environment information disclosure.

截至2015年底,各子公司(除新建項目以外) 均達到清潔生產水平二級標準并通過清潔生產驗 收。各子公司生產過程中產生的含鉛廢氣、廢水均 符合《電池工業污染物排放標準》(GB30484-2013)中的各項要求;產生的固廢均按照《中華人 民共和國固體廢物污染環境防治法》、《危險廢物 收集、貯存、運輸技術規範》進行收集、貯存和運 輸;廠界嗓聲均符合《工業企業廠界環境噪聲排放 標準》(GB 12348-2008)。

近年來天能投入大量資金進行廢氣、廢水和廢 料處理裝置升級、更换,引入先進的處理工藝和净 化裝置,提高處理效率及回收利用率。

Clean Production

We persist on clean production, continue to build green, eco-friendly production environment. Based on the industry access conditions, the subsidiaries upgrade processing technologies and equipment, and reduce pollutants by source control, process management and end treatment. In addition, the Company adopts advanced processing technology and environmental protection facilities to ensure standard discharge of pollutants. The Ministry of Industry and Information Technology announced (the first batch) 39 enterprises that meet the requirements of Lead-acid Battery Industry Standards (2015 version), including 6 subsidiaries of Tianneng.

By the end of 2015, the subsidiaries (excluding new projects) reached second level of clean production, and passed the acceptance inspection of clean production. The leaded gas and wastewater generated in the production process of subsidiaries meet with the requirements of "Battery Industry Pollutant Emission Standards" (GB30484-2013); the solid wastes shall be collected, stored and transported according to the requirements of the Law of the People's Republic of China on the Prevention and Control of Environmental Pollution by Solid Waste, and the Technical Specifications For The Collection, Storage and Transportation of Hazardous Wastes; factory noises meet the requirements of Standards on Emission of Environmental Noise in Industrial Enterprises (GB 12348-2008).

In recent years, Tianneng has invested heavily in upgrading and replacing waste gas, waste water and waste material treatment equipment, introduced advanced processing technologies and purification devices, and improved the processing efficiency and recycling rate.

節能降耗

回收利用

廢舊電池回收:我們是浙江省唯一具有鉛蓄電 池回收處理資質的生產企業,擁有代表國內外最先 進水平的廢鉛蓄電池回收處理的全自動智能化生產 綫。2015年,我們回收廢舊鉛酸蓄電池15萬噸,再 生鉛金屬10萬噸,實現銷售收入12.53億元。

固廢回收:將在生產過程中收集的鉛粉和產生 的含鉛固廢作爲危險固廢送至簽訂協議的鉛回收企 業重新冶煉利用。

廢水回收: 對廢水進行分類收集,分質處理, 盡可能使產生的廢水能够回收利用。目前公司采用 國內外先進的深度中水回用系統,使污水的回用率 達70%。

電能回收:進行了充電機的技術升級,采用母 綫反饋式充放電機,對放電過程的電能進行回收重 復利用。

廢酸液回收:購置相應的廢酸液提升裝置,對 收集的一定純度的廢酸液進行提純處理, 達到技術 要求後作爲電解液加注進行回用。

緑色辮公

我們開發了各種辦公管理系統,不僅節約了人 力,也使無紙化辦公成爲可能;出臺雙面打印、隨 手關電、限制紙杯等的環保措施,督促員工節約資 源,減少浪費;積極宣貫環保理念,不定期舉辦環 保活動,鼓勵員工將緑色節約的理念融入生活,形 成習慣。

Saving Energy and Reducing Consumption

We vigorously develop circular economy, advocate green office, and strive to be international eco-friendly, resource-saving new energy enterprise.

Recycling

Waste Battery Recycling: We are the only qualified manufacturing enterprise engaged in waste lead-acid battery recycling in Zhejiang province, and have the most advanced intelligent automatic production line of waste lead-acid battery recycling in the world. In 2015, we recycled 15 tons of waste lead-acid battery, regenerated 100,000 tons of lead metal, and achieved sales income of about 1.25 billion yuan.

Solid Waste Recycling: The lead powder collected in the production process and lead-contained solid wastes are treated as hazardous solid wastes and sent to the lead recycling enterprise specified by the agreement for smelting and re-utilization.

Wastewater Recycling: Wastewater was collected and divided according to quality, so as to enable wastewater to be recycled. Currently the Company adopts internationally advanced deep water recycling system, enabling the wastewater reuse rate to reach 70%.

Energy Recycling: Battery charger is technically upgraded, bus feedback charger motor is adopted to recycle and reuse the electrical energy in the discharging process.

Waste Acid Recycling: Corresponding waste acid lifting device is purchase, the collected waste acids are extracted and purified, and be reused as electrolyte after reaching technical requirements.

Green Office

We have developed various office management systems, not only saved manpower, but also made paperless office possible; introduced many environmental protection measures, such as doublesided printing, reducing electricity consumption, restricting the use of paper cups, urging employees to save resources and reduce wastes; actively publicized the idea of environmental protection, organized environmental protection activities from time to time, and encouraged employees to integrate green ideas into life and form good habits.

嚴格遵守《勞動合同法》與員工簽訂勞動合 同,2015年員工勞動合同簽約率達100%;依法爲員 工繳納基本養老保險、基本醫療保險、失業保險、 工傷保險和生育保險等,2015年員工社會保險覆蓋 率達100%。

制定了完善的薪酬福利和績效管理制度,對員 工進行有效激勵。同時,堅持同工同酬,公平對待 員工。2015年天能薪酬總額11.59億元,人均薪酬達 6.39萬元,比2014年增長12.8%;完成了員工第二 批期權全部行權及第三批期權的第一次行權,實現 員工收益1.2億港元。 We adhere to the principle of equal employment, respect and fairly treat employees from different backgrounds, have no gender or racial discrimination, and create an inclusive win-win work environment. We respect and uphold international labor conventions and labor standards, and strictly prohibit any employment of child labor.

We strict abide by the Labor Contract Law and sign labor contract with employee. In 2005, the signing rate of employee labor contracts reached 100%; the Company paid basic pension insurance, basic medical insurance, unemployment insurance, industrial injury insurance and maternity insurance for employees according to the law. The employee social insurance coverage reached 100% in 2015.

We have developed comprehensive salary, welfare and performance management system to provide effective incentives for employees. Meanwhile, we insist on equal payment and fair treatment of employees. In 2015, the total salares of employees in Tianneng reached 1.16 billion yuan, per capita salary reached 63.9 thousand yuan, with an increase of 12.8% compared with 2014. The Company completed the second batch of staff options, the first exercise of third batch of options, and employees' benefits reached to 120 million HK \$.

職業健康 OCCUPATIONAL HEALTH

爲防範職業病,天能爲所有員工建立健康檔 案,并每年提供一次員工體檢活動。從制度上,建 立了完善的職業健康安全管理體系,并通過 OHSAS18000體系認證;從過程上,爲每一位車間 員工配備了高品質的工作服、防護口罩及手套等一 流的職業衛生防護設備,各車間也配備了必要的應 急處理藥品;從預防上,通過對員工的定期職業健 康培訓,舉辦相關活動,提升員工自身的職業危害 自我保護能力。

2015年天能勞保成本1544萬元;共開展職業健 康相關培訓150餘次,參與員工2.5萬人次。當年無 工傷、職業病等事故發生。 In order to preven: occupational diseases, Tianneng establishes health records for all employees and provide employees with physical examination every year. Institutionally, we have established a comprehensive occupational health and safety management system, which passed OHSAS18000 certification; in terms of process, we provide all the employees in the workshops with high-quality work clothing, protective masks and gloves, and other occupational health protective equipment; each workshop is also equipped with necessary emergency medicines. From the perspective of prevention, we carry out regular occupational health trainings for employees, and organize relevant activities to enhance employees ability to protect themselves against occupational hazards.

In 2015, Tianneng spent labor costs of 15.44 million yuar; carried out a total of 150 occupational healthrelated trainings, 25000 employees participated in the trainings. There was no injury, occupational diseases or other incident in 2015.

In the employee satisfaction survey carried out in December 2015, the staff satisfaction on the hard environment of Tianneng Circular Economy Industrial Park reached 93.88%.

In terms of soft environment, we take trade union as the main carrier to implement democratic management, regularly organize employee activities, promote the exchanges, learning and growth between employees, make employees cheerful, mobilize the atmosphere, stimulate employee creativity, and create a cheerful, harmonious and happy community atmosphere of Tianneng.

The growth of employee is a key element to ensure the continuous development of Tianneng, and will provide momentum for Tianneng's sustainable development. In view of this, we spare no effort to create training opportunities for employees, expand promotion channels, and promote the common development of the Company and employees.

In 2015, we strengthened the cultivation of leadership, and the core ability of business professionals and employees, implement staff rotation system and AB post system, and further enhanced the team's comprehensive quality and ability. In May, Anhui College of Tianneng University was founded; in July, Jiangsu College was founded, Tianneng University has becomes an important booster for the management center to build a learning-oriented enterprise and create a learningoriented team. In 2015, the training budget of Tianneng University was 13 million yuan, trained 28,000 people, the per capita hours was 20 hours, there were a total of 360,000 learning hours, with increase of 18%, 56%, 33% and 38% compared with 2014; the Company introduced mobile learning, organized, designed and solved 22 practical work topics.
