ANNOUNCEMENT

This announcement is made by China Metal International Holdings Inc. (the “**Company**”) pursuant to Rule 13.09(1) of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The Board of Directors of the Company announces that China Metal Products Company Limited (“**CMP**”), a company listed and incorporated in Taiwan and the ultimate controlling shareholder of the Company, is required to release certain information regarding its investments made through its subsidiaries to the Taiwan market pursuant to applicable laws and regulations of Taiwan (including those of the Taiwan Stock Exchange). The Company has been informed by CMP that the information it proposes to release (the “**Relevant Information**”) includes the unaudited profit / (loss) of the Company and certain of its subsidiaries for the three months ended 31 March 2016. The Company has been further informed that the Relevant Information will be released by CMP on 16 May 2016.

The Relevant Information to be disclosed by CMP has not been audited and is prepared by CMP in accordance with Generally Accepted Accounting Principles in Taiwan, which is different from the accounting standards adopted by the Company and has not been verified by the Company. Investors and shareholders of the Company are advised to exercise caution when dealing in the shares of the Company.
