On 12 January 2015, the board of directors of the Company, upon recommendation of the remuneration committee of the Company, resolved to grant (the “Grant”) the awarded shares (the “Award Shares”) pursuant to the performance share scheme to (i) Mr Sun Jinguo (“Mr Sun) and Mr Li Jun (“Mr Li”), the executives directors of the Company and (ii) 44 employees (the “Grantees”) of the Company or its subsidiaries, who are not connected person of the Company. The aggregate number of Award Shares of the Company to be allotted and issued pursuant to the Grant, if fully vested, is 10,400,000 to the Grantees and each of Mr Sun and Mr Li will be allotted and issued 700,000 Award Shares, if fully vested. Hence the total number of Award Shares, if fully vested, is 11,800,000.
