(1)	On March 23, 2016, the Company entered into a subscription agreement with China Guorong
	Assets Management Limited ("China Guorong"), pursuant to which the Company has conditionally
	agreed to issue, and China Guorong has conditionally agreed to subscribe for, the convertible bonds in an
	aggregate principal amount of HK\$166,905,800 (the "Convertible Bonds"). The Convertible
	Bonds will bear an interest of 6% per annum payable on the date falling on the second anniversary of the
	date of the issue of the Convertible Bonds (the "Maturity Date") or on the date of redemption thereof,
	whichever is the earlier. The Convertible Bonds may prior to the Maturity Date be converted into
	357,400,000 conversion shares (subject to adjustments) based on the initial conversion price of HK\$0.467
	each upon full conversion. The Convertible Bonds were issued on April 29, 2016. Details of the
	transactions are set out in the announcements of the Company dated March 24, 2016, April 15, 2016 and
	April 29, 2016.
