



# **Gold Peak Industries (Holdings) Limited**

"Abstraction" by Mao Lizi, a famous Chinese contemporary artist, was chosen to be the cover piece for this year's annual report. Mao, born in 1950, is a member of the 1979 avant-garde "Stars Art Group" and a graduate of Beijing's Central Academy of Fine Arts Department of Oil Painting. He is well-known as a photo-realist painter who has exhibited internationally.

"Abstraction" is oil on canvas painting that captures the dynamic energy of Chinese ink painting. Mao's versatility and creativity prompts him to explore new forms such as this abstract three-panel painting in marine blue, on a white background. The intense marine blue, in varying shades, covers the whole panel as if painted in one brushstroke, and is intensively exuberant and joyous in the centre. The colour suggests water, a wave, or the sea, while the white background offers spacious breathing room. The vibrant brushwork demonstrates the determination and vitality which coincides with the business philosophy of Gold Peak Group.

本年度年報選刊了著名中國現代畫家毛栗子作品《抽象》為封面。毛氏於 1950 年出生, 1979 年成為前衛派「星星畫會」成員, 其後於北京中央美術學院油畫系研修班修業。他是著名照相寫實主義畫家, 作品於世界各地廣泛展出。

《抽象》是一幅布面油畫作品,充分表現中國水墨畫的澎湃動力。毛氏的靈活及創意令他不斷探索嶄新的形式,就如這件三幅合一的畫作一樣。濃烈但層次分明的海洋藍色貫穿三連幅,活像是一氣呵成之作,尤以中間部份更覺情感豐富和歡欣喜樂。藍色好比清水、海浪,又像是海洋,而白色的背景正好提供了寬敞的空間感。充滿動感和剛勁的筆觸,正好與金山工業集團充滿動力、堅毅不撓的管理精神不謀而合。

# GROUP PROFILE 集團簡介

Gold Peak Group is an Asian multinational group which owns high-quality industrial investments via GP Industries Limited, its major industrial investment vehicle. The Group has built renowned brand names for its major product categories, such as GP batteries, KEF premium consumer speakers and CELESTION professional speaker drivers.

The parent company, Gold Peak Industries (Holdings) Limited, was established in 1964 and has been listed on the Stock Exchange of Hong Kong since 1984. Currently, Gold Peak holds an approximately 85.5%\* interest in GP Industries while GP Industries holds an approximately 64.7%\* interest in GP Batteries International Limited. GP Industries and GP Batteries are publicly listed in Singapore.

Including all divisions, the Group's turnover for the financial year 2015-2016 amounted to HK\$5.8 billion and its total assets exceeded HK\$5.9 billion. Including the major operations of its various divisions, the Group currently employs 8,250 people worldwide.
















# Profit (Loss) Attributable to Owners of the Company


# Earnings (Loss) Per Share and Dividends Per Share

# CHAIRMAN'S STATEMENT 主席報告書

"The financial year of 2015-16 has been challenging. The slow global economy and volatilities in trading currencies has affected the revenue of the Group. We faced the challenges by actively pursuing growth of expanding market share and cautiously controlling manufacturing costs. We will also continue with the strategy of brand building, distribution development and further automation to strengthen our businesses."

# **Results and Dividend**

Consolidated turnover for the financial year ended 31 March 2016 dropped by 1% to HK\$5,795 million. Profit attributable to shareholders of the Company was HK\$18.7 million compared to HK\$51.5 million last year. Earnings per share were 2.4 HK cents, as compared with 6.6 HK cents for the previous year.

The Board proposed a final dividend of 1.0 HK cent (2015: 2.5 HK cents) per share, making a total of 3.5 HK cents (2015: 5 HK cents) per share for the whole year.

# **Operations**

Weak consumer demand in key global markets affected the Group's sales performance but stabling material prices and a weaker Renminbi helped to alleviate increasing production costs in China.

Sales of electronics and acoustics business performed steadily in the US but sales in Asia and Europe suffered from weak demand. The MUO, a Bluetooth loudspeaker under the KEF brand launched during the year, received good market response and the Group's professional audio business provided solid performance despite challenging market conditions.

The automotive wire harness business grew steadily. Despite a mild drop in the US market due to maturity of certain model of the car camera harness market, business in the China market grew and increasing parts localization contributed to lower production costs. The Group has been supplying wire harnesses for ultimate use by a leading US electric vehicle manufacturer and sales is expected to grow steadily in the coming years.

Market slowdown and volatile foreign currency exchange rates have affected the sales of GP Batteries. Keen price competition and the emergence of more energy efficient electronic devices further curtailed battery consumption. However, lower raw material prices

# 業績及股息

截至 2016 年 3 月 31 日止,集團營業額微跌 1% 至 57.95 億港元。本公司股東應佔溢利為 1,870 萬港元,去年同期為 5,150 萬港元。每股基本盈利為 2.4港仙,去年為 6.6港仙。

董事局建議派發末期股息每股 1.0 港仙,去年為每股 2.5 港仙。全年股息每股 3.5 港仙,去年度則為每股 5.0 港仙。

# 業務表現

全球主要市場的消費者需求減少,影響 集團銷售表現,但物料價格穩定,加上 人民幣處於弱勢,有助舒緩中國上漲的 生產成本。

電子產品及揚聲器產品於美國市場的銷售表現平穩,亞洲及歐洲市場的銷售則仍受制於當地疲弱的需求。年內,KEF推出的藍芽揚聲器 MUO廣受市場歡迎。在嚴峻的市況下,集團的專業揚聲器業務取得滿意表現。

汽車配線業務穩定增長。由於個別汽車相機配線已發展成熟,美國市場的銷售錄得溫和跌幅,中國市場則錄得增長。集團積極在中國尋找本地零件供應商,此舉有助減低生產成本。集團會繼續維持向一間大型美國電動車生產商供應汽車配線,預期未來數年銷售將有穩定增長。

市場增長緩慢及外幣匯率波動均影響金山電池的銷售。價格競爭激烈及市面上 湧現省電的電子產品進一步削弱電池購買力,但原材料價格下跌及增加生產過

and progress in automation contributed to improve productivity and control costs. Restructuring of certain production facilities in China and Taiwan will help to further streamline production process and improve factory utilization. Meanwhile, GP Batteries will continue to invest into expanding its global distribution network including online platforms to seek business growth.

程自動化有助控制成本及改善產能。同時,集團正為中國及台灣的生產廠房進行 重組,此舉有助簡化生產流程及善用廠房 資源。金山電池會繼續投資拓展全球分銷 網絡,包括網上平台,以提高營業額。

# Outlook

KEF's wireless new media products will gradually become the growth driver for our acoustics business in conjunction with the current line of premium loudspeakers. Commissioning of the extension for the factory in Huizhou, China in the second quarter of the financial year 2016-2017 will further strengthen the Group's capabilities in developing and in better protecting its proprietary technologies as well as in improving manufacturing efficiency.

For the wire harness business, the mid-term strategy is to gradually become a Tier 1 supplier while expanding the high value-added wire harness business in the Tier 2 market. The efforts on parts localization will continue and supply to electric vehicle manufacturers is expected to continue growing.

GP Batteries' new plant in Vietnam is under construction and the production capacity of the Malaysian plant is being expanded substantially. Looking forward, global demands for primary batteries and nickel metal hydride batteries are expected to be slow-growing. Growth will come from increasing market share and developing new applications.

Despite the challenging market, the Group will continue to strengthen its brands and focus on distribution development in priority growth markets.

# 展望

KEF無線新媒體產品與現時高端揚聲器將逐步成為揚聲器業務的增長動力。集團於中國惠州的廠房擴建工程將於2016-2017財政年度第二季完成,此舉有助集團完善發展及妥善保護專有技術,並改善生產效率。

至於汽車配線業務,中期策略是逐步發展 成為第一線供應商,同時擴大高增值汽車 配線業務在第二線市場的佔有率。集團會 繼續加強零件本土化,並預期會增加供應 配線予電動車生產商。

金山電池於越南的新廠房正在興建當中, 同時亦會顯著提升馬來西亞廠房的產能。 展望未來,全球對一次性電池及鎳氫充電 池的需求預期會緩慢增長,業績增長需來 自增加市場份額及發展新產品。

雖然面對嚴峻的市場環境,集團將繼續積極拓展品牌,並在首選增長地區著力拓展 銷售網絡。

# REVIEW OF OPERATIONS 業務回顧

# **Overview**

The financial year of 2015-16 was a challenging year for the Group. Slow-growing global economy together with volatilities in trading currencies affected the Group's performance. The Group maintained the strategy of strengthening its brands, investing in new technology and product development as well as actively expanding sales networks to grow business.

# **GP Industries**

(85.5% owned by Gold Peak as at 31 March 2016)

For the financial year ended 31 March 2016 ("FY2016"), GP Industries' revenue was S\$1,038.3 million, an increase of 6.6% over the revenue reported for the financial year ended 31 March 2015 ("FY2015").

GP Industries reported a net exceptional loss of \$\$2.0 million for FY2016, comprising a \$\$1.3 million write-back of unclaimed warranty provision, a \$\$4.1 million property disposal gain of GP Batteries and an exceptional loss of \$\$7.4 million mainly from impairment charges for under-utilised factory assets and goodwill of GP Batteries. In FY2015, GP Industries reported a net exceptional gain of \$\$5.6 million, which included property disposal gains, impairment charges and restructuring costs.

For FY2016, profit after taxation attributable to equity holders of GP Industries decreased by 10.3% to \$\$22.8 million, compared to \$\$25.5 million reported for FY2015.

However, excluding exceptional items, profit attributable to equity holders of GP Industries for FY2016 was \$\$23.7 million, compared to \$\$24.1 million for FY2015, a decrease of 1.7%.

#### **Electronics and acoustics business**

Revenue from the business segment increased by 6.4%. Sales of electronics and acoustics products increased by 4.8% and 11.7% respectively. Geographically, sales of acoustics products to Asia and the US recorded steady growth while sales to Europe suffered from the slow economy.

Sales of professional audio products were affected by the weak market in the first half of FY2016 though a pickup was recorded in the second half of the year. Sales to the US and Europe increased but sales to Asia declined.

Profit contribution after exceptional items and before taxation increased by 4.7%.

# 概述

2015-2016年度的營商環境充滿挑戰。 全球經濟增長緩慢,交易貨幣波動影響 集團業績表現。集團於年度內維持拓展 品牌、投資科技及產品研發的策略,並 積極擴大銷售網絡以提高營業額。

# GP工業

(於2016年3月31日金山工業持有其85.5%權益)

截至2016年3月31日止,GP工業營業 額較去年增加6.6%至10.383億坡元。

GP工業全年錄得淨特殊虧損200萬坡元,包括回撥未使用之抵押保證撥備130萬坡元、金山電池出售物業收益410萬坡元及金山電池為有剩餘產能的廠房資產及商譽作減值撥備之特殊虧損740萬坡元。GP工業去年錄得淨特殊收益560萬坡元,當中包括出售物業收益、減值支出及重組成本。

年內,除稅後GP工業資本股東應佔溢利由去年之2,550萬坡元減少10.3%至2,280萬坡元。

但倘撇除特殊項目,資本股東應佔溢利 為2,370萬坡元,較去年同期之2,410 萬坡元減少1.7%。

# 電子產品及揚聲器業務

營業額較去年上升6.4%。電子產品及揚聲器產品銷售分別增加4.8%及11.7%。若以地域計算,揚聲器產品於亞洲及美國市場的銷售錄得平穩增長,歐洲市場則仍受制於當地緩慢的經濟。

專業揚聲器產品的銷售在首半財政年度 受疲弱的市場環境影響,下半年則有所 改善。美國及歐洲的銷售增加,但亞洲 的銷售則減少。

計算特殊項目後的除税前盈利貢獻較去 年增加4.7%。

#### **Automotive wire harness business**

Revenue from the wholly-owned automotive wire harness business grew by 12.9%. Sales growth was driven mainly by a 38.9% sales increase to China despite a slight drop in sales to the US due to the peak off of demand for camera harness.

This business segment wrote-back S\$1.3 million during FY2016, being the unclaimed warranty cost provision relating to the disposal of the previously 50%-owned automotive wire harness manufacturing joint venture, Shanghai Jinting Automobile Harness Limited, in 2013. As a result, profit contribution after exceptional item and before taxation increased by 9.8%.

# **Battery business**

#### ("GP Batteries" 64.7% owned by GP Industries as at 31 March 2016)

The revenue of GP Batteries for FY2016 increased by 6.4% to S\$765 million. Despite the emergence of more energy efficient electronic products which affected the overall consumption of battery products, the Group maintained a growth of 6.1% and 8.2% for sales of primary and rechargeable batteries respectively. Sales of primary alkaline and carbon zinc batteries increased slightly and primary lithium batteries recorded a significant growth. Geographically, sales to Asia and Europe increased by 7.5% and 5.3% respectively.

Gross profit margin improved slightly from 23.1% of FY2015 to 23.2%. In FY2016, GP Batteries reported a net exceptional loss of S\$3.3 million, comprising S\$4.5 million of fixed assets impairment with respect to its under-utilised rechargeable lithium batteries production facilities, S\$2.9 million of goodwill impairment and S\$4.1 million of property disposal gain. In FY2015, GP Batteries reported a net exceptional gain of S\$6.9 million, comprising property disposal gains and impairment charges against fixed assets and inventories.

Share of profit from associates increased from S\$0.7 million for FY2015 to S\$4.9 million for FY2016, due mainly to improved performance of its associates in Taiwan and Russia.

GP Batteries reported a profit after taxation of S\$2.4 million, compared to S\$13.0 million last year.

#### Other industrial investments

Meiloon Industrial Co., Ltd. reported a profit before taxation during FY2016, compared to a loss in FY2015. On the other hand, the pre-tax profit contributed by Linkz Industries Limited decreased. Excluding exceptional items, the business segment reported a 59.6% increase in profit contribution.

#### 汽車配線業務

屬全資擁有之汽車配線業務之營業額較去年增加12.9%。美國市場的相機配線需求已到飽和階段,銷售因而微跌,但中國內銷增加 38.9%,推高營業額。

年內,此業務就2013年出售上海金亭線束有限公司(「金亭」)回撥了130萬坡元未使用抵押保證撥備。金亭前為GP工業持有50%股權生產汽車線束之合營企業。汽車配線業務於計算特殊項目後的除稅前盈利貢獻較去年增加9.8%。

#### 電池業務

#### ("金山電池"於2016年3月31日GP工業持有其64.7%權益)

金山電池的營業額為7.65億坡元,較去年上升6.4%。雖然市面上湧現省電的電子產品影響整體電池產品消耗,但一次性電池及充電池之銷售仍分別錄得6.1%及8.2%增長。一次性鹼性電池及碳鋅電池的銷售均微升,一次性鋰電池錄得大幅度增長。若以地域計算,亞洲及歐洲的銷售分別增加7.5%及5.3%。

毛利率由去年23.1%微升至23.2%。年內,金山電池錄得淨特殊虧損330萬坡元,主要包括為生產鋰充電池廠房的剩餘產能作450萬坡元的固定資產減值、商譽減值290萬坡元及出售物業收益410萬坡元。金山電池於上年度錄得淨特殊收益690萬坡元,當中包括出售物業收益及為固定資產和庫存所作的減值支出。

金山電池之所佔聯營公司業績由去年70 萬坡元增至本年度490萬坡元,主要由於 台灣及俄羅斯聯營公司業績改善所致。

金山電池錄得除税後溢利240萬坡元, 去年同期為1,300萬坡元。

#### 其他工業投資

美隆工業股份有限公司轉虧為盈,錄得除税前溢利;領先工業有限公司的税前盈利貢獻則減少。倘撇除特殊項目,此業務之盈利貢獻增長59.6%。

# **Financial Review**

During the year, the Group's net bank borrowings increased by HK\$198 million to HK\$1,146 million. As at 31 March 2016, the aggregate of the Group's shareholders' funds and non-controlling interests was HK\$2,560 million and the Group's gearing ratio (the ratio of consolidated net bank borrowings to shareholders' funds and non-controlling interests) was 0.45 (31 March 2015: 0.35). The gearing ratios of the Company, GP Industries and GP Batteries were 0.44 (31 March 2015: 0.39), 0.25 (31 March 2015: 0.18) and 0.16 (31 March 2015: 0.13) respectively.

At 31 March 2016, 61% (31 March 2015: 71%) of the Group's bank borrowings was revolving or repayable within one year whereas 39% (31 March 2015: 29%) was repayable from one to five years. Most of these bank borrowings are in US dollars, Singapore dollars and Hong Kong dollars.

The Group's exposure to foreign currency arises mainly from the net cash flow and the translation of net monetary assets or liabilities of its overseas subsidiaries. The Group continued to manage foreign exchange risks prudently. Forward contracts, borrowings in local currencies and local sourcing have been arranged to minimise the impact of currency fluctuation.

# 財務回顧

本年度集團之銀行貸款淨額增加1.98億港元至11.46億港元。於2016年3月31日,集團之股東資金及非控股權益合共25.60億港元,借貸比率(按綜合銀行貸款淨額除以股東資金及非控股權益計算)為0.45(2015年3月31日:0.35)。若以個別公司計算,本公司、GP工業及金山電池之借貸比率分別為0.44、0.25及0.16(2015年3月31日之比較數字分別為:0.39、0.18及0.13)。

於2016年3月31日,本集團有61% (2015年3月31日:71%)之銀行貸款 屬循環性或一年內償還借貸,其餘39% (2015年3月31日:29%)則為一年至 五年內償還貸款。本集團之銀行貸款大 部份為美元、新加坡元及港元貸款。

本集團之外幣匯率風險主要來自其淨現金 流動及換算其海外附屬公司之淨貨幣資產 或負債,本集團及其主要聯營公司貫徹其 審慎管理外匯風險的策略,透過安排遠 期合約、當地貨幣借貸及於當地採購等舉 措,減低匯率波動所帶來的風險。

Throughout the financial year ended 31 March 2016, the Company has complied with the code provisions set out in the Code, except for the deviations from A.2.1 of the Code, details of which are set out below.

#### **BOARD OF DIRECTORS**

The principal focus of the board of directors (the "Board") is on the overall strategic development of the Group. The Board also monitors the financial performance and the internal controls of the Group's business operations.

Other duties of the directors include but not limited to maintaining effective control of the Company, giving specific strategic direction to the Company, reviewing, approving and monitoring the fundamental financial and business strategies, plans and major corporate actions, ensuring that the Company complies with the relevant laws, regulations and codes of business practice, ensuring that the Company communicates with shareholders and the relevant stakeholders transparently and promptly and monitoring the overall corporate governance functions of the Company.

The Company has received from each of the independent non-executive directors an annual confirmation of his independence pursuant to Rule 3.13 of the Listing Rules. The Company considers all the independent non-executive directors to be independent.

# APPOINTMENT AND RE-ELECTION OF DIRECTORS

The Board reviews its own structure, size and composition regularly to ensure that it has a balance of expertise, skills and experience appropriate to the needs of the business of the Company.

集團廠房融入環保建築概念,減少廠房內的能源消耗,包括設計上在屋頂加裝天窗及以玻璃庭院引進天然光,把設施置於地底增加淨空高度,多採用玻璃作間隔,並把照明燈更換為發光二極管,及安裝太陽能照明系統。

#### **ENVIRONMENTAL PROTECTION**

The Group has formed teams to deal with waste emission. The teams manage programs to cut down hazardous and non-hazardous waste, as well as encourage recycling for more efficient use of resources. Proper treatment of industrial waste water and hazardous waste has been put into practice.

The Group engages in energy efficiency practices and strives to reduce energy consumption to alleviate effects on global warming. Airconditioning, electricity and water conservation have been closely tracked and reviewed to maintain a lean and an efficient operation. Water used in certain production plants is recycled for watering, toilet flushing and manufacturing. Product packaging is constantly reviewed in order to reduce material usage and minimise the impact on the environment.

Green building concept has been employed by the Group to reduce energy consumption in its factories. This includes using natural lighting from roof window and courtyard glass, installing utilities underground to have more headroom, using glass as partition as much as possible, replacing various light sources with LED tubes and using solar energy for certain lighting systems.

The accreditations QC080000 and ISO14001 obtained by our factories have demonstrated the Group's efforts in establishing an effective management system to control and manage hazardous substances.

A number of the Group's subsidiaries received the "Hong Kong – Guangdong Cleaner Partner (Manufacturing)" award from the Economic & Information Commission of Guangdong Province, PRC and Environmental Protection Department of the Government of the Hong Kong Special Administrative Region.

Three factories were named the "Eco Challenger & 5 Years+ Eco Pioneer" by the Federation of Hong Kong Industries and one factory was named the "Eco Partner & 3 Years+ Eco Pioneer" to recognize their achievement in environmental and economic efficiency.

Retirement schemes are offered as part of the remuneration package. Remuneration policies and packages are reviewed regularly to ensure that compensation and benefits are in line with the market of each territory.

The Group invests in employees through development programs to enhance their soft and hard skills as well as work competence in preparation for their career development. Various workshops and training sessions on laws and regulations, management and leadership skills, as well as language and communication were organized.

During the year, the Group moved its headquarters to a new home which provided a better environment for networking and creativity as well as better views with fresh air. Connecting shuttle services were also provided for the convenience of employees.

#### **Health and Safety**

The Group strives to provide its employees with a safe and healthy workplace. Safety and occupational health courses were included in orientation program for new employees in production plants. Training courses on the authentication of QC080000 and SA8000, first aid, proper use of hazardous and chemical materials, etc were held.

A number of the Group's plants in China were certified with OHSAS18001 by DNV, a worldwide certification body. A plant has also won the third prize in the "Shenzhen Public Health Literacy Contest" organized by the Health and Family Planning Commission Shenzhen Municipality, China.

#### **Procurement Management and Product Responsibility**

The Group has a well-established supply chain management policy to monitor the quality of its suppliers. Suppliers are qualified based on their capability to meet the product's technical and quality requirement, health, safety and environment standards and business ethics. The Group conducted random audits of the suppliers' production sites to ensure their continuous compliance with the quality and environmental regulatory requirements.

The Group is committed to producing safe and quality products. It strives to comply with all regulatory requirements pertaining to the health and safety impacts of its products and services. It provides appropriate mechanisms to receive customers' feedback in order to continuously improve upon its products and services.

Most of the Group's factories have received ISO9001 accreditation which illustrates the Group's endeavor to ensure consistently good quality products and services for its customers.

An interim dividend of 2.5 HK cents per share was paid to the shareholders during the year. A final dividend of 1.0 HK cent per share is proposed by the directors. On the basis of 3.5 HK cents per share for the entire year, total dividends amount to HK\$27,464,000.

During the period from 15 June 2015 to 31 March 2016, GP Batteries (Shenzhen) Co., Ltd ("GPB Shenzhen"), an indirect non-wholly owned subsidiary of the Company, had sourced and purchased parts for battery production from Surface Mount Technology Limited ("SMTL"), which is a connected person of the Company by virtue of it being wholly owned by Mr. CHAN Kei Biu, an independent non-executive Director, and his associates (the "Transactions"). The aggregate consideration of the Transactions payable by GPB Shenzhen to SMTL for the period from 15 June 2015 to 31 March 2016 was US\$752,000 (or approximately HK\$5.8 million). Further details of the Transactions have been disclosed in the announcement of the Company dated 12 April 2016 (the "Announcement") in compliance with the requirements under Chapter 14A of the Listing Rules.

As disclosed in the Announcement, the Group has conducted the Transactions in its ordinary and usual course of business but there was no written agreement for the Transactions. The Company should have complied with the announcement requirement set out in Rule 14A.35 of the Listing Rules when the aggregate amount of the Transactions exceeded HK\$3 million in December 2015. The failure to enter into a written agreement for and to make timely disclosure of the Transactions constituted a breach of Rules 14A.34 and 14A.35 of the Listing Rules.

The independent non-executive Directors (other than Mr. CHAN Kei Biu) have reviewed the Transactions and confirmed that the respective contracts and terms of the Transactions were:

- 1. in the ordinary and usual course of business of the Group;
- 2. on normal commercial terms; and
- 3. fair and reasonable and in the interests of the Company's shareholders as a whole

Pursuant to Rule 14A.56 of the Listing Rules, the Company's auditor was engaged to report on the Transactions in accordance with Hong Kong Standard on Assurance Engagements 3000 (Revised) "Assurance Engagements Other Than Audits or Reviews of Historical Financial Information" and with reference to Practice Note 740 "Auditor's Letter on Continuing Connected Transactions under the Hong Kong Listing Rules" issued by the Hong Kong Institute of Certified Public Accountants. Based on the Announcement as set out above, the Company's auditor has concluded that the Transactions were not entered into, in all material respects, in accordance with the relevant requirements of the Listing Rules and has expressed adverse opinion on the matters set out in Rule 14A.56 of the Listing Rules because no written agreement in respect of the Transactions was entered into with SMTL as required by 14A.34 of the Listing Rules, no annual cap has been set by the Company accordingly and no formal approval was given by the Company's board of directors at the time of entering into the Transactions. A copy of the auditor's letter has been provided by the Company to the Stock Exchange.

#### **HKFRS 9 Financial instruments**

HKFRS 9 issued in 2009 introduces new requirements for the classification and measurement of financial assets. HKFRS 9 amended in 2010 includes the requirements for the classification and measurement of financial liabilities and for derecognition, and further amended in 2013 to include the new requirements for hedge accounting. Another revised revision of HKFRS 9 was issued in 2014 mainly to include a) impairment requirements for financial assets and b) limited amendments to the classification and measurement requirements by introducing a "fair value through other comprehensive income" measurement category for certain simple debt instruments.

Key requirements of HKFRS 9 that are applicable to the Group are described as follows:

- All recognised financial assets that are within the scope of HKAS 39 "Financial instruments: Recognition and measurement" are subsequently measured at amortised cost or fair value. Specifically, debt investments that are held within a business model whose objective is to collect the contractual cash flows, and that have contractual cash flows that are solely payments of principal and interest on the principal outstanding are generally measured at amortised cost at the end of the subsequent accounting periods. Debt instruments that are held within a business model whose objective is achieved both by collecting contractual cash flows and selling financial assets, and that have contractual terms that give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding, are generally measured at FVTOCI. All other debt investments and equity investments are measured at their fair values at the end of subsequent reporting periods. In addition, under HKFRS 9, entities may make an irrevocable election to present subsequent changes in the fair value of an equity investment (that is not held for trading) in other comprehensive income, with only dividend income generally recognised in profit or loss.
- in relation to the impairment of financial assets, HKFRS 9 requires an expected credit loss model, as opposed to an incurred credit loss model under HKAS 39. The expected credit loss model requires an entity to account for expected credit losses and changes in those expected credit losses at each reporting date to reflect changes in credit risk since initial recognition. In other words, it is no longer necessary for a credit event to have occurred before credit losses are recognised.

The directors anticipate that the application of HKFRS 9 in the future may have significant impact on amounts reported for the Group's financial assets in respect of available-for-sale investments. However, it is not practicable to provide a reasonable estimate of that effect until a detailed review has been completed.

# 香港財務報告準則第15號「客戶合約收入」

# **HKFRS 15 Revenue from contracts with customers**

HKFRS 15 was issued which establishes a single comprehensive model for entities to use in accounting for revenue arising from contracts with customers. HKFRS 15 will supersede the current revenue recognition guidance including HKAS 18 "Revenue", HKAS 11 "Construction contracts" and the related interpretations when it becomes effective.

The core principle of HKFRS 15 is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. Specifically, the Standard introduces a 5-step approach to revenue recognition:

Step 1: Identify the contract(s) with a customer

Step 2: Identify the performance obligations in the contract

Step 3: Determine the transaction price

Step 4: Allocate the transaction price to the performance

obligations in the contract

Step 5: Recognise revenue when (or as) the entity satisfies a

performance obligation

Under HKFRS 15, an entity recognises revenue when (or as) a performance obligation is satisfied, i.e. when 'control' of the goods or services underlying the particular performance obligation is transferred to the customer. Far more prescriptive guidance has been added in HKFRS 15 to deal with specific scenarios. Furthermore, extensive disclosures are required by HKFRS 15.

The directors anticipate that the application of HKFRS 15 in the future may have a material impact on the amounts reported and disclosures made in the Group's consolidated financial statements. However, it is not practicable to provide a reasonable estimate of the effect of HKFRS 15 until the Group performs a detailed review.

# 香港財務報告準則第16號「租賃」

於二零一六年頒佈之香港財務報告準則第16號,於二零一九年一月一日或其後開始之年度期間生效,並將取代所有現行租賃的會計要求,亦即代表租賃的會計處理和報告有顯著的變化,更多的資產和負債呈報於綜合財務狀況報表和租賃費用的不同確認。

香港財務報告準則第16號按可識別資產是 否由客戶控制來區分租賃和服務合同。除了 符合短期租賃和低價值資產之少數例外,營 運租約和融資租賃的區分從承租人會計中刪 除,並且使用承租人按資產使用權和相應負 債來確認所有租賃之模式取代。

應用香港財務報告準則第16號將導致本集團就旗下許多租賃安排按資產使用權和相應的負債確認。該等資產和負債於當前不需要被確認,但若干相關信息載於綜合賬目附註41,並披露為承擔。

除上述所披露者外,本公司董事預期應用其 他新訂或經修訂香港財務報告準則對本集團 之綜合財務報表將不會造成重大影響。

綜合財務報表已按香港會計師公會頒佈之香 港財務報告準則編製。此外,綜合財務報表 包括香港聯交所證券上市規則及香港公司條 例所規定適用披露。

綜合財務報表已按照歷史成本基準編製,除 部分物業及金融工具按期末重估金額或公平 值計量之外,詳情於下列會計政策闡釋。

歷史成本通常按交換貨品及服務所付代價之 公平值計算。

公平值指市場參與者之間在計量日進行的有序交易中出售一項資產所收取的價格或轉移一項負債所支付的價格,無論該價格為直接觀察到的結果還是採用其他估值技術作出的估計。在對資產或負債的公平值作出估計時,本集團考慮了市場參與者在計量日本,本集團考慮了實價時將會考慮的那些特徵。在本綜合財務報告中計量及/或披露的公平值均在此基礎上予以確定,但香港財務電內以股份支付交易、香港會計準則第17號「租賃」範圍內的租賃交易、以及與公平值期(但並非公平值的計量(例如香港會計準則第2號「存貨」中的可變現淨值或香港會計準則第36號「資產減值」中的使用價值)除外。

#### **HKFRS 16 Leases**

HKFRS 16 was issued in 2016 and is effective for annual periods beginning on or after 1 January 2019. HKFRS 16 will replace all existing lease accounting requirements and represents a significant change in the accounting and reporting of leases, with more assets and liabilities to be reported on the consolidated statement of financial position and a different recognition of lease costs.

HKFRS 16 distinguishes leases and service contracts on the basis of whether an identified asset is controlled by a customer. Subject to limited exceptions for short-term leases and low value assets, distinctions of operating and finance leases are removed for lessee accounting, and is replaced by a model where a right-of-use asset and a corresponding liability have to be recognised for all leases by lessees.

Application of HKFRS 16 will result in the Group's recognition of rightof-use assets and corresponding liabilities in respect of many of the Group's lease arrangements. These assets and liabilities are currently not required to be recognised but certain relevant information is disclosed as commitments in these consolidated financial statements in note 41.

The directors of the Company are in the process to assess the impact of HKFRS 16 on the Group's consolidated financial statements. Operating lease arrangements are disclosed in note 41.

Except as describe above, the directors do not anticipate that the application of the other new and revised HKFRSs will have a material impact on the Group's consolidated financial statements.

# 3. SIGNIFICANT ACCOUNTING POLICIES

The consolidated financial statements have been prepared in accordance with HKFRSs issued by the HKICPA. In addition, the consolidated financial statements include applicable disclosures required by the Rules Governing the Listing of Securities on the Stock Exchange and by the Hong Kong Companies Ordinance.

The consolidated financial statements have been prepared on the historical cost basis except for certain properties and financial instruments, that are measured at revalued amounts or fair values at the end of each reporting period, as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of HKAS 17 "Leases", and measurements that have some similarities to fair value but are not fair value, such as net realisable value in HKAS 2 "Inventories" or value in use in HKAS 36 "Impairment of assets".

# 綜合基準

本綜合財務報告包含本公司及由本公司及其 附屬公司控制之實體之財務報告。取得控制 權是指本公司:

- 對投資對象行使權力;
- 因參與投資對象之業務而獲得或有權獲 得可變回報;及
- 有能力行使其權力以影響該等回報。

倘事實及情況反映上文所列三項控制因素其 中一項或多項改變,則本集團會重估是否仍 然控制被投資方。

倘本集團於投資對象之投票權未能佔大多數,則當投票權足以賦予本集團實際能力以單方面指揮投資對象的相關活動時即對投資對象擁有權力。本集團於評估本集團於投資對象的投票權是否足以賦予其權力時考慮所有相關事實及情況,包括:

- 相較其他投票權持有人所持投票權的數量及分散情況,本集團持有投票權的數量;
- 本集團、其他投票權持有人或其他人士 持有之潛在投票權;
- 其他合約安排產生的權利;及
- 需要作出決定時,本集團目前能夠或不 能指揮相關活動的任何額外事實及情況 (包括於過往股東會議上的投票模式)。

In addition, for financial reporting purposes, fair value measurements are categorised into Level 1, 2 or 3 based on the degree to which the inputs to the fair value measurements are observable and the significance of the inputs to the fair value measurement in its entirety, which are described as follows:

- Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the entity can access at the measurement date;
- Level 2 inputs are inputs, other than quoted prices included within Level 1, that are observable for the asset or liability, either directly or indirectly; and
- Level 3 inputs are unobservable inputs for the asset or liability.

The principal accounting policies are set out below.

# Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- is exposed, or has rights, to variable returns from its involvement with the investee; and
- has the ability to use its power to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

When the Group has less than a majority of the voting rights of an investee, it has power over the investee when the voting rights are sufficient to give it the practical ability to direct the relevant activities of the investee unilaterally. The Group considers all relevant facts and circumstances in assessing whether or not the Group's voting rights in an investee are sufficient to give it power, including:

- the size of the Group's holding of voting rights relative to the size and dispersion of holdings of the other vote holders;
- potential voting rights held by the Group, other vote holders or other parties;
- rights arising from other contractual arrangements; and
- any additional facts and circumstances that indicate that the Group has, or does not have, the current ability to direct the relevant activities at the time that decisions need to be made, including voting patterns at previous shareholders' meetings.

當本集團取得附屬公司之控制權,便將該附屬公司綜合入賬;當本集團失去附屬公司之控制權,便停止將該附屬公司綜合入賬。具體而言,年內收購或出售之附屬公司之收入及支出會於本集團取得控制權當日起計入綜合損益,直至本集團對該附屬公司之控制權終止當日為止。

損益及其他全面收益各項目均歸屬於本公司 股東及非控股權益。附屬公司的全面收益總 額歸屬於本公司股東及非控股權益,即使此 舉會導致非控股權益的結餘為負數。

在必要時,本集團會將附屬公司財務報告作 出調整,以令其會計政策與本集團所採用者 一致。

與本集團成員公司間交易有關之所有集團內公司間之資產及負債、權益、收入、開支及 現金流量均在編製綜合賬目時抵銷。

# 本集團於現有附屬公司之擁有權權益變動

本集團於現有附屬公司擁有權之變動並無導致本集團對附屬公司失去控制權,乃作為股本交易入賬。本集團之權益及非控股權益之 賬面值經調整以反映彼等於附屬公司之有關權益變動。非控股權益之面額與已付或已收 代價之公平值間任何差額直接於權益中確認 並歸屬於本公司擁有人。

# Basis of consolidation (continued)

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

When necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies into line with the Group's accounting policies.

All intragroup assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

# Changes in the Group's ownership interests in existing subsidiaries

Changes in the Group's ownership interests in existing subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's interests and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

When the Group loses control of a subsidiary, a gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable HKFRSs). The fair value of any investment retained in the former subsidiary at the date when control is lost is regarded as the fair value on initial recognition for subsequent accounting under HKAS 39, when applicable, the cost on initial recognition of an investment in an associate.

#### 業務合併

收購附屬公司使用收購法列賬。業務合併轉讓之代價乃按公平值計量,公平值乃按於收購日本集團為交換被收購者之控制權而轉移之資產、產生之負債及發行股本權益之總額計算。相關收購成本一般於產生時在損益確認。

於收購日,收購之可識別資產及承擔之負債 按其於收購日之公平值確認,惟下列除外:

- 遞延税項資產或負債及與僱員福利安排 有關的負債或資產,分別按香港會計準 則第12號「所得税」及香港會計準則第19 號「僱員福利」確認及計量;
- 與被收購者以股份付款安排或以本集團股份形式付款安排以取代被收購者股份形式付款安排有關之負債或股本工具,於收購日根據香港財務報告準則第2號「以股份為基礎之付款」計量(見下文會計政策);及

商譽乃按所支付代價、於被收購者所佔任何 非控股性權益額及收購者過往持有之被收購 者股本權益之公平值(如有)之總額超逾於收 購日收購之可識別資產及承擔之負債淨額之 差額計量。倘經重新評估後,收購之可識別 資產及承擔之負債於收購日之淨額超逾支付 代價、於被收購者之任何非控股性權益額 及收購者過往持有之被收購者權益之公平值 (如有)之總額,則差額即時於損益確認為優 惠收購收益。

現時為權益擁有者且持有人可於清盤時就此按比例獲得實體淨資產之非控股性權益,可按公平值或被收購者之可識別淨資產已確認金額之按比例應佔部份初始計量,計量選擇以逐項交易為基準。其他類別之非控股性權益乃按其公平值或(倘適用)其他準則所載之基準計量。

# **Business combinations**

Acquisitions of businesses are accounted for using the acquisition method. The consideration transferred in a business combination is measured at fair value, which is calculated as the sum of the acquisition-date fair values of the assets transferred by the Group, liabilities incurred by the Group to the former owners of the acquiree and the equity interests issued by the Group in exchange for control of the acquiree. Acquisition-related costs are generally recognised in profit or loss as incurred.

At the acquisition date, the identifiable assets acquired and the liabilities assumed are recognised at their fair value, except that:

- deferred tax assets or liabilities, and assets or liabilities related to employee benefit arrangements are recognised and measured in accordance with HKAS 12 "Income taxes" and HKAS 19 "Employee benefits" respectively;
- liabilities or equity instruments related to share-based payment arrangements of the acquiree or share-based payment arrangements of the Group entered into to replace share-based payment arrangements of the acquiree are measured in accordance with HKFRS 2 "Share-based payment" at the acquisition date (see the accounting policy below); and
- assets (or disposal groups) that are classified as held for sale in accordance with HKFRS 5 "Non-current assets held for sale and discontinued operations" are measured in accordance with that standard.

Goodwill is measured as the excess of the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree, and the fair value of the acquirer's previously held equity interest in the acquiree (if any) over the net of the acquisition-date amounts of the identifiable assets acquired and the liabilities assumed. If, after re-assessment, the net of the acquisition-date amounts of the identifiable assets acquired and liabilities assumed exceeds the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree and the fair value of the acquirer's previously held interest in the acquiree (if any), the excess is recognised immediately in profit or loss as a bargain purchase gain.

Non-controlling interests that are present ownership interests and entitle their holders to a proportionate share of the entity's net assets in the event of liquidation may be initially measured either at fair value or at the non-controlling interests' proportionate share of the recognised amounts of the acquiree's identifiable net assets. The choice of measurement basis is made on a transaction-by-transaction basis. Other types of non-controlling interests are measured at their fair value or, when applicable, on the basis specified in another HKFRS.

When a business combination is achieved in stages, the Group's previously held equity interest in the acquiree is remeasured to fair value at the acquisition date (i.e. the date when the Group obtains control), and the resulting gain or loss, if any, is recognised in profit or loss. Amounts arising from interests in the acquiree prior to the acquisition date that have previously been recognised in other comprehensive income are reclassified to profit or loss where such treatment would be appropriate if that interest were disposed of.

就減值檢測而言,商譽會分配至預期受惠於 合併所產生協同效益之各個集團之現金產生 單位或多組現金產生單位。

獲分配商譽之現金產生單位會每年或當有跡象顯示該單位可能出現減值時更頻密地檢測減值。就因收購產生商譽之報告期間而言,獲分配商譽之現金產生單位會於該報告期。倘現金產生單位之可收回。倘現金產生單位之可收回。 額低於其賬面值,則減值虧損會先用作減低任何分配至該單位之商譽賬面值,其後則接配值的,其後可以接下, 該單位內各項資產賬面值之比例分配至於設單位之其他資產。任何商譽減值虧損直接於誤單位之其他資產。 合損益表之損益中確認。商譽之確認減值虧損不會於往後期間撥回。

#### Goodwill

Goodwill arising on an acquisition of a business is carried at cost as established at the date of acquisition of the business (see the accounting policy above) less accumulated impairment losses, if any.

For the purposes of impairment testing, goodwill is allocated to each of the Group's cash-generating units (or groups of cash-generating units) that is expected to benefit from the synergies of the combinations.

A cash-generating unit to which goodwill has been allocated is tested for impairment annually or more frequently whenever there is an indication that the unit may be impaired. For goodwill arising on an acquisition in a reporting period, the cash-generating unit to which goodwill has been allocated is tested for impairment before the end of that reporting period. If the recoverable amount of the cash-generating unit is less than the carrying amount of the unit, the impairment loss is allocated first to reduce the carrying amount of any goodwill allocated to the unit and then to the other assets of the unit pro rata on the basis of the carrying amount of each asset in the unit. Any impairment loss for goodwill is recognised directly in profit or loss in the consolidated statement of profit or loss. An impairment loss recognised for goodwill is not reversed in subsequent periods.

On disposal of the relevant cash-generating unit, the attributable amount of goodwill is included in the determination of the amount of profit or loss on disposal.

The Group's policy for goodwill arising on the acquisition of an associate is described below.

# Investments in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting, even though they are classified as held for sale. The financial statements of associates used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate. When the Group's share of losses of an associate exceeds the Group's interest in that associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate.

# 於聯營公司的投資(續)

於聯營公司之投資按權益會計法入賬,由該投資對象成為一間聯營公司開始。在收購一間聯營公司時,任何投資成本超出本集團應佔投資方可識別資產及負債之公平淨值之差額確認為商譽,並已包括在投資的賬面值中。本集團應佔可識別資產及負債淨公平值超出收購成本之任何差額,在重新評估後即時確認於該投資收購年度之損益。

香港會計準則第39號之規定適用於釐定有否需要就本集團於一間聯營公司之投資確認任何減損。如有需要,投資之全部賬面值(包括商譽)會根據香港會計準則第36號「資產減值」作為單一資產進行減值測試,方法為將可收回金額(即使用價值與公平值減銷售成本之較高者)與賬面值作比較。任何已確認之減值虧損構成投資賬面值之一部分。倘其後投資之可收回金額增加,則根據香港會計準則第36號確認該減損之撥回。

本集團自投資對象不再為聯營公司之日起, 停止採用權益法。當本集團保留於前聯營公 司之權益時,該保留權益為一項金融資產, 本集團於該日按公平值計量該保留權益,而 根據香港會計準則第39號,公平值視為初 始確認公平值。停止採用權益法日期聯營公 司賬面值與任何保留權益之公平值及出售於 聯營公司之一部分權益之所得款項之差額用 於釐定出售聯營公司之收益或虧損。此外, 本集團將先前於其他全面收入確認與該聯營 公司有關之所有金額按倘若該聯營公司已直 接出售有關資產或負債所要求者相同基準入 賬。因此,倘由先前該聯營公司於其他全面 收入確認為收益或虧損會於出售有關資產或 負債後重新分類至損益,當停止採用權益法 時,本集團將有關收益或虧損自權益重新分 類至損益(作為重新分類調整)。

當集團實體與本集團之聯營公司進行交易 時,則與聯營公司交易所產生之損益僅於聯 營公司之權益與本集團無關時,方於本集團 之綜合財務報表確認。

# Investments in associates (continued)

An investment in an associate is accounted for using the equity method from the date on which the investee becomes an associate. On acquisition of the investment in an associate, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The requirements of HKAS 39 are applied to determine whether it is necessary to recognise any impairment loss with respect to the Group's investment in an associate. When necessary, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with HKAS 36 "Impairment of assets" as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs of disposal) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with HKAS 36 to the extent that the recoverable amount of the investment subsequently increases.

The Group discontinues the use of the equity method from the date when the investment ceases to be an associate. When the Group retains an interest in the former associate and the retained interest is a financial asset, the Group measures the retained interest at fair value at that date and the fair value is regarded as its fair value on initial recognition in accordance with HKAS 39. The difference between the carrying amount of the associate at the date the equity method was discontinued, and the fair value of any retained interest and any proceeds from disposing of a partial interest in the associate is included in the determination of the gain or loss on disposal of the associate. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate on the same basis as would be required if that associate had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) when the equity method is discontinued

When a group entity transacts with an associate of the Group, profits and losses resulting from the transactions with the associate are recognised in the Group's consolidated financial statements only to the extent of interests in the associate that are not related to the Group.

#### 收入確認

收入按已收或應收代價公平值計算。收入減去估計的客戶退貨、折扣和其他類似津貼。

貨物出售所得收入於貨物付運及貨權已轉手 時確認,並符合下列所有條件:

- 本集團已將貨品擁有權之重大風險及回報轉移到買方;
- 本集團未保留與擁有權相關的持續管理權,且對已出售貨品亦無有效的控制權;
- 收益能可靠地計量;
- 本集團可得到與該項交易有關的經濟利益;及
- 有關該項交易產生或將要產生的成本能可靠地計量。

服務收入於提供服務時確認。

金融資產之利息收入於本集團可得到經濟利益及能可靠計量收入金額時確認。利息收入乃以本金及其有效利率按時間基準計入。有效利率為可於金融資產預計年期內把將收取現金折現至資產最初確認時之賬面值之利率。

投資股息收入於股東已確定有權收取該款項 時確認。

本集團有關經營租賃收入確認的會計政策之 詳情,列載於下列租賃之會計政策。

# Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable. Revenue is reduced for estimated customer returns, rebates and other similar allowances.

Revenue from the sale of goods is recognised when the goods are delivered and titles have passed, at which time all the following conditions are satisfied:

- the Group has transferred to the buyer the significant risks and rewards of ownership of the goods;
- the Group retains neither continuing managerial involvement to the degree usually associated with ownership nor effective control over the goods sold;
- the amount of revenue can be measured reliably;
- it is probable that the economic benefits associated with the transaction will flow to the Group; and
- the costs incurred or to be incurred in respect of the transaction can be measured reliably.

Service income is recognised when services are provided.

Interest income from a financial asset is recognised when it is probable that the economic benefits will flow to the Group and the amount of income can be measured reliably. Interest income is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

Dividend income from investments is recognised when the shareholders' right to receive payment has been established.

The Group's accounting policy for recognition of revenue from operating leases is described in the accounting policy for leasing below.

# 待出售非流動資產

倘賬面值主要通過出售交易而非通過持續使用而收回,則非流動資產及出售組別會被分類為待出售。此條件僅於極有可能達成出售及該資產(或出售組別)可於現況下以一般及慣常條款即時出售時方告符合。管理層必須致力進行銷售,且有關資產預計在分類日期起計1年內合資格確認為已完成銷售。

當本集團承諾出售計劃,當中涉及失去一間 附屬公司控制權時,該附屬公司的所有資產 及負債於符合上述條件時均分類為持有作出 售,不論本集團是否將於出售後保留其前附 屬公司的非控股權益。

分類為待出售之非流動資產(及出售組別)按 其以往之賬面值與公平值減出售成本中較低 者計量。

# 投資物業

# Non-current assets held for sale

Non-current assets and disposal groups are classified as held for sale if their carrying amounts will be recovered principally through a sale transaction rather than through continuing use. This condition is regarded as met only when the asset (or disposal group) is available for immediate sale in its present condition subject only to terms that are usual and customary for sales of such asset (or disposal group) and the sale is highly probable. Management must be committed to the sale, which should be expected to qualify for recognition as a completed sale within one year from the date of classification.

When the Group is committed to a sale plan involving loss of control of a subsidiary, all of the assets and liabilities of that subsidiary are classified as held for sale when the criteria described above are met, regardless of whether the Group will retain a non-controlling interest in its former subsidiary after the sale.

Non-current assets (and disposal groups) classified as held for sale are measured at the lower of their previous carrying amount and fair value less costs of disposal.

# **Investment properties**

Investment properties are properties held to earn rentals and/or for capital appreciation.

Investment properties are initially measured at cost, including any directly attributable expenditure. Subsequent to initial recognition, investment properties are measured at their fair values. Gains or losses arising from changes in the fair value of investment property are included in profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use or no future economic benefits are expected from its disposal. Any gain or loss arising on derecognition of the property (calculated as the difference between the net disposal proceeds and the carrying amount of that asset) is included in the profit or loss in the period in which the asset is derecognised.

# Property, plant and equipment

Property, plant and equipment held for use in the production or supply of goods or services, or for administrative purposes (other than asset under construction and freehold land) are stated in the consolidated statement of financial position at cost or fair value less subsequent accumulated depreciation and accumulated impairment losses, if any.

Advantage has been taken of the transitional relief provided by HKAS 16 "Property, plant and equipment" from the requirement to make regular revaluations of the Group's land and buildings which had been carried at revalued amounts prior to 30 September 1995, and accordingly no further revaluation of land and buildings is carried out. Prior to 30 September 1995, the revaluation increase arising on the revaluation of these assets was credited to the property revaluation reserve. Any future decreases in value of these assets will be dealt with as an expense to the extent that they exceed the balance, if any, on the property revaluation reserve relating to a previous revaluation of the same asset. On the subsequent sale or retirement of a revalued asset, the corresponding revaluation surplus is transferred to retained profits.

Depreciation is recognised so as to write off the cost or valuation of assets other than asset under construction or freehold land less their residual values over their estimated useful lives, using the straight-line method or the reducing balance method.

Assets held under finance leases are depreciated over their expected useful lives on the same basis as owned assets. However, when there is no reasonable certainty that ownership will be obtained by the end of the lease term, assets are depreciated over the shorter of the lease term and their useful lives.

Asset under construction and freehold land are carried at cost less any identified impairment losses. Depreciation of the asset under construction commences when they are available for use (i.e. when they are in the location and condition necessary for it to be capable of operating in the manner intended by management).

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between the sales proceeds and the carrying amount of the assets and is recognised in the profit or loss.

估計可使用年期及攤銷方法於報告期結 算日進行審閱,而任何估計變動的影響 則按前瞻基準入賬。

# (b) 內部產生無形資產-研究及開發支出

研究活動開支於產生期間被確認為費用。

開發支出產生的內部產生無形資產只在 具備以下所有條件時方被確認:

- 完成無形資產技術之可行性以至能 夠使用或出售;
- 完成該無形資產並使用或出售之意 向:
- 使用或出售該無形資產之能力;
- 無形資產將如何產生未來經濟利益;
- 具備足夠的技術、資金和其他資源,以完成開發並使用或出售該無 形資產;及
- 發展無形資產的過程中,可靠地計 量應佔開支的能力。

首次被確認為內部產生無形資產的金額,為無形資產符合確認標準日起計支 出的總和。如沒內部產生無形資產可被 確認,開發支出於產生期間從損益中扣 除。

# Intangible assets

# (a) Intangible assets acquired separately – Trademarks and Technical know-how

Trademarks are measured initially at purchase cost and are amortised on a straight-line basis over their estimated useful lives, which are estimated to be twenty years.

The cost of acquiring rights to technical know-how for the production of new products is amortised on a straight-line method, over a period of three to five years from the date of acquisition or over the licence period, whichever is shorter.

The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

# (b) Internally-generated intangible assets – Research and development expenditure

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

An internally-generated intangible asset arising from development expenditure is recognised only if, all of the following have been demonstrated:

- the technical feasibility of completing the intangible asset so that it will be available for use or sale;
- the intention to complete the intangible asset and use or sell it.
- the ability to use or sell the intangible asset;
- how the intangible asset will generate probable future economic benefits;
- the availability of adequate technical, financial and other resources to complete the development and to use or sell the intangible asset; and
- the ability to measure reliably the expenditure attributable to the intangible asset during its development.

The amount initially recognised for internally-generated intangible asset is the sum of the expenditure incurred from the date when the intangible asset first meets the recognition criteria. Where no internally-generated intangible asset can be recognised, development expenditure is charged to profit or loss in the period in which it is incurred.

Subsequent to initial recognition, internally-generated intangible assets are recorded at cost less accumulated amortisation and accumulated impairment losses, on the same basis as intangible assets acquired separately. The resultant asset is amortised on a straight-line basis over its estimated useful live, not exceeding ten years, commencing in the year when the product is put into commercial use.

客戶關係以直線法於5年內攤銷。首次確認之後,按成本減累計攤銷及累計減值 虧損列賬。

無形資產於出售或當預期使用或出售不會產生任何未來經濟利益時剔除確認,其產生的損益按出售所得款項淨額與該資產賬面值之間差額計算,並於損益確認。

#### 有形資產及無形資產(除商譽外)減值

# (c) Intangible assets acquired in a business combination – Customer relationship

Intangible assets acquired in a business combination are recognised separately from goodwill and are initially recognised at their fair value at the acquisition date, which is regarded as their cost.

The customer relationship is amortised using straight-line method, over a period of five years. Subsequent to initial recognition, the customer relationship is recorded at cost less accumulated amortisation and accumulated impairment losses.

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains and losses arising from derecognition of an intangible asset, measured as the difference between the net disposal proceeds and the carrying amount of the asset, are recognised in profit or loss when the asset is derecognised.

# Impairment of tangible and intangible assets (other than goodwill)

At the end of the reporting period, the Group reviews the carrying amounts of its tangible and intangible assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss, if any.

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount under another standard, in which case the impairment loss is treated as a revaluation decrease under that standard.

Where an impairment loss subsequently reverses, the carrying amount of the asset is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of an impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount under another standard, in which case the reversal of impairment loss is treated as a revaluation increase under that standard

# 全融工具

當集團公司成為金融工具合約條文之訂約方,金融資產及金融負債即被確認。

金融資產及金融負債初次按公平值計量。收購或發行金融資產及金融負債(按公平值計入損益中之金融資產或金融負債(「以公平值計入損益中」)除外)直接產生之交易成本,於初次確認時於金融資產及金融負債(按適用情況而定)之公平值計入或扣除。收購以公平值計入損益中之金融資產及金融負債直接產生之交易成本,將立即在損益中確認。

#### 金融資產

# **Financial instruments**

Financial assets and financial liabilities are recognised when a group entity becomes a party to the contractual provisions of the instrument.

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets or financial liabilities at fair value through profit or loss ("FVTPL")) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at FVTPL are recognised immediately in profit or loss

#### Financial assets

Financial assets included financial assets at FVTPL, available-for-sale ("AFS") financial assets and loans and receivables. The classification depends on the nature and purpose of the financial assets and is determined at the time of initial recognition. All regular way purchases or sales of financial assets are recognised and derecognised on a trade date basis. Regular way purchases or sales are purchases or sales of financial assets that require delivery of assets within the time frame established by regulation or convention in the marketplace.

# Effective interest method

The effective interest method is a method of calculating the amortised cost of a debt instrument and of allocating interest income over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash receipts (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the debt instrument, or, where appropriate, a shorter period to the net carrying amount on initial recognition.

Interest income is recognised on an effective interest basis for debt instruments.

# Financial assets at FVTPL

A financial asset may be designated as at FVTPL upon initial recognition if:

- such designation eliminates or significantly reduces a measurement or recognition inconsistency that would otherwise arise; or
- the financial asset forms part of a group of financial assets or financial liabilities or both, which is managed and its performance is evaluated on a fair value basis, in accordance with the Group's documented risk management or investment strategy, and information about the grouping is provided internally on that basis: or
- it forms part of a contract containing one or more embedded derivatives, and HKAS 39 permits the entire combined contract (asset or liability) to be designated as at FVTPL.

Financial assets at FVTPL (including investment in convertible note) are stated at fair value, with any gains or losses arising from remeasurement recognised directly in profit or loss. The net gain or loss recognised in profit or loss excludes any dividend or interest earned on the financial assets. Fair value is determined in the manner described in note 6.

Loans and receivables

Loans and receivables (including trade and other receivables, dividend receivable, bank balances, deposits and cash) are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Subsequent to initial recognition, loans and receivables are measured at amortised cost using the effective interest method, less any impairment.

# AFS financial assets

AFS financial assets are non-derivatives that are either designated as AFS or are not classified as financial assets at FVTPL, loans and receivables or held-to-maturity investments.

Equity securities held by the Group that are classified as AFS financial assets and are traded in an active market are measured at fair value at the end of each reporting period. Dividends on AFS equity investments are recognised in profit or loss. Other changes in the carrying amount of AFS financial assets are recognised in other comprehensive income and accumulated under the heading of available-for-sale investment reserve. When the investment is disposed of or is determined to be impaired, the cumulative gain or loss previously accumulated in the reserve is reclassified to profit or loss (see the accounting policy in respect of impairment loss on financial assets below).

AFS equity investments that do not have a quoted market price in an active market and whose fair value cannot be reliably measured are measured at cost less any identified impairment losses at the end of the reporting period.

# Impairment of financial assets

Financial assets, other than those at FVTPL, are assessed for indicators of impairment at the end of each reporting period. Financial assets are considered to be impaired where there is objective evidence that, as a result of one or more events that occurred after the initial recognition of the financial asset, the estimated future cash flows of the financial assets have been affected.

For AFS equity investment, a significant or prolonged decline in the fair value of that investment below its cost is considered to be objective evidence of impairment.

For all other financial assets, objective evidence of impairment could include:

- significant financial difficulty of the issuer or counterparty; or
- breach of contract, such as default or delinquency in interest or principal payments; or
- it becoming probable that the borrower will enter bankruptcy or financial re-organisation.

For certain categories of financial assets, such as trade receivables, assets that are assessed not to be impaired individually are, in addition, assessed for impairment on a collective basis. Objective evidence of impairment for a portfolio of receivables could include the Group's past experience of collecting payments, an increase in the number of delayed payments in the portfolio past the credit period of 30 to 120 days, and observable changes in national or local economic conditions that correlate with default on receivables.

For financial assets carried at amortised cost, the amount of the impairment loss recognised is the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the financial asset's original effective interest rate.

For financial assets carried at cost, the amount of the impairment loss is measured as the difference between the asset's carrying amount and the present value of the estimated future cash flows discounted at the current market rate of return for a similar financial asset. Such impairment loss will not be reversed in subsequent periods.

The carrying amount of the financial asset is reduced by the impairment loss directly for all financial assets with the exception of trade and other receivables where the carrying amount is reduced through the use of an allowance account. Changes in the carrying amount of the allowance account are recognised in profit or loss. When trade and other receivables are considered uncollectible, it is written off against the allowance account. Subsequent recoveries of amounts previously written off are credited to profit or loss.

When an AFS financial asset is considered to be impaired, cumulative losses previously recognised in other comprehensive income are reclassified to profit or loss in the period.

For financial assets measured at amortised cost, if, in a subsequent period, the amount of impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment losses was recognised, the previously recognised impairment loss is reversed through profit or loss to the extent that the carrying amount of the investment at the date the impairment is reversed does not exceed what the amortised cost would have been had the impairment not been recognised.

In respect of AFS equity investments, impairment losses previously recognised in profit or loss are not reversed through profit or loss. Any increase in fair value subsequent to impairment loss is recognised in other comprehensive income and accumulated under the heading of available-for-sale investment reserve.

# 金融工具(續)

# 金融負債及股本工具

由集團公司發行之負債及股本工具,按所訂立之合約安排性質及金融負債及股本工具之定義分類為金融負債或股本工具。

# 股本工具

股本工具為證明股本資產剩餘權益(經扣除 其所有負債)之任何合約。本公司發行之股 本工具按已收所得款項扣除直接發行成本確 認。

# 金融負債

金融負債包括應付賬項及其他應付款項、銀 行貸款及商業信貸及借款,以有效利率法按 攤銷成本列賬。

# 有效利率法

有效利率法指計算金融負債之攤銷成本及分配有關期間利息費用之方法。有效利率指金融負債之估計未來所付現金(包括構成實際利率、交易成本及其他溢價或折讓一部分的所有已支付或已收取的費用及基點)在估計可使用年期或較短期間(按適用者)內可折現至初步確認之賬面淨金額之折現利率。

負債工具利息費用按有效利率法確認。

# 衍生金融工具

衍生工具以衍生工具合約簽訂日之公平值作 初次確認及其後以報告期結算日之公平值重 新計量。所產生的收益或虧損將即時於損益 內確認,除非該衍生工具是指定而有效之對 沖工具,在此情況下,於損益內確認的時間 取決於對沖關係的類別。

# 財務擔保合約

財務擔保合約為須由簽發者預備特定款項以 補償持有者因特定負債人未能根據債務文件 條款於到期日支付貸款之損失之合約。

本集團所簽發及不指定以公平值計入損益中之財務擔保合約,將以公平值首次確認。隨著首次確認後,本集團財務擔保合約以較高者計算:(i)根據香港會計準則第37號「撥備、或然負債及或然資產」釐定金額;及(ii)根據最初確認金額(如適用)減累積攤銷確認。

# Financial instruments (continued)

# Financial liability and equity instruments

Debt and equity instruments issued by a group entity are classified as either financial liabilities or as equity in accordance with the substance of the contractual arrangements and the definitions of a financial liability and an equity instrument.

# Equity instruments

An equity instrument is any contract that evidences a residual interest in the assets of an equity after deducting all of its liabilities. Equity instruments issued by the Company are recognised at the proceeds received, net of direct issue costs.

#### Financial liabilities

Financial liabilities including creditors and other payables, bank loans and import loans and borrowings are subsequently measured at amortised cost, using the effective interest method.

# Effective interest method

The effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or, where appropriate, a shorter period, to the net carrying amount on initial recognition.

Interest expense is recognised on an effective interest basis for debt instruments

# **Derivative financial instruments**

Derivatives are initially recognised at fair value at the date when derivative contracts are entered into and are subsequently remeasured to their fair value at the end of the reporting period. The resulting gain or loss is recognised in profit or loss immediately unless the derivative is designated and effective as a hedging instrument, in which event the timing of the recognition in profit or loss depends on the nature of the hedge relationship.

# Financial guarantee contracts

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the terms of a debt instrument.

Financial guarantee contracts issued by the Group are initially measured at their fair values and, if not designated as at FVTPL, are subsequently measured at the higher of: (i) the amount of obligation under the contract, as determined in accordance with HKAS 37 "Provisions, Contingent Liabilities and Contingent Assets"; and (ii) the amount initially recognised less, when appropriate, cumulative amortisation recognised over the guarantee period.

於全數剔除金融資產時,資產賬面值與已收 及應收代價及已於其他全面收益確認及於股 本中累計之累計損益之總和之差額,於損益 中確認。

當或只當金融負債獲解除、取消或已屆滿時,本集團將其剔除。取消確認之金融負債 賬面值與已付及應付代價之差額,將於損益 中確認。

### 存貨

存貨乃根據成本和可變現淨值二者中之較低值入賬。存貨成本以先入先出法計算。可變現淨值乃按存貨之估計售價減所有估計完成成本及在市場上銷售所需成本計算。

## 税項

所得税支出指即期應付税項及遞延税項總 和。

即期應付税項按年內應課税溢利計算。由於 應課税溢利就其他年度的應課税或可扣税收 入及開支項目及毋須課税或不可扣税之項目 之處理上之分別,故與綜合損益表所列稅前 溢利不同。本集團即期稅項負債按於報告期 結算日已頒佈或實際上已頒佈稅率計算。

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity.

On derecognition of a financial asset in its entirety, the difference between the asset's carrying amount and the sum of the consideration received and receivable and cumulative gain or loss that had been recognised in other comprehensive income and accumulated in equity is recognised in profit or loss.

The Group derecognises financial liabilities when, and only when, the Group's obligations are discharged, cancelled or have expired. The difference between the carrying amount of the financial liability derecognised and the consideration paid and payable is recognised in profit or loss.

### **Inventories**

Inventories are stated at the lower of cost and net realisable value. Costs of inventories are determined on first-in, first-out method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale

### **Taxation**

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit before taxation as reported in the consolidated statement of profit or loss because of income and expense that are taxable or deductible in other years and items that are never taxable or deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognized for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary differences to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such deferred assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences arising on investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

遞延税項資產及負債乃按預期於償還負債或 變現資產期間適用之税率及基於於報告期間 結算日已頒佈或實際頒佈之税率(及税法)計 算。

遞延税項負債及資產之計量反映本集團預期 於報告期間結算日收回其資產或償還其負債 之賬面值後將出現的稅務後果。

就計量利用公平值模式計量之投資物業之遞 延稅項負債或遞延稅項資產而言,賬面值乃 假設通過銷售全數收回。

即期及遞延税項於損益內確認,惟倘其與在 其他全面收益確認或直接在權益確認之項目 有關,則即期及遞延税項亦會在其他全面收 益確認或直接在權益確認。

### 租賃

當租約之條款實質上將所有權之絕大部分風險及回報轉移至承租人,則分類為融資租約。所有其他租約被分類為營運租約。

### 本集團作為出租人

來自營運租約之租金收入於有關租約年期按 直線基準在損益中確認。

### 本集團作為承租人

按融資租約持有之資產按租約開始時之公平 值或(倘為較低者)按最低租賃款項之現值確 認為本集團資產。對出租人之相應責任則於 綜合財務狀況表列為融資租賃責任。

租賃款項按比例分攤為融資費用及租賃責任減少,從而讓該等負債之利息按負債之應付餘額以固定息率計算。融資費用立即於損益中確認,除非它們直接歸屬於符合條件的資產,在這情況下,它們將按照本集團借貸成本的一般政策被資本化。

營業租賃租金按直線法於有關租約年期確認 為費用。因營業租賃產生之或然租金將在其 產生之會計期間內確認為費用。

倘訂立營業租賃時收取租賃獎勵,該獎勵確認為負債,獎勵總利益按直線法確認為租金 開支減少。

### Taxation (continued)

The carrying amount of deferred taxation assets is reviewed at the end of the reporting period and reduced to the extent that it is no longer probable that sufficient taxable profit will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax liabilities or deferred tax assets for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale.

Current and deferred tax are recognised in profit or loss, except when it relates to items that are recognised in other comprehensive income or directly in equity, in which case, the current and deferred tax are also recognised in other comprehensive income or directly in equity respectively.

### Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

### The Group as lessor

Rental income from operating leases is recognised in profit or loss on a straight-line basis over the term of the relevant lease.

### The Group as lessee

Assets held under finance leases are recognised as assets of the Group at their fair value at the inception of the lease or, if lower, at the present value of the minimum lease payments. The corresponding liability to the lessor is included in the consolidated statement of financial position as a finance lease obligation.

Lease payments are apportioned between finance charges and reduction of the lease obligation so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are recognised immediately in profit or loss, unless they are directly attributable to a qualifying assets, in which case they are capitalised in accordance with the Group's general policy on borrowing cost.

Operating lease payments are recognised as an expense on a straightline basis over the lease term. Contingent rentals arising under operating leases are recognised as an expense in the period in which they are incurred.

In the event that lease incentives are received to enter into operating leases, such incentives are recognised as a liability. The aggregate benefit of incentives is recognised as a reduction of rental expense on a straight-line basis.

### 外幣

編製集團旗下個別公司之財務報表時,以該公司之功能貨幣以外貨幣(外幣)進行之交易,按交易日期之適用匯率確認。於報告期結算日,以外幣列值之貨幣項目按當日之適用匯率重新換算。按歷史成本計量之以外幣列值非貨幣項目不予重新換算。

貨幣項目之匯兑差額於其產生期間在損益中 確認。

就綜合財務報表之呈列方式而言,本集團海外業務之資產與負債以於報告期結算日適用之匯率換算為本公司之呈列貨幣(即港元)。收入及開支則按該年度之平均匯率換算,惟匯率於該期間大幅波動則除外,於此情況下,則按各交易日期適用之匯率換算。產生之匯兑差額(如有)確認為其他全面收益及累計於權益中之換算儲備(如適用則歸屬於非控股權益)。

在出售海外業務(即出售本集團在海外業務的全部權益,或出售一間包括海外業務的附屬公司而失去控制權,或出售一間包括海外業務的聯營公司部份權益而保留之權益成為金融資產),就該業務日常營運積累屬於本公司擁有人權益的所有匯兑差額重新分類至損益中。

### Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date. Non-monetary items that are measured in terms of historical cost in a foreign currency are not re-translated.

Exchange differences on monetary items are recognised in profit or loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's foreign operations are translated into the presentation currency of the Group (i.e. Hong Kong dollars) using exchange rate prevailing at the end of the reporting period. Income and expenses are translated at the average exchange rates for the year, unless exchange rates fluctuate significantly during the period, in which case, the exchange rates prevailing at the dates of transactions are used. Exchange differences arising, if any, are recognised in other comprehensive income and accumulated in equity under the heading of translation reserve (attributable to noncontrolling interests as appropriate).

On the disposal of a foreign operation (i.e. a disposal of the Group's entire interest in a foreign operation, or a disposal involving loss of control over a subsidiary that includes a foreign operation, or a partial disposal of an interest in an associate that includes a foreign operation of which the retained interest becomes a financial asset), all of the exchange differences accumulated in equity in respect of that operation attributable to the owners of the Company are reclassified to profit or loss.

In addition, in relation to a partial disposal of a subsidiary that does not result in the Group losing control over the subsidiary, the proportionate share of accumulated exchange differences are reattributed to non-controlling interests and are not recognised in profit or loss. For all other partial disposals (i.e. partial disposals of associates that do not result in the Group losing significant influence), the proportionate share of the accumulated exchange differences is reclassified to profit or loss.

Goodwill and fair value adjustments on identifiable assets acquired arising on an acquisition of a foreign operation on or after 1 April 2005 are treated as assets and liabilities of that foreign operation and translated at the rate of exchange prevailing at the end of each reporting period. Exchange differences arising are recognised in other comprehensive income.

收購、建設或生產合資格資產(資產需要相當長時期準備投入作擬訂用途或出售)直接涉及之借貸成本被計入這些資產的成本,直至當資產大致上可準備投入作擬訂用途或出售時停止。在特定借貸撥作合資格資產之支出前暫時用作投資所賺取之投資收入,須自可資本化之借貸成本中扣除。

所有其他借貸成本均於其產生期間於損益中 確認。

### 退休福利成本

界定供款計劃(包括指定託管退休福利計劃 和強制性公積金計劃)之供款於員工作出使 其可享有供款之服務時於損益中確認為支 出。

### 以股份為基礎支付之交易 *以股權結算股份為基礎支付之交易*

於二零零二年十一月七日之後授予僱員及二 零零五年四月一日或之後歸屬之購股權 以股權結算股份為基礎支付於授出日期之公 平值,在歸屬期間(按集團估計最終將歸屬 之股本工具)以直線法列作支出並於權益(購 股權儲備)中作相應增加。

於報告期結算日,本集團修訂預期歸屬股本工具數目之估計。原來估計的變動所帶來之影響(如有)在損益中被確認使累計支出反映重新作出之估計,購股權儲備亦會作出相應的調整。

### **Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sales. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

#### **Retirement benefit costs**

Payments to the defined contribution retirement plan, including stated managed retirement benefit scheme and the Mandatory Provident Fund Scheme, are recognised as expenses when employees have rendered service entitling them to the contributions.

# Share-based payment transactions Equity-settled share-based payment transactions

Share options granted to employees of the Group after 7 November 2002 and vested on or after 1 April 2005

The fair value determined at the grant date of the equity-settled share-based-payments is expensed on a straight-line basis over the vesting period, based on the Group's estimate of equity instruments that will eventually vest, with a corresponding increase in equity (share option reserve)

At the end of the reporting period, the Group revises its estimates of the number of equity instruments expected to vest. The impact of revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share options reserve.

When the share options are exercised, the amount previously recognised in share option reserve will be transferred to retained profits. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to retained profits.

Share options granted to employees on or before 7 November 2002, or granted after 7 November 2002 and vested before 1 April 2005

The financial impact of share options granted is not recorded in the consolidated financial statements until such time as the options are exercised, and no charge is recognised in profit or loss in respect of the value of options granted. Upon the exercise of the share options, the resulting shares issued are recorded as additional share capital. Options which lapse or are cancelled prior to their exercise date are deleted from the register of outstanding options.

### 4. 估計不確定因素主要來源

應用附註3所述的本集團會計政策時,管理層須對未能從其他來源明顯得知的資產及負債賬面值作出判斷、估計及假設。估計及相關假設乃以過往經驗及其他被視為相關的因素為依據。實際結果可能有別於此等估計。

本集團持續檢討該等估計及相關假設。因應會計估計需作出的修訂將在該等估計之修訂期間(倘該等修訂僅影響該期間)或者修訂期間及未來期間(倘該等修訂影響現時及未來期間)予以確認。

於報告期結算日,存有重大風險可能須於下一財政年度對資產及負債賬面值作出重大調整的有關未來的主要假設及估計不明朗因素的其他主要來源如下。

#### 估計商譽減值

在釐定商譽是否作出減值時,須評估已分配商譽之現金產生單位之使用價值。計算使用價值時,本集團須評估預期從現金產生單位所得之未來現金流量,並需以合適之貼現率計算現值。倘實際現金流量少於預期之金額,則可能產生重大減值虧損。於截至二零一六年三月三十一日止年度,本集團確認之商譽減值虧損為16,382,000港元(二零一五年:零港元)。於二零一六年三月三十一日,商譽賬面值為102,066,000港元(二零一五年:118,448,000港元)。有關可收回金額之計算詳情載於附註22。

### 可供出售投資的估計減值

本集團的可供出售投資按成本減去減值列 賬。管理層乃根據投資的可收回金額,以決 定減值金額。於截至二零一六年三月三十一 日止年度,本集團並無確認可供出售投資的 減值虧損(二零一五年:5,977,000港元)。 於二零一六年三月三十一日,可供出售投 資賬面值為62,286,000港元(二零一五年: 61,123,000港元)。

### 估計應收貨款減值

當存在減值虧損的客觀證據時,本集團將考慮預期未來現金流。減值虧損為資產賬面值與預期未來現金流(未發生的將來信貸虧損除外)以金融資產的原來有效利率(即於最初確認時計算的有效利率)折算得出的現值間之差額。當真正未來現金流少於預期時,或會產生重大減值虧損。於二零一六年三月三十一日,應收貨款之賬面值為797,083,000港元(二零一五年:816,652,000港元)。

### 4. KEY SOURCES OF ESTIMATION UNCERTAINTY

In the application of the Group's accounting policies, which are described in note 3, the directors of the Company are required to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The following are the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

### Estimated impairment of goodwill

Determining whether goodwill is impaired requires an estimation of the value in use of the cash-generating units to which goodwill has been allocated. The value in use calculation requires the Group to estimate the future cash flows expected to arise from the cash-generating unit and a suitable discount rate in order to calculate the present value. Where the actual future cash flows are less than expected, a material impairment loss may arise. For the year ended 31 March 2016, the Group recognised impairment loss on goodwill of HK\$16,382,000 (2015: nil). As at 31 March 2016, the carrying amount of goodwill was HK\$102,066,000 (2015: HK\$118,448,000). Details of the recoverable amount calculation are disclosed in note 22.

### Estimated impairment of available-for-sale investments

The Group's available-for-sale investments are stated at cost less impairment. The management determined the impairment amount based on the recoverable amount of the investments. No impairment loss was recognised during the year ended 31 March 2016 (2015: HK\$5,977,000). As at 31 March 2016, the carrying amount of available-for-sale investments was HK\$62,286,000 (2015: HK\$61,123,000).

### **Estimated impairment of trade receivables**

When there is objective evidence of impairment loss, the Group takes into consideration the estimation of future cash flows. The amount of the impairment loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition). Where the actual future cash flows are less than expected, a material impairment loss may arise. No impairment loss on trade receivables was recognised during the year ended 31 March 2016 and 2015. As at 31 March 2016, the carrying amount of trade receivables was HK\$797,083,000 (2015: HK\$816.652.000).

# Depreciation and impairment of properties, plant and equipment

The Group's management determines the estimated useful lives, residual value and related depreciation charges for its property, plant and equipment. This estimate is based on the historical experience of the actual useful lives of property, plant and equipment of similar nature and functions. Management will increase the depreciation charge where useful lives are expected to be shorter than previously estimated, or it will write-off or write-down obsolete or nonstrategic assets that have been abandoned or sold. Change in these estimations may have a material impact on the results of the Group. The Group tests whether property, plant and equipment have suffered any impairment in accordance with its accounting policy whenever there is any indication that the assets may have been impaired. The recoverable amounts of property, plant and equipment have been determined based on discounted cash flow method of each asset or a cash-generating unit. The directors consider that the recoverable amount less than the carrying amount of the property, plant and equipment and therefore, impairment loss of HK\$25,000,000 (2015: HK\$15,000,000) was recognised during the year ended 31 March 2016. At as 31 March 2016, the carrying amount of property, plant and equipment is approximately HK\$1,393,409,000 (2015: HK\$1,409,224,000).

# Impairment of interests in associates and amounts due from associates

Determining whether interests in associates are impaired requires an estimation of the recoverable amount of the associates. Recoverable amount is the higher of fair value less costs to sell and value in use. The recoverable amount of the associates is determined based on the estimated fair value less costs to sell of the associates. Management has evaluated the recovery of the investments based on such estimates and is confident that the allowance for impairment, where necessary, is adequate. No impairment loss was recognised in respect of interests in associates or amounts due from associates during the year ended 31 March 2016 (2015: HK\$3,151,000) was recognised in respect of interests in associates.

### Fair value measurements and valuation processes

Some of the Group's assets are measured at fair value for financial reporting purposes. The directors have a designated team to determine the appropriate valuation techniques and inputs for fair value measurements.

In estimating the fair value of the Group's investment properties, the Group uses market-observable data to the extent it is available. Where Level 1 inputs are not available, the Group engages third party qualified valuers to perform the valuation of the Group's investment properties. At the end of each reporting period, the management of the Group works closely with the qualified external valuers to establish and determine the appropriate valuation techniques and inputs for Level 2 and Level 3 fair value measurements. The Group will first consider and adopt Level 2 inputs where inputs can be derived observable guoted prices in the active market. When Level 2 inputs are not available, the Group will adopt valuation techniques that include Level 3 inputs. Where there is a material change in the fair value of the assets, the causes of the fluctuations will be reported to directors. Any changes in the price per square metre in reference with recent transactions will affect the fair value of the investment properties of the Group. Information about the valuation techniques and inputs used in determining the fair value of the Group's investment properties are disclosed in note 15.

In estimating the fair value of the Group's available-for-sale investments and derivative financial instruments, the Group uses market-observable data to the extent it is available. Where Level 1 inputs are not available, the management of the Group will assess the valuation of financial instruments with reference to the fair value quoted in the over-the-counter market with the adjustments for the lack of marketability. Where there is a material change in the fair value of the assets, the causes of the fluctuations will be reported to the board of directors. Any changes in the marketability of the investments will affect the fair value of the investments. Note 6 provides detailed information about the valuation techniques, inputs and key assumptions used in the determination of the fair value of the Group's available-for-sale investments and derivative financial instruments.

### Income taxes

The Group is subject to income taxes in numerous jurisdictions. Judgement is involved in determining the group-wide provision for income taxes. There are certain transactions and computations for which the ultimate tax determination is uncertain during the ordinary course of business. The Group recognises liabilities for expected tax issues based on estimates of whether additional taxes will be due. Where the final tax outcome of these matters is different from the amounts that were initially recognised, such differences will impact the income tax and deferred tax provisions in the period in which such determination is made.

### 5. CAPITAL RISK MANAGEMENT

The Company manages its capital to ensure that the entities in the Group will be able to continue as a going concern while maximising the return to owners through the optimisation of the debt and equity balance. The Group's overall strategy remains unchanged from prior years.

The capital structure of the Group consists of net debt, which includes bank loans and import loans, and borrowings disclosed in notes 30 and 31, net of cash and cash equivalents and equity attributable to owners of the Company, comprising issued share capital, reserves and retained profits as disclosed in the consolidated statement of changes in equity.

The directors of the Company review the capital structure on a regular basis. As part of this review, the directors consider the cost of capital and the risks associated with each class of capital. In the opinion of the directors of the Company, the Group will balance its overall capital structure through the payment of dividends, new share issues and share buy-backs as well as the issue of new debt or the redemption of existing debt.

The rates mentioned above are the sensitivity rates used when reporting foreign currency risk internally to key management personnel and represent management's assessment of the reasonably possible change in foreign exchange rates. ## Interest rate risk

The Group is exposed to cash flow interest rate risk in relation to its variable-rate bank balances at prevailing market deposit rates (see note 25), variable-rate bank loans and import loans (see note 30), and borrowings (see note 31).

The Group will enter into interest rate swaps to mitigate part of the exposure to interest rate risk, if necessary. In addition, the management will monitor the situation and consider further hedging such exposure should the need arises.

The Group's cash flow interest rate risk is mainly concentrated on the fluctuation of Hong Kong Interbank Offered Rate, Singapore Interbank Offered Rate or Prime Rate arising from the Group's bank borrowings. The management considers the Group's exposure of the short-term bank balances to interest rate risk is not significant as interest bearing bank balances are within short maturity period.

The sensitivity analysis below has been determined based on the exposure to interest rates for variable-rate bank loans and import loans, and bank borrowings. The analysis is prepared assuming financial instruments outstanding at the end of the reporting period were outstanding for the whole year. A 50 basis points increase or decrease is used when reporting interest rate risk internally to key management personnel and represents management's assessment of the reasonably possible change in interest rates.

### Sensitivity analysis

If the interest rate on bank loans and import loans, and borrowings had been 50 basis points higher/lower and all other variables were held constant, the Group's profit before taxation would decrease/increase by approximately HK\$9,786,000 (2015: HK\$9,286,000).

### Other price risk

The Group is exposed to equity price risk through its investment in listed equity securities and unlisted equity securities. The Group has a team to monitor the price risk and will consider hedging the risk exposure should the need arise.

### Sensitivity analysis

The sensitivity analysis below has been determined based on exposure to equity price risks at the end of the reporting period.

If the price of the listed equity investments had been 5% (2015: 5%) higher/lower, the available-for-sale investment reserve will increase/decrease by HK\$686,000 (2015: increase/decrease by HK\$821,000).

In the opinion of the directors, the Group's investments in unlisted equity securities are not sensitive to price changes, therefore, no sensitivity analysis is prevented.

由於交易對手為獲國際信貸評級機構給予高 度信貸評級之銀行,故流動資金之信貸風險 有限。

本集團就其聯營公司所提供銀行信貸的擔保存在風險(見附註39)。管理層定期評估聯營公司財務狀況及認為聯營公司財務狀況良好,而本集團已採取足夠監控程序減低此風險。

本集團之應收貨款並無任何重大集中之信貸 風險。應收貨款包括大量客戶,並分佈於不 同的行業。

### 流動資金風險

本集團透過結合借款及股本作為日常營運之融資,並維持足夠備用信貸以確保在需要時提供必須之流動資金。管理層定期密切監察本集團之資金流動性以確保具足夠流動資金應付所有到期責任。參照公司截至綜合財務報表獲准印發日期現有的未使用貸款額和獲得的新貸款額,及經考慮未來可能發生之出售投資和再融資安排後,本公司董事認為流動資金及資本來源充足。

As at 31 March 2016, the Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties and financial guarantees provided by the Group is arising from:

- the carrying amount of the respective recognised financial assets as stated in the statement of financial position; and
- the amount of contingent liabilities in relation to financial guarantee issued by the Group as disclosed in note 39.

The management considers that the Group has adequate credit control for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. The Group reviews the recoverable amount of each individual trade and other receivables at the end of the reporting period to ensure that adequate impairment losses are made for irrecoverable amounts. In addition, the Group manages the credit risk of trade receivables by ongoing evaluation of the counterparties' financial position and requesting counterparties to provide other form of security, if consider as necessary. In this regard, the directors of the Company consider that the Group's credit risk is significantly reduced.

The credit risk on liquid funds is limited because the counterparties are banks with high credit-ratings assigned by international credit-rating agents.

The Group is also exposed to the credit risk in respect of guarantees given to banks relating to banking facilities utilised by associates (see note 39). The management periodically reviews financial position of the associates and considers that the associates are of strong financial strength and the Group has adequate monitoring procedures to reduce the credit risk.

The Group does not have any significant concentration of credit risk over trade receivables. Trade receivables consist of a large number of customers and spread across diverse industries.

# Liquidity risk

The Group finances its operations by using a combination of borrowings and equity. Adequate lines of credit are maintained to ensure necessary liquidity is available when required. The management monitors the liquidity position of the Group on a periodical basis to ensure the availability of sufficient liquid funds to meet all obligations. With reference to the existing unutilised facilities and newly obtained facilities up to the date when the consolidated financial statements are authorised for issue and after taking into account of any possible disposal of investments and re-financing arrangements, the directors of the Company consider the source of liquidity and capital for the daily operation are sufficient.

During the year ended 31 March 2016, the Group carried out a review of the recoverable amount on certain property, plant and equipment. The recoverable amount is determined by the value in use calculation and according to the review, an impairment loss of HK\$25,000,000 (2015: HK\$15,000,000) was recognised mainly attributable to a deterioration in expected future cash flows of one of the subsidiaries of GP Batteries due to the Group's effort to reduce capacity by consolidating the rechargeable lithium battery plants. The rate used to discount the forecast cash flow approximates 10.4% (2015: 9.7%).

In addition, during the year ended 31 March 2015, the management has determined to write off property, plant and equipment with a carrying amount of HK\$15,479,000 as the factory in overseas was expected to be closed down.

In the opinion of the directors, the Group cannot exercise significant influence over the company and accordingly, such investment is classified as availablefor-sale investments.
- (b) During the year ended 31 March 2016, BMTPow Limited increase its share capital through issuing new shares. The Group subscribed the additional shares of BMTPow Limited at a consideration of USD500,000 (equivalent to HK\$3,875,000), resulting in the dilution of shareholdings on the investment in BMTPow Limited from 15% to 14.68%.

During the year ended 31 March 2015, impairment loss on available-for-sale investments of HK\$5,977,000 (2016: nil) was recognised as a result of decline in the fair value below the cost of certain of the Group's investments upon disposal.

The fair value of listed equity securities, all of which are listed outside Hong Kong, are measured based on the quoted closing market prices on the last market day of the financial year.

All unlisted equity securities are measured at cost less impairment because the range of reasonable fair value estimates is so significant that the directors of the Company are of the opinion that their fair values cannot be measured reliably.

## 19. INVESTMENT IN CONVERTIBLE NOTE

On 21 April 2011, the Group entered into an agreement (the "Subscription Agreement") to subscribe for a convertible note (the "Convertible Note") in the principal amount of approximately HK\$68,019,000 issued by GSM Holdings Limited ("GSMH"). The Convertible Note will mature on 21 April 2016 and is interest bearing at 2.00% per annum. Unless converted into new shares of GSMH before maturity or repaid in accordance with the terms of the Convertible Note, GSMH shall redeem the Convertible Note on 21 April 2016 at the outstanding principal together with interest accrued thereon.

蔣商控股授出之可換股票據包括嵌入式衍生 工具,因此被分類為以公平值計入損益中之 可換股票據投資。

於截至二零一六年三月三十一日及二零一五年三月三十一日止年度,管理層根據蔣商控股之最新財務資料,認為蔣商控股多不能於可換股票據到期日(即二零一六年四月二十一日)還款。因此,並無作出公平值調整。

截至財務報表刊發日期,沒有從蔣商控股收 到還款,本集團沒有將可換股票據任何部分 轉換為蔣商控股之股份。

On 26 March 2013, the Group further entered into a supplemental deed with GSMH concerning the Convertible Note (the "Supplemental Deed"). Pursuant to the Subscription Agreement, as amended by the Supplemental Deed, the Group can convert the Convertible Note in whole or in part into new shares to be issued by GSMH during the period from 21 April 2012 to 21 April 2016 (the "Conversion Period"), on the basis of conversion as set out in the Subscription Agreement and as amended by the Supplemental Deed, if immediately after such conversion, the aggregate number of GSMH's shares held by the Group does not exceed 49% of the total number of issued GSMH's shares. The basis of conversion is determined as 8 times of the audited net profit after tax of GSMH attributable to the owners of GSMH divided by the total number of issued and fully paid shares of GSMH on the date of conversion ("Conversion Price"). In addition, the Supplemental Deed also clarified that the Group shall not be entitled to convert any part of the Convertible Note into GSMH's shares during the Conversion Period if the applicable Conversion Price, derived pursuant to the Subscription Agreement, shall be nil or is a negative figure.

During the year ended 31 March 2016 and 2015, the conversion option of the Convertible Note was not exercisable and the Group did not convert any part of the Convertible Note into GSMH's shares.

The investment in Convertible Note issued by GSMH is designated as at FVTPL as the Convertible Note contains embedded derivative.

During the year ended 31 March 2016 and 31 March 2015, the directors based on the latest available financial information of GSMH considered that GSMH was unlikely to repay the Convertible Note on the date of maturity (i.e. 21 April 2016). As a result, no fair value adjustment was made.

Up to the date of the issuance of these financial statements, there was no repayment received from GSMH and the Group has not converted any part of the Convertible Note into GSMH's shares.

於本年度,本集團根據現金流量預測為商譽進行減值測試。現金流量預測根據未來1至5年(二零一五年:1至5年)的最新財務預算案及參照年增長率0%至17.6%(二零一五年:0%至23.6%),以折現率12.2%至16.2%(二零一五年:12.9%至16.1%)計算。

各現金產生單位的可收回金額以使用價值 計算。使用價值計算之主要因素為該年度 之折現率、增長率及收入與直接支出的預 期轉變。管理層使用反映市場當時所評估之 貨幣時間價值之除税前折現率和現金產生單 位之獨有風險計算折現率。增長率按行業增 長預測。收入及直接支出的轉變按以往經驗 及預期市場未來之變化預測。其他計算使用 價值的主要假設包括基於現金產生單位之過 往業績及管理層對市場發展預期作出之銷售 及毛利預算及有關之現金流入及流出預算。 於截至二零一六年三月三十一日止年度,本 集團就東歐市場及其他確認之減值虧損分別 為9.665.000港元(二零一五年:零港元)及 6,717,000港元(二零一五年:零港元),主要 由於歐洲市場低迷,導致相關現金產生單位 之銷售及財務業績下降,令財務預算之現金 流不足。

東歐市場及其他的可收回金額按使用價值的 基礎確定,該可收回金額乃基於若干主要假 設。兩項使用價值均基於管理層批准為期5 年之財務預算分別按16.2%和12.2%的貼現 率計算之預算現金流所確定。兩組超過5年 期的現金流均以穩定之0%增長率推算。該 增長率是基於相關行業的增長預測,並且不 超過相關行業的平均長期增長率。東歐市場 和其他在預算期內之現金流量預測均基於預 算期內的預算銷售、預計毛利率及相同的原 材料價格上漲。預計現金流入和流出,包括 預算銷售、預算毛利率及預算原材料價格上 漲已根據以往的業績和管理層對市場發展的 期望而確定。管理層相信該等假設的任何合 理可能變動,將不會導致東歐市場和其他的 總賬面值超過其總可收回金額。

### 22. IMPAIRMENT TESTING ON GOODWILL (continued)

During the year, the Group performed impairment review for goodwill, based on cash flow forecasts derived from the most recent financial budgets of each of the CGUs for the next 1 to 5 years (2015: 1 to 5 years) with reference to annual growth rate ranging from 0% to 17.6% (2015: 0% to 23.6%) by using the discount rate ranging from 12.2% to 16.2% (2015: 12.9% to 16.1%).

The recoverable amount of each of the CGUs has been determined on the basis of value in use calculation. The key factors for the value in use calculation are discount rates, growth rates and expected changes to revenue and direct costs during the year. Management estimates discount rates using pre-tax rates that reflect current market assessments of the time value of money and the risks specific to the CGUs. The growth rate is based on industry growth forecasts. Changes in revenue and direct cost are based on past practices and expectations of future changes in the market. Other key assumptions for the value in use calculations included budgeted sales and gross margins and their related cash inflow and outflow patterns, estimated based on the CGUs' historical performance and management's expectation of the market development. During the year ended 31 March 2016, the Group recognised impairment losses of HK\$9,665,000 (2015: nil) and HK\$6,717,000 (2015: nil) in relation to EE and others respectively, which arose mainly due to insufficient cash flows derived from respective financial budgets due to the economic downturn in the European market that resulted in a drop in the sales and the financial performance of the relevant CGUS.

The recoverable amounts of EE and others have been determined on the basis of value in use calculations. Their recoverable amounts are based on certain similar key assumptions. Both value in use calculations use cash flow projections based on financial budgets approved by management covering a 5-year period, and a discount rate of 16.2% and 12.2% respectively. Both sets of cash flows beyond the 5-year period are extrapolated using a steady 0% growth rate. This growth rate is based on the relevant industry growth forecasts and does not exceed the average long-term growth rate for the relevant industry. Cash flow projections during the budget period for both EE and others are also based on the budgeted sales, expected gross margins and the same raw materials price inflation during the budget period. Expected cash inflows and outflows, which include budgeted sales, gross margin and raw material price inflation have been determined based on past performance and management's expectations for the market development. Management believes that any reasonably possible change in any of these assumptions would not cause the aggregate carrying amount of EE and others to exceed the aggregate recoverable amount of EE and others.

The maximum number of shares in respect of which options may be granted under the Option Scheme cannot exceed 10% of the issued share capital of the Company. The number of shares in respect of which options may be granted to any individual in any twelve-month period up to the offer date is not permitted to exceed 1% of the number of shares in issue.

Options granted under the Option Scheme must be taken up within the period as specified in the offer of options and upon payment of HK\$1 as the consideration for the options granted. Options granted are exercisable within the period as specified in the offer of options. The number of shares in respect of which options had been granted and represents outstanding on 31 March 2015 under the Option Scheme is 15,165,000 (2016: nil), 1.93% (2016: nil) of the shares on 31 March 2015. ### **37. RETIREMENT BENEFIT SCHEMES**

The Company and certain of its subsidiaries participate in the Gold Peak Group Provident Fund Scheme, a defined contribution retirement benefit scheme, for all qualified employees in Hong Kong. The scheme is funded by contributions from employers according to the employees' remuneration and length of services as defined under the trust deed. The monthly contribution rates of this scheme ranged from 5% to 10%. At the same time, the Group also participated in a mandatory provident fund ("MPF") scheme registered under the Hong Kong Mandatory Provident Fund Ordinance. All new employees have the option to join the Gold Peak Group Provident Fund Scheme or the MPF scheme with terms as stipulated by the MPF Authority. Under the MPF scheme, both the employer and its employees are required to make contributions to the scheme at 5% of the employees' relevant income, subject to a cap of monthly relevant income of HK\$30,000 effective from June 2014 for the MPF scheme.

For the Gold Peak Group Provident Fund Scheme, the unvested benefits of employees who terminate employment are utilised by the employers to reduce their future level of contributions. The amounts of unvested benefits so utilised by the employers during the year ended 31 March 2016 were approximately HK\$571,000 (2015: HK\$488,000). As at 31 March 2016, the forfeited contributions of HK\$195,000 (2015: HK\$154,000) were available to reduce the level of employers' future contributions.

The Group also participates in the employees' pension schemes of the respective municipal government in various places in the PRC where the Group operates. The Group makes monthly contributions calculated as a percentage of the monthly payroll costs and the respective municipal government undertakes to assume the retirement benefit obligations of all existing and future retirees of the Group. The Group has no other obligations for the payment of pension and other post-retirement benefits of employees other than the above contributions payments.

In addition, certain subsidiaries of the Company outside Hong Kong and the PRC participate in central provident fund schemes established by the relevant authority in their respective countries which are defined contribution plan.

The Group contributed an aggregate amount of HK\$16,148,000 (2015: HK\$14,844,000) to the above retirement benefit schemes during the year ended 31 March 2016.

As a result of the acquisitions, the difference of HK\$8,940,000 (2015: HK\$51,147,000) between the consideration paid of HK\$8,077,000 (2015: HK\$65,146,000) and the amount of non-controlling interests adjusted of HK\$17,017,000 (2015: HK\$116,293,000) was directly recognised in capital reserve.

During the year ended 31 March 2015, a subsidiary increased its share capital through issuing new shares to a third party shareholder, resulting to the dilution of shareholdings on the investment. As a result, the investee became an associate of the Group and a gain on deemed disposal of HK\$64,000 which was directly recognised in profit or loss (note 36).

During the year ended 31 March 2016, the listed subsidiaries of the Company repurchased their shares from the market at cash consideration of HK\$44,909,000 (2015: HK\$40,762,000). As a result of the repurchase, the difference of HK\$9,747,000 (2015: HK\$6,007,000) between the consideration paid of HK\$44,909,000 (2015: HK\$40,762,000) and the amount of non-controlling interests adjusted of HK\$54,656,000 (2015: HK\$46,769,000) was directly recognised in capital reserve.

During the year ended 31 March 2016, the Group received cash contribution of HK\$9,450,000 (2015: HK\$3,936,000) from non-controlling shareholders of certain subsidiaries as a result of capital injection during the year.
