2. 目的

證券持有人的個人資料可以任何方式被採用、持有、處理及/或保存，以作下列用途：

- 處理閣下的申請及退款支票(如適用)、核實是否符合本申請表格及招股章程載列的條款和申請手續以及公佈香港發售股份的分配結果；
- 遵守香港及其他地方的適用法律及法規；
- 以證券持有人(包括(如適用)香港結算代理人)的名義登記新發行證券或轉讓或受讓證券；
